Sherriff. The office hours are to be from 10 a.m. to 4 p.m., except during the long and Christmas vacations, when they are to close at 1 p.m.

Succession Duties.—Provision is made against evasion of payment of these duties by disposition of property in anticipation of death, or by purchase of annuities. Property brought into Ontario from without the Province is made liable to the duty.

Registration of Births, etc.—The act has been revised and consolidated. The Law Courts.—Provision is made for the removal of an executor or trustee, either for cause, or upon his own application. Who the estate is \$1,000 or under the application is to be to the county court.
