

The opening service of the Sixty-fourth Annual Convention of the Evangelical Lutheran Synod of Canada was held in St. Paul's Evangelical Lutheran Church, Hamilton, Ont., Wednesday, June 2nd, 1926, at 8 p.m. The German Sermon was preached by the Rev. O. Stockman, using as text, Matthew 28:20. The English Sermon was preached by the Rev. Dr. C. H. Little, from the text, Colossians 3:24. The Liturgy was conducted by the Secretaries of Synod.

FIRST SESSION

St. Paul's Lutheran Church, Thursday, June 3rd, 1926, 9.00 a.m.

The President of Synod formally opened the Synod, using the Order of the Kirchenbuch. Immediately thereafter he introduced the Rev. J. R. Strock, D.D., Missionary from India, who addressed the Synod, pleading for renewed support of the Missionary cause, and especially for the Andhra Christian College.

The President appointed as a Committee on Excuses: Pastors Ziegler, Iseler, Kutter, and Delegates W. G. Berner, E. B. Christiansen and L. Becker (Logan).

The President welcomed to the Convention: Rev. Paul Ludwig, Mission Superintend of the Board of Northwestern Missions; Rev. A. Grauer, Miss E. Szember, returned missionary from India, and Rev. Dr. Keck, President of the Michigan Synod.

The time of sessions was set at 9 to 11.30 in the morning and 2 to 5 in the afternoon.

The President presented his annual report.

PRESIDENT'S REPORT

Dear Brethren:-

A day of historical and far-reaching importance, yes, a turning point in the history of the Evangelical Lutheran Synod of Canada, was Friday, June 12th, 1925, when at Sebastopol in Trinity Church, Rev. O. Stockmann, pastor loci, the careful, well considered and diligent endeavors of the Joint-Merger Committee were brought to a successful close: the merger of the Evangelical Lutheran Synod of Central Canada with the Evangelical Lutheran Synod of Canada. We have worked together one year. The following report shows that pastors and congregations have been very active, that many jubilees and re-dedications of churches have taken place, but also that sickness and death occurred causing anxiety and sorrow. The word of St. Paul, "Rejoice with them that do rejoice and weep with them that weep" was fulfilled.

Although the past Synodical year was more or less a year of transition it has been a year of peaceful, harmonious activity and with heartfelt humble thanks and praise towards the Lord of the Church we meet in these days to discuss and consider the welfare of our beloved church.

Permit me to submit to you in the usual form and order a report of the work and activities within the Synod.

1. RESIGNATIONS AND CALLS.

On August 10th, 1925, Rev. C. Zarnke. Conestogo, informed me that he had received a second call from Zion's Church, Pembroke, and that he had resigned his pastorate in Conestogo, and that the resignation had been accepted.

On August 18th, 1925, Rev. O. C. D. Klaehn, D.D., notified the undersigned that he had accepted a call from the Inner Mission Board of the U.L.C. and of his resignation as pastor of Zion's Church, Stratford, and that he would commence his work as Immigrant-pastor in Montreal, on Oct. 1st, 1925.

On Sept. 6th, 1925, Rev. A. Grunwald resigned from the Petawawa Parish to accept a call to Conestogo. On Oct. 11th, 1925, he preached his farewell sermon in Petawawa and Alice.

At the end of Oct., 1925, Rev. H. L. Schildroth resigned from St. Paul's Church, Guelph, to accept a call to Trinity Church at Windsor, Ont. As Trinity Church is connected with the Synod of Michigan, Rev. H. L. Schildroth, upon his request, has been honorably dismissed to the Michigan Synod.

On Oct. 22nd, 1925, Rev. S. Cooper informed me of his resignation as pastor of St. Paul's Church, Galt, and that he would commence his work as pastor of the Lutheran Church at Sault St. Marie, on Dec. 1st, 1925. Like Windsor, this congregation is also a member of the Michigan Synod. Rev. Cooper did not ask for a letter of dismissal; on the contrary he wishes to remain a member of the Canada Synod.

On Oct. 26th, 1925, the Petawawa Parish extended a call to its former pastor, Rev. P. Kleine. The latter accepted the call and resigned from the Ladysmith Parish on Dec. 7th, 1925.

At a meeting on Nov. 22nd, 1925, Rev. Prof. H. Schorten, presiding, the Sullivan Parish extended a call to Rev. E. Tuerkheim, Edmonton, Alta. Soon afterwards the call was accepted by Rev. E. Tuerkheim, who commenced his pastorate in Sullivan and Williamsford early in February, 1925. For 15 years Rev. E. Tuerkheim has been a faithful pastor of the Manitoba Synod and comes with an honorable dismissal from that Synod. He is herewith recommended for membership into this body.

On Dec. 3rd, 1925, I was notified by Mr. E. B. Westcott, that Rev. H. Gruhn had resigned from Trinity Church, Hamilton, and that the resignation had been accepted by the congregation. Rev. H. Gruhn accepted a call to Stratford.

Soon afterwards Trinity Church sent a unanimous call to Rev. P. S. Baringer, Sherwood, Ont. On Jan. 3rd, 1926, Rev. Baringer resigned from the Sherwood Parish and took charge of his new field on February 1st, 1926.

On Jan. 31st and February 7th respectively, 1926, Rev. K. Blohm resigned as pastor of the Rankin Parish, Renfrew Co., to accept a call to the Mission Parish, Ladysmith-Schwartz, Que. He moved to Ladysmith the week of February 7th.

Student Schultz of Waterloo-Seminary has been called by the German Mission Committee as pastor of the Rankin Parish, and Student Vorkoper has received a call from St. Paul's Church, Galt.

After an examination by the Examining Committee of Synod, both candidates will be received into membership of this body and soon after Synod take charge of their respective fields.

It is also to be reported that on April 11th, 1926, the independent congregation of Rev. H. Hamfeldt, Toledo, Ohio, decided to join the Ohio Synod (U.L.C.), and therefore Rev. H. Hamfeldt is obliged to resign from the membership of the Canada Synod. He has been honorably dismissed to the Ohio Synod.

2. Installations.

The following pastors have been solemnly installed according to the prescribed order of the Church:

On July 5th, 1925, Rev. C. R. Cronmiller in Brantford by Rev. S. Cooper.

On July 12th, 1925, Rev. S. J. Wittig in Mildmay, by Rev. C. C. Maass, and on Aug. 2nd, 1925, in Walkerton by Rev. H. Rembe, Sr.

On July 12th, 1925, Rev. J. Jannau in Raglan and Denbigh by Rev. C. F. Christiansen.

On July 26th, 1925, Rev. J. Koehle in Massey, by Rev. H. J. Mangelsen.

On Oct. 18th, 1925, Rev. C. Zarnke in Pembroke, by Rev. M. Voss.

On Oct. 25th, 1925, Rev. A. Grunwald in Conestogo by the President of Conference, Rev. Prof. H. Henkel.

On Dec. 13th, 1925, Rev. P. Kleine in Petawawa and Alice by Rev. C. Zarnke.

On Jan. 3rd, 1925, Rev. H. Gruhn in Stratford by Rev. O. C. D. Klaehn, D.D.

On February 7th, 1926, Rev. P. S. Baringer in Trinity Church, Hamilton, by the President of Synod.

On February 14th, 1926, Rev. K. Blohm, in Ladysmith and Schwartz, Que., by Rev. J. Kutter.

On February 21st, 1926, Rev. E. Tuerkheim in Sullivan and Williamsford by President of Conference, Rev. E. Gomann.

3. Founding of Congregations and Commencement of New Work Undertaken.

May 1st, 1925, saw the union of Holy Trinity Church at Port Colborne and St. Paul's Church at Humberstone, the latter once a member of the Canada Synod, but since 20 years ago served by the Buffalo Synod. Rev. W. A. Schmidt, at the time a member of the Synod of Central Canada was unanimously called as pastor of this new First Lutheran Church, and consequently gave up his pastoral work in Welland.

Welland was served during the summer months by Student A. Mehlenbacher, who revived the work begun by Rev. Schmidt in Bridgeburg, and under the direction and with the co-operation of Rev. Dr. Maurer, D.D., chairman of the English Miss. Committee, founded a congregation of 28 members on Sept. 8th, 1925. Welland and Bridgeburg are now to form one parish. Unfortunately the efforts of the English Miss. Committee to find a suitable man for this field have up to the present time been without success.

Rev. S. Cooper, since Dec. 1st, 1925, pastor of Zion Evangelical Lutheran Church in Sault St. Marie, informed me during Conference in Toronto that his congregation, which belongs to the Michigan Synod, had on February 14th, 1926 unanimously resolved to join the Canada Synod. Rev. Dr. Maurer attended the Convention of the Michigan Synod in October, 1925, which already at that time expressed itself as willing to transfer the congregations at Windsor and Sault St. Marie to the Canada Synod, at their own request. Through the kindness of Rev. A. H. Steck, D.D., President of the Michigan Synod, Rev. Dr. Maurer was able to participate in the installation of Rev. S. Cooper on Jan. 31st, 1926. We rejoice that Rev. Cooper remains with us, and that his congregation will join the Canada Synod. The Synod hopes and wishes that Rev. Schildroth will be similarly successful.

An entirely new work of the Lutheran Church in Canada can be reported: Immigrant Mission. Rev. Dr. Klaehn and also the Women's Missionary Society for some years recognized the necessity of this work and repeatedly called the attention of the Church to it. Not being in a position to undertake it alone, the Synod sought the assistance of the Inner Mission Board of the U.L.C. Soon after the close of last year's convention of Synod we were notified of the willingness of the I.M.B. to assist this work. On the recommendation of the Executive Committee Rev. Dr. Klaehn was called by the I.M.B. of the U.L.C. as Immigrant-pastor for Montreal and other eastern ports of Canada. This is an important branch of church activity and should prove a great blessing for the Church. The Inner Mission Committee appointed by the Executive Committee will report to Synod, and Rev. Dr. Klaehn will at the proper time speak on his various activities.

4. Dedications of Churches and Other Festivals.

On June 28th, 1925, the 3rd Sunday after Trinity, St. John's Church at Ayton, Rev. J. Langholz, pastor loci, celebrated the 25th jubilee of the dedication of its church. In the morning service Rev. Dr. Hoffmann preached on Psalm 81, and Rev. Dr. Zinck, spoke in English on the union of the two Canada Synods. At the evening service Dr. Zinck was the speaker of the occasion (Text Eph. 1:7), and Dr. Hoffmann spoke on "Our Seminary and College." The choir of Elmira church contributed to the beauty of the services by several anthems.

On July 12th, 1925, the Mission congregation Bethlehem of Woito, Renfrew Co., 20 families strong, was privileged to dedicate its new church. The dedication was performed by the pastor loci, Rev. K. Blohm, with the assistance of Pastors Schroeder, Henkel, Voss, Kutter, Grunwald and Grauer. Rev. Prof. Henkel preached the dedication sermon, and conveyed to the congregation the greeting and felicitations of Synod. The collection amounted to \$800. The new church is built of cement blocks, at a cost of c. \$13,000, of which \$8,000 are paid.

Trinity congregation at Walkerton reopened its simply and tastefully renovated church, the altar of which is now adorned by a Christus statue donated by the Ladies' Aid Society, on the 8th Sunday after Trinity, August 2nd, 1925. At that day also the installation of the new pastor, Rev. S. Wittig, took place. Rev. H. Rembe, Sr., preached at the morning service, and Rev. A. A. Zinck, D.D., preached in English in the evening.

On August 9th, 1925, St. Peter's Congregation at Heidelberg, (Rev. H. L. Lamack), conducted a jubilee service of its 80 years of existence, in the church dedicated 55 years ago. At the morning service two former pastors preached, Rev. E. Schuelke and Rev. R. Geelhaar, in the evening Rev. C. Zarnke, a son of the congregation, and Rev. Dr. Zinck. The male choir of St. John's Church, Waterloo, and the church choirs of Erbsville and Heidelberg also took part in the service.

August 16th, 1925, was an especially happy day and festival for St. Matthew's Church, Kitchener, Rev. J. Schmieder, pastor loci. The renovated and artistically decorated church was reopened. A Christus-statue (Thorwaldsen) adorns the altar and the walls of the altar-niche are panelled in oak. At the same time a set of organ chimes, donated by Mr. Fr. Daub in memory of his wife, Louise Schmidt, were set apart for sacred use, and two artistically engraved collection plates were presented to the Church by the Catechetical Class of 1925. At the morning service Rev. C. Zarnke preached, and in the evening Rev. F. E. Ober-

lander, D.D. At a service on Monday evening for the neighboring congregations the undersigned conveyed the Greetings of Synod; Rev. C. S. Roberts spoke as pastor of the neighboring congregation, and Rev. Dr. E. Hoffmann as founder, and first pastor of St. Matthews congregation. The Revds. E. J. Fischer and S. Wittig officiated at the altar.

After many improvements and embellishments especially on the church lot, had been carried out at St. James church, Hespeler (Rev. A. C. E. Grotke), also the interior of the church was suitably re-decorated last summer and the work of renovation therewith concluded. The congregation now possesses a beautiful, inviting church. Especially the church-lot and the situation of the church affect one in a friendly and inviting way. The reopening occurred on Aug. 23rd, 1925. The festival preachers were Rev. Prof. H. Schorten and Rev. Prof. C. H. Little, D.D.

St. John's Church, Waterloo, Rev. C. S. Roberts, pastor, entered the ranks of celebrating congregations on Sept. 20th, 1925. After services had been conducted in the Sunday School Room for three months, the congregation was privileged on the above date to re-enter its completely renovated church, which had been beautifully re-decorated at a cost of \$6000. New electric lighting and fixtures had been installed, two brass vases had been donated by the Luther League, an altar-cross by the Bible-Class, a carpet for the altar-space by the Ladies' Aid, new collection plates by the Church Council, and several dozen new Common Service Books by the Men's Society. Rev. H. Sperling, Ph.D., preached at the German service, and the pastor loci at the evening service. Let it be mentioned here also that some improvements were made on the parsonage.

On the same Sunday as St. John's, Waterloo, St. John's in Petawawa celebrated an unusual festival: the dedication of the first rural parish hall within the Synod. A large festival congregation and friends from the neighboring congregations gathered before the parish-house in the afternoon. After the singing of hymns, scripture-lesson and prayer the door was opened by the pastor loci, Rev. A. Grunwald, and the building set apart for its purpose by a further service in the assembly hall. Addresses were given by Rev. K. Blohm and the President of Synod. In the evening Rev. Ebinger, of Ottawa, spoke to the young people and the pastor loci gave an illustrated lecture on Dr. Martin Luther's life. The p arish hall is built in the style of a modern school, 40x60 ft., and consists of hall, auditorium and platform. The kitchen is located in the basement.

On Oct. 25th, 1925, St. Paul's Church, Morrisburg, Rev. A. G. Jacobi, celebrated the 50th anniversary of the dedication of

its church. On this day two altar-chairs and memorial-windows were dedicated. Rev. Prof. N. Willison, Litt. D., preached on Luke 5:4 at the morning service. In the afternoon Rev. L. McCreery spoke on the work of the pastors and the congregation during its 50 years of existence, and at the evening service Rev. Theo. Iseler spoke on "The Church."

On Nov. 22nd, 1925, Zion Church, Massey, Rev. J. Koehle, was privileged to dedicate its village church, purchased from the Presbyterians and completely changed and renovated. Rev. G. Brackebusch and General Secretary P. Ludwig, who were on a tour through the Mission fields, were the Festival speakers.

St. Peter's Church, Ottawa, Rev. L. McCreery, has undertaken considerable changes on its church property. The basement has been changed so that it meets all requirements of the Luther League and Sunday School. The Luther League presented a piano to the congregation.

On March 25th, 1926, Rev. L. Kalbfleisch, Elmira, informed me that the St. James congregation had sold its old parsonage for \$2575.00, and that during the summer a two-storey modern parsonage would be erected beside the church. Building is now in progress and is to be finished in September.

5. PERSONAL.

1. Marriages: The following pastors were married by Rev. J. Schmieder:

On June 17th, 1925, Rev. S. J. Wittig and Miss Delphine Louise Kraemer, Kitchener.

On June 18th, 1925, Rev. Edgar J. Fischer and Miss Irene Christine Heldmann of Kitchener.

On June 23rd, 1925, Rev. Karl Raymond Cronmiller, and Miss Martha Auguste Margaret Schaefer, of Kitchener.

On Oct. 6th, 1925, Rev. C. Zarnke, and Miss Delphine Marie Scheifele of Conestogo.

On Nov. 9th, 1925, Rev. Hans Mangelsen and Miss Katherine Schmidt of Milverton, were married in the parsonage at Listowel by Rev. R. Geelhaar.

2.—Jubilees: On June 17th, 1925, Missionary Rev. E. Neudoerffer, India, celebrated his silver jubilee. The congratulations and felicitations of the Synod as also a jubilee gift from the brethren were transmitted to him by cable.

On Sept. 23rd, 1925, Rev. and Mrs. Schroeder, of Pembroke, were permitted to celebrate the rare, but happy festival of their golden wedding. Rev. P. Kleine, President of the Eastern Conference, conducted the church service in Zion Church. May our Heavenly Father grant the venerable Jubilee couple a peaceable eve of life!

On Dec. 5th, 1925, it was 50 years since Rev. E. Neudoerffer, Sr., was ordained to the holy office of the ministry. Rev. Neudoerffer resides with his daughter in Mooretown, N.J. Greetings and felicitations of the brethren were sent to him by wire, and the usual jubilee gift by letter through Rev. E. Holm.

On Dec. 17th, 1925, there gathered in Waterloo in spite of the approaching Christmas Festival, 24 pastors in order to celebrate in the Seminary chapel, among the professors, a number of students, and the befriending families, the 25th jubilee of ordination of Rev. Prof. H. Schorten. Rev. Dr. Hoffmann and the undersigned delivered addresses befitting the occasion, and Rev. Dr. Maurer and Rev. Prof. Henkel acted at the altar. Rev. Holm presented the Jubilee gift in the name of the pastors and Rev. R. Geelhaar the greetings and also a present from the Listowel parish.

Toward the end of February, 1926, the St. Matthew's congregation at Hanover commemorated the close of the 30th year of the pastorate of Rev. H. Twietmeyer. Of the active pastors of the Synod Rev. Twietmeyer is now the longest at one and the same church.

- 3.—Distinction: An especial honor and well merited distinction was given to the senior of our Synod, the Rev. Fr. Veit, Kitchener. On the recommendation of the Faculty of the School of Arts at Waterloo, A. O. Potter, Ph.D., Dean, the Rev. Fr. Veit was granted the degree of Doctor of Divinity from the Western University, London, Ont. The Synod rejoices with its senior, accords him cordial greetings and expresses its gratitude for his many faithful services.
- 4.—Sickness and Death. With joy we can report that Rev. H. Hamfeldt has since a few months back completely recovered from a long illness, and Rev. K. Blohm also, looks with more hope and courage into the future and feels stronger again, now having a less arduous field of labor. Pastors W. A. Schmidt and A. G. Jacobi were also afflicted with sickness.

Unfortunately also the parsonage inmates of Kitchener (St. Matthew's), Sebastopol and Ellice have had hard and dread battles with disease which are not yet entirely won. In our prayers

we will remember the pastors' wives and families before God's Throne of Grace and pray Him to let His Mercy be new each morn, and to help.

With deep sorrow and sadness the entire Synod, pastors and congregations, received the message of the passing of its greatest leader and teacher, Rev. Dr. E. Hoffmann. Seized with a chill at the time of preparation of his Easter sermon for his little congregation in St. Jacobs, he had to take to his bed during the afternoon, and soon pneumonia set in. On Sunday, April 11th, 1926, at half past ten in the evening, surrounded by his family, he was privileged to enter into the joy of his Lord. With our late highly respected Dr. Hoffmann, a noble, highly talented figure has passed on. None did and could serve the Lutheran Church in Canada in so many various offices and in so many ways as Dr. Hoffmann. He was also well-known beyond the boundaries of Canada, and his word and appearance were of great influence. The funeral service took place on April 14th. A private service for the family was conducted in the home at 1.30 p.m. by Rev. C. S. Roberts, and a public service was held in St. Matthew's church, founded by the deceased, in which the pastors of Synod, the Seminary Board, the Faculties, and Student body took part. The English oration was delivered by Rev. Dr. Zinck, President of the Seminary and College, and the German sermon by the President of Synod. The church has suffered a great loss, but we submit under the Almighty Hand of God Who is Providence indeed, and we pray with the Psalmist: "Return, O Lord, how long? and let it repent thee concerning thy servants. And let the beauty of the Lord our God be upon us, and establish thou the work of our hands upon us, yea, the work of our hands establish thou it."

A few days later the parsonage in Toledo was placed in mourning through the death of a grandchild.

Let it be also mentioned here that Rev. J. Badke, for many years a member of the Canada Synod, died at an advanced age, toward the end of February, 1926, in Brantford, and was buried by Rev. Cronmiller.

The cordial sympathy of the Synod is hereby extended to all in their sorrow.

6. Announcements.

On June 15th, 1925, the undersigned attended as delegate of Synod, the 135th meeting of the New York Ministerium at Niagara Falls, N.Y., Rev. H. Brezing, pastor loci. Your President enjoyed the privilege of addressing the convention and of conveying to it the greetings of the Canada Synod. This day was

exclusively devoted to the merger-question. The result of the discussion was the resolution to table this matter until the special meeting to be held in the fall of 1925. At this special meeting on Nov. 10th and 11th, 1925, some alterations of the submitted constitution were made and then the proposed constitution adopted. Therefore the merger of the New York Synod and the New York and New England Synod with the Ministerium of New York may be expected in the near future.

Your President, together with Rev. O. C. D. Klaehn, D.D., and Rev. H. Sperling, Ph. D., also attended the German General Conference of the U. L. C. in Mt. Vernon; Rev. G. V. Bosse, pastor, on Oct. 20th and 21st, 1925. For the information of this body may it be said that this Conference is sanctioned by the U.L.C., but is without legislative authority, and submits its resolutions and recommendations through the Committee on German Interests to the U.L.C. It concerns itself with the problem of German Education, Publications and Mission interests. 150 delegates were present. The convention was honored by the presence of Rev. Dr. F. H. Knubel, Rev. Dr. W. J. Morehead and Rev. Dr. F. G. Gottwald.

On July 23rd, 1925, a letter was received from Rev. M. Voss, then President of the Eastern Conference, stating that a free-conference between the pastors of the Canada and Missouri Synod was held and that the wish had been expressed to ask the Executive Committee of Synod to appoint a committee that should meet a committee of the Missouri Synod at the close of the convention at Dashwood. As we were informed that the Committee on Co-operation had planned to go to Dashwood, the matter was referred to this committee with the request to give it the proper attention. Rev. Dr. Klaehn, chairman of above committee sent into the Executive Committee a comprehensive report. We assume that this Committee will also submit a short report to the Synod.

On Dec. 16th, 1925, I received a letter from Rev. Prof. C. V. Pilcher, D.D., Wycliffe College, Toronto, in which I was requested to appoint a committee to discuss with a committee of the Anglican and United Church the organizing of a Canadian Council of the World Alliance for Promoting International Friendship through the Churches." In order to furnish sufficient information to the Synod the Revds. J. Maurer, D.D., Vice-President of Synod; P. S. Baringer and C. F. Christiansen, were appointed such a committee, and Rev. Pilcher notified that this committee would participate in order to obtain further information.

Rev. O. C. D. Klaehn, D.D., attended the opening of Parliament at Ottawa, on Jan. 7th and 8th, 1926, as representative of

the Lutheran Church. This afforded him as he reports, an opportunity to meet the Consul-Generals of the Lutheran countries and discuss the Immigration work.

In Oct. 1925, Rev. Dr. Hoffmann resigned as President of Waterloo College and Seminary. Rev. Dr. Zinck was appointed by the Board of Governors as his successor, and took charge of this important position on Jan. 1st, 1926. May the Lord of the Church bless him in his high, responsible office, and may the Synod, pastors and congregations faithfully support him!

7. RECOMMENDATIONS.

As the work and obligations of the Synod are continually expanding and becoming more important, and this means the utilization of our whole strength, it would be advisable to create alongside of the Young People's organization and Women's Missionary Society, also a men's organization. Your President recommends to the honorable Synod the appointment of a committee for the purpose of uniting the local men's organizations into a Synodical Brotherhood.

As is generally known, a campaign for the Ministerial Pension and Relief Fund is to be initiated on Reformation Sunday, 1927. For two years plans have been made and discussions taken place. When it is put into effect it should be made a complete success. It is the duty of the Church to support this cause energetically. It is doubly the duty of the Lutheran Church because she does not place her pastors in as favorable a position financially, as other denominations, which above that grant also a higher pension. The Co-operating committee named for this purpose, will suggest to Synod a certain plan. The undersigned would earnestly request at this time that the pastors lay aside all false modesty as to presenting the work to their people, but above all give the Board all information desired; that our lay delegates give this plan full publicity in the congregations, talk about it, and make this drive as easy and unembarrassing to the pastors as possible; that every congregation participate in this drive; and that the Synod set apart one evening of its convention of 1927 for this purpose.

As in former years, the Synod should this year also request the Conference to hold joint Reformation Services in their districts.

The wish has been expressed that a Hoffmann Memorial volume be published. Besides a biography and testimonial of his services also a selection of his sermons and literary works should be included. Such a Memorial volume would render decided as-

sistance to the Seminary Board in the collection of a Hoffmann Endowment Fund.

Other matters which await the decision of Synod will be brought forward by the Committee on Correspondence.

Herewith I have reached the end of my report and hope to have given an account of the outstanding occurrences of the last year. May the Father of our Lord Jesus Christ be among us with His Blessing, direct us through His Holy Spirit, and strengthen us in brotherly communion. We commend our dear Church with all her needs, cares and problems to Him, the Thrice-Holy, for His is the Kingdom, and the Power and the Glory.

This report was received and handed to a committee on President's report, to which the President appointed the following brethren: Pastors Henkel, Baringer, Kutter, Alberti, Gomann, and Delegates Bitzer, Klaehn, Ramsperger and Summerfeldt.

On motion the chair was authorized to appoint a Press Committee for the daily and Church papers. Pastors Grotke, Little and Alberti and Delegate Lidkie were appointed to this committee.

The President appointed as a Committee on Conference Minutes: Pastors Maas, Mosig, Dr. Sperling, W. A. Schmidt, Jacobi, and Delegates Wolff, Kalbfleisch and Pfeffer.

At this time the President introduced to Synod, Mayor Treleven of Hamilton, who addressed the Synod, welcoming the pastors, delegates and visitors. Rev. Dr. J. Maurer, Vice-President of Synod, made a suitable reply. It being the King's birthday, the English Secretary of Synod offered prayer in behalf of the King and Empire, after which the Synod joined in singing the National Anthem.

The President appointed the following committees:

The President declared the session open for business. The Minutes of the morning session were read in both German and English, and adopted.

Rev. H. Henkel resigned as assistant to the German Secretary. Rev. E. Schuelke was elected in his place.

The Report of the Ministerium.

- 1. That the Rev. E. Tuerkheim, of Sullivan Parish, who comes with a letter of honorable dismissal from the Manitoba Synod, be received into full membership with this body.
- 2. That Candidates Schultz and Vorkoper, who have graduated from the Waterloo Seminary, and received calls to congregations in this Synod, be ordained at the Sunday Morning Service, June 6th, and received into full membership with Synod on the following morning.

The report was adopted.

Dr. Maurer introduced the Rev. E. Tuerkheim to Synod, and the latter signed the Constitution of Synod.

Dr. Little reported that he had a matter concerning the German-English Catechism of the Synod to which he desired to call the attention of Synod. Rev. J. Alberti stated that he was ready to report for the Committee on the German English Catechism.

- Rev. P. W. Mueller stated that he had a matter on which he requested information, and that he desired to raise some questions concerning the constitution of Synod.
- Rev. P. S. Baringer stated that he proposed to present resolutions regarding entertainment of Synod, a change in the time of meeting of Synod, and a syllabus of all reports to Synod. He also gave notice of a motion regarding a Dr. Hoffman memorial.
- Rev. M. O. Heller asked information regarding Legal difficulties in the Province of Quebec, and some difficulties in the Eastern Conference.
- Rev. E. Holm reported that he wanted information concerning the payment of travelling expenses.
- Mr. W. G. Berner reported that his congregation (St. Paul's, Toronto) had forwarded a letter to Synod seeking information on certain points.

REPORT OF THE EXECUTIVE COMMITTEE OF THE EVANGELICAL LUTHERAN SYNOD OF CANADA

Dear Brethren:

Your Executive Committee has met four times since the last Synodical Convention, July 3rd and November 3rd, 1925, and

May 5th and June 2nd, 1926. Each meeting, except the last, was held in the Seminary office at Waterloo, the last meeting was held in the Parsonage, 104 Hughson St., Hamilton. The following matters are brought to your attention.

1. At the meeting on July 3rd, 1925, a letter dated June 12th, 1925, was read, written by Dr. Freas, Executive Secretary of the Inner Mission Board of the United Lutheran Church, regarding Immigrant Mission Work in Canada. The Executive Committee gratefully accepted the offer of the Inner Mission Board of the United Lutheran Church to provide \$2,000 as salary for an immigrant Missionary, the Synod to provide a suitable residence for him in Montreal. The yearly appropriation for such residence should not exceed \$800. In order to meet this expense until January First, 1926, the President of Synod was authorized to send a circular letter to all the pastors and congregations explaining the matter and asking that a special offering be devoted to this purpose.

A Synodical Committee on Inner Missions was elected to look after this work, namely, President Reble, Pastors M. Voss and M. O. Heller, with Messrs J. C. Casselman, (Montreal) and A. Loa (Ottawa).

Pastor O. C. D. Klaehn, D.D., was recommended to the Inner Mission Board of the United Lutheran Church as a suitable Immigrant Mission Pastor for Canada. He was called by that Board for this work, and since October First, 1925, has carried on his work among the immigrants at Montreal and other Canadian harbours.

At the Executive Meeting of November Third, it was decided to include \$1800 in the Synodical Budget to be used for Inner Missions, and to instruct the Inner Mission Committee that it could expect not more than \$1200 of this sum. The Treasurer of Synod was instructed to forward these funds to the Secretary-Treasurer of the Synodical Inner Mission Committee.

The Synodical Treasurer was authorized to borrow, if necessary, not more than \$800 from the Mission Fund until January First, 1927.

- 2. On July 3rd, 1925, a letter from the Women's Missionary Society of Canada was received by your committee containing two requests:
- (a) The establishment of a Young Women's Hospice in Kitchener.

- (b) The appointment of a deaconess at Montreal, who could assist in Port Work. The former request was referred to a Committee, consisting of the Lutheran Pastors of Kitchener and Waterloo, to consider and report on at a later meeting. The latter request was referred to the Inner Mission Committee of Synod.
- 3. The question of calling a Mission Superintendent for Synod was discussed. Dr. Maurer was appointed to take the matter up with the Board of Home Missions and Church Extension of the United Lutheran Church, in order to ascertain what assistance they would give in this project. The correspondence in the matter is not yet complete.
- 4. At the July meeting it was decided that either the President or Vice-President of Synod should visit the Michigan Synod and discuss with it the dismissal of the congregations at Windsor and Sault Ste. Marie to the Canada Synod. Dr. Maurer, the Vice-President, visited the Michigan Synod, and reported at the November meeting of your Committee, that the Michigan Synod stood ready to dismiss both congregations to our Synod, so soon as these congregations expressed their desire to be so dismissed. At the Executive meeting of May 5th, 1926, Dr. Maurer reported that he had assisted at the installation of Pastor Cooper at Sault Ste. Marie, and that this Congregation had decided to join the Canada Synod.
- 5. At the July Meeting a committee was named to prepare the Synodical Budget for 1926. At the November meeting this committee presented the following Budget, which was adopted.

It was also decided that the system of distribution of apportionment to the Congregations hitherto in use in the Canada Synod be continued for the present.

6. At the November meeting a report of the Committee on Co-operation with other Lutheran Bodies was read. This report is left for disposal by the Synod.

- 7. The Synodical Committee on Education reported to the November meeting, recommending:
- (a) That aid to the extent of \$200 be granted to Student Irwin Gross of the Waterloo Seminary.
- (b) That Art. 7, Sec. 1, Sub. Sec. 1. of the Constitution be changed to read: "This Committee shall consist of three pastors and two laymen to be appointed annually by the Synod."

This Report was adopted and part (b) referred to Synod for action.

Treasurer Holm recommended the following change in the By-Laws: "That in By-Law 2, Section 5, the word "Quarterly" be changed to "Semi-annually", and the words "Seminary Board" be changed to "President of the Evangelical Lutheran Seminary of Canada". This was approved by the Executive Committee and referred to Synod.

- 8. At the May meeting a letter addressed to the President of Synod by Student Irwin Gross was considered and the following actions taken:
- (a) That Student Irwin Gross be given no further opportunity to preach or supply pulpits in this Synod, because of his theological position which would prevent him from signing the constitution of Synod.
- (b) That Mr. Gross be notified by the President of Synod that the Executive Committee of Synod held him morally obligated to return the \$200 previously advanced to him by the Treasurer of Synod.
- 9. A Committee appointed by the President of Synod to seek information concerning the formation of a "Canadian Council of the World Alliance for promoting international friendship through the churches" reported on May Fifth, 1926, to the Executive Committee. This report was returned to the Committee with instructions to present it at the Synodical Convention.
- 10. The Executive Committee recommends that the Delegates to the meeting of the United Lutheran Church be nominated by the Nomination Committee, and elected by Synod.
- 11. A recommendation of the Synodical Inner Mission Committee concerning necessary Pastoral care for the many Finlanders now immigrating to Canada was adopted at the May meeting and referred to the Executive Board of the United Lutheran Church, by whom it was handed to the Board of Immigrant Missions of the United Lutheran Church.

- 12. The President was authorized to secure a Synodical Seal bearing an inscription in English.
- 13. The following committees were named by the Executive Committee during the year.
- (a) Auditors for the books of the Synodical Treasurer: Pastors H. L. Henkel and A. Grunwald, and Delegate Geo. Dahmer.
- (b) Mission Fund Committee: Pastors H. Twietmeyer and E. Holm, and Mr. H. N. Huehn (Heidelberg).
- (c) Pastor E. Gomann was elected to the Examining Committee in place of Pastor J. Alberti who resigned.
- 14. At the meeting of June 2nd, 1926, applications for admission to Synod were read from Zion English Evangelical Lutheran Church, Sault Ste. Marie, and St. Paul's Evangelical Lutheran Church, Wallace Township, Perth County. Both applications were accompanied by the Constitutions of the congregations concerned, which constitutions were found to be in harmony with the Constitution of the Evangelical Lutheran Synod of Canada.

The Executive Committee therefore recommends that both these congregations be received into membership with this Synod.

On motion the report was received, and items 4 and 14 given first consideration.

Dr. A. H. Keck, President of the Michigan Synod, brought greetings from that body and also from the United Lutheran Church in America. He reported on the organization of the congregations at Windsor and the Sault, and declared that the Executive Committee of the Michigan Synod had recommended to both congregations that they should join the Canada Synod. A suitable reply to Dr. Keck was made by Dr. Willison.

A vote of thanks was extended to Dr. Keck and to the Michigan Synod for the kindness and splendid spirit which they have manifested.

Points 4 and 14 of the report of the Executive Committee were now adopted. The remaining points were adopted in order. The report was adopted as a whole.

At 4.00 p.m. Synod adjourned until 9.00 a.m., Friday, using the Lord's Prayer.

At 4.00 p.m. a memorial service was held for the late Dr. E. Hoffmann, a former President of this Synod, and formerly President of the Evangelical Lutheran Seminary of Canada, who died April 11th, 1926. Beautiful addresses were made by Rev. H. Hamfeldt and Rev. N. Willison, Litt.D. Dr. O. C. D. Klaehn acted as Liturgist.

SECOND SESSION

Friday, June 4th, 1926, 9.00 a.m., St. Paul's Lutheran Church, Hamilton.

The Matin Service was read by Rev. J. Maurer, D.D., Vice-President of the Synod. Roll was called. The German and English minutes of the previous session were read and adopted.

On motion it was decided that the address of Pastor Hamfeldt at the Hoffmann Memorial Service be printed in the Lutherische Herold and the Canada Lutheran, and that it be printed in Pamphlet form and distributed among the congregations.

REPORT OF THE INNER MISSION COMMITTEE

Your Committee begs leave to report its activities and the work under its supervision, as follows:

This Committee as appointed in the late summer of 1925, by the Executive Committee of Synod, numbers five men: Pastors Reble, Voss and Heller, and Messrs. Loa (Ottawa) and Casselman (Montreal). This committee met for its first meeting at Ottawa, Sept. 11th, 1925, its second at Montreal, April 27th, and its third in Hamilton, June 2, 1926. At the first meeting the Inner Mission Board of the U.L.C. was represented by Rev. Siever, Sec. of Immigration, and at its second meeting by Rev. Freas, Secretary of the Board. The Committee officers are Rev. Reble, Chairman, and Rev. Heller, Sec.-Treas. The work of the Committee involves two fields of activity, (1) Immigration, (2) Institutional.

As for the former, definite steps were taken last summer. Dr. Klaehn was called from his parish at Stratford, Ont., by the Inner Mission Board of the United Lutheran Church, to become Immigrant Pastor in Eastern Canada, with headquarters in Montreal. He assumed charge officially Oct. 1st, 1925. His experience and contacts as President of the Lutheran Immigration Board of Canada, serving as a groundwork upon which to build without delay. As arranged between the Inner Mission Board of the United Lutheran Church, and the Executive Committee

of our Synod. Dr. Klaehn's salary is being paid by the I.M.B., while all the expenses involved in the work, including house rent for the pastor, are to be met by the Synod. The Committee estimated a budget of \$150 per month to cover all needs. For the months just passed this was reduced to \$100 by the action of the Executive Committee.

It may be noted that in method of operation Dr. Klaehn is responsible to your Committee, to whom he makes monthly reports, while your Committee is responsible to the Inner Mission Board of the United Lutheran Church and the Executive Committee of our Synod, to whom they in turn make monthly reports of Dr. Klaehn's activity, and to whom also they present copies of the minutes of their meetings.

In these eight months of activity such commendable progress has been made by your Immigrant Pastor, in laying the foundation of general Lutheran Immigration work in Canada, that your Committee voices its sentiment in hearty approval of the selection of Dr. Klaehn to fill this important post. His natural inclination to be incessantly active stands him in good stead in meeting the many demands on his time which this position requires.

The estimated annual Lutheran immigration is 20,000 per year. All third class immigrants disembark at Quebec, St. John and Halifax, and continue to Montreal by rail. Through the cooperation of the immigrant workers of the United Church of Canada at these ports of entry, the names and points of destination are forwarded to Dr. Klaehn at Montreal and cases needing attention specifically noted. These names are in turn forwarded by Dr. Klaehn to the N.Y. office, for further distribution to the pastors in the neighborhoods where the immigrants settle. Your Committee would emphasise that all of us in our respective communities face a tremendous responsibility in looking after the welfare of these new comers to our shores. In this connection, as a special matter of interest, it may be noted that this recent entrance into the work of the Inner Mission field has been the means of acquainting us with Home Mission problems, affecting our Scandinavian and Finnish brethren in particular, which constitute a real challenge to our Church. We would urge your close attention to these matters as they occur in other reports and also on the floor of Synod.

As for the second field of activity coming under our supervision, namely institutional work, little has been done. A survey of our Synodical field was attempted by mail last fall, but met with little response. The Committee will attempt to formulate plans to coincide with the peculiar conditions in our Synod, but

their success of operation will depend entirely upon the support and co-operation given by our pastors. Aside from caring for our own constituency, Institutional work is our most fruitful opportunity for reaching and ministering to the great body of the unchurched.

The report was adopted.

Dr. Bachman, Chairman of the Inner Mission Board of the United Lutheran Church addressed the Synod on its Inner Mission problems, congratulating its Inner Mission Committee on its activity. Dr. O. C. D. Klaehn, gave an excellent review of the work which he is carrying on at the Port of Montreal. He asked that the members of Synod take an individual interest in his work, and assist him in an effort to place Lutheran immigrants in Lutheran communities. He answered several questions asked by the brethren.

The President was authorized to appoint a committee to formulate resolutions to stimulate interest in the Inner Mission work at Montreal. He referred the matter to the Inner Mission Committee of Synod.

On motion it was decided to defer until next year, action on the change in Article 6, Section 2 of the Constitution of Synod as proposed on page 24 of the printed English Minutes of 1925.

The report of the Nominating Committee was now received and voting took place. The session was extended ten minutes.

Rev. P. S. Baringer introduced to Synod the Rev. Dr. I. Chantry Hoffman, Eastern District Superintendent of the Board of Home Missions and Church Extension of the United Lutheran Church in America, Dr. C. S. Bauslin, College Secretary of the Board of Education of the United Lutheran Church in America, and Mr. Grant Hultberg, Manager of the United Lutheran Publication House at Philadelphia. The President heartily welcomed these brethren to the Convention.

Delegate Pauli of Stratford, and Delegate Westcott of Trinity, Hamilton, were excused for Saturday's Sessions.

The Synod adjourned at 12.00 noon, the President pronouncing the Apostolic Benediction.

SECOND SESSION (Continued)

Thursday, June 4th, 1926, 2.00 p.m., St. Paul's Lutheran Church, Hamilton, Ont.

The President declared the meeting open for business.

The minutes of the previous session were read in German and English, and adopted.

Dr. Bauslin addressed the Synod stressing the importance of religious education throughout the entire school life of our young people. He appealed for greater consecration and more united effort in prosecuting the work of the Church. The President expressed the thanks of the Synod to Dr. Bauslin. Dr. I. Chantry Hoffman of the Board of Home Missions and Church Extension brought greetings from his Board and also from the United Lutheran Church. He commended the work of the Synod, and gave brief reports of the Jewish Mission Board, the Immigrant Mission Board, the Foreign Mission Board, and the Board of Home Missions and Church Extension, appealing for united effort in evangelization. President Reble thanked him and asked him to convey the greetings of the body to the Executive Board of the United Lutheran Church.

Rev. Paul Ludwig, superintendent of the Board of Northwestern Missions of the United Lutheran Church brought greetings from that body, and spoke of his recent trip of visitation to Texas, the Northwest Provinces and to Ontario. He urged selfsupport on the part of some of the congregations at present receiving aid. He announced that during this year the newly organized Board of American Missions would likely begin to function.

Mr. Grant Hultberg, Manager of the United Lutheran Publication House of Philadelphia, spoke of the work of the Parish and Church School Board, and of the Board of Publication. He reported the revision of the Graded Course to be known as the Christian Life Course, and the preparation of a new Sunday School Hymnal. The Board of Publication issued last year 200,000 books, 600,000 tracts and 28,000,000 pieces of Sunday School literature and similar tracts. He brought the personal greetings of the Rev. C. R. Tappert, Editor of the Lutherische Herold.

The Rev. H. Hamfeldt, who previously at his own request, was honorably dismissed to the Ohio Synod of the United Lutheran Church in a few well chosen words of farewell, expressed his gratitude for the fellowship with Synod of the past years, and prayed the Divine blessing upon the Synod for the future. President Reble thanked Pastor Hamfeldt for his interest in and support of the Canadian work and wished God's richest blessing for him and his congregation in their new relationship.

The President welcomed Dr. Potter, Dean of Waterloo College.

Miss E. Szember, Canadian Missionary on furlough from India, spoke of the work in India, its methods, and the wisdom of supporting the Christian Education Programme in the Indian Field. President Reble thanked her for her address.

Mrs. M. Hagey, representative of the Women's Missionary Society of the Canada Synod, presented the report of that organization. On motion this report was received and ordered spread on the Minutes.

REPORT OF THE NECROLOGIST

Dear Brethren:

It is the sad duty of your necrologist to report the deaths of the Rev. Emil Hoffmann, D.D., and the Rev. Julius Badke.

The Rev. Emil Hoffmann, D.D., was born March 1st, 1862, at Oebisfelde, Province Saxony, Germany. He died at his home, Waterloo, Ont., after an illness of one week, April 11th, 1926.

Dr. Hoffmann's preliminary education was received in the schools at "Halle". Graduated from the Theological Seminary at Kropp in 1886, and, on coming to Canada shortly thereafter, accepted a call to the North Easthope-Wellesley-Gadshill Parish.

In Nov. 1887 he married Miss Pauline Treusch.

In 1888 he accepted a call to St. Paul's Church, Hamilton. During his pastorate, at Hamilton he was elected President of the Synod of Canada, which position he held for sixteen years.

In April 1904 he accepted a call to St. Matthew's Church, Kitchener, which he had previously organized.

In 1911 he celebrated the twenty-fifth anniversary of his ordination, and in the same year received the degree D.D., from Thiel College in recognition of his services to the Lutheran Church in Canada.

In 1912 he accepted a call to First Lutheran Church, Toronto. He was elected, at its organization, first President of the Board of Governors of Waterloo Lutheran Seminary.

In 1920 he resigned his pastorate in Toronto and accepted the Presidency of the Seminary to which the Board of Governors had called him, which position he held until Jan. 1, 1926, when he resigned the Presidency, but retained his professorship in the Faculty.

In 1923 he was appointed delegate to represent the Lutheran Church in Canada at the "Eisenach" convention in Germany.

In addition to his work at the Seminary he was also Pastor of St. James' Lutheran Church, St. Jacobs'.

In his death a life full of activity in the cause of the Master has ended. "Blessed are the dead which die in the Lord from henceforth: Yea, saith the Spirit, that they may rest from their labours; and their works do follow them."

Survivors are his widow, three sons, Frederick G., Walter J., and Paul H., and one daughter, Mrs. (Dr.) H. L. Merscher, four grandchildren, one brother, and two sisters.

From the evil to come he is taken away and his memory shall be in peace.

The Rev. Julius Badke was born at Evanbusch, Preussen, Germany, May 19th, 1850. With his parents he came to Canada in 1864, the family establishing their home in Kitchener (then Berlin). He lived at Kitchener for six years. Leaving Kitchener he went to Chicago, and in 1875 entered Concordia Theological Seminary at Springfield, Ill., graduating in 1880. Oct. 21 of the same year he was married to Miss Elizabeth Rittinger of Kitchener, at St. Peter's Evangelical Lutheran Church.

The first seven years of his ministry were spent in Wisconsin. In 1887 he returned to Canada where he served the congregations at Conestogo, Bridgeport, Breslau, 1887-1889; Humberstone and district, 1889-1904; Brantford 1904-1907; Auburn 1907-1911. In 1911 he retired and until the time of his death resided in Brantford.

He died at his home the evening of April 30th, 1926. Services were conducted at the home and Church by his pastor, the Rev. C. Cronmiller, assisted by the Rev. A. C. E. Grotke, of Hespeler, after which the body was interred at Mt. Hope Cemetery, Brantford, May 3rd, 1926.

Besides his widow he leaves one daughter, Mrs. E. S. Neff, of Brantford, and one son E. F. Badke, of Toronto, and seven grandchildren.

We would recommend that Synod pass the following resolution:

Whereas it has pleased Almighty God in His unsearchable wisdom to call from the Church Militant to the Church Triumphant, His servants, the Rev. Emil Hoffmann, and the Rev. Julius Badke, be it therefore resolved:

"That at this, the first meeting of our Synod following the deaths of these servants, we bow in submission to God's will, in prayer show our gratitude to God for the years of service rendered to the Church and ask Him for guidance and implore His comfort and mercy upon the Church and families in their sorrow and loss.

At 5.15 p.m. the Synod adjourned, using the Lord's Prayer.

THIRD SESSION

Saturday, June 5th, 1926, 9.00 a.m., Trinity Lutheran Church, Hamilton, Ont.

The Matin Service was conducted by Pastor C. P. Boerner.

Roll was called. The German and English minutes of the previous session were read and adopted.

A Telegram was read from Rev. Neudoerffer, Kotagiri, India, conveying greetings to Synod and sympathy because of the death of Dr. E. Hoffmann.

The Ministerium was called to meet at the close of the morning session.

On motion the Lay Delegates were called to meet at the close of the afternoon session.

Mr. K. Homuth, M.P.P. for South Waterloo, was welcomed and given the privilege of the floor. He gave a report for the Committee on Ministerial Pensions and Relief, as follows:

Hamilton, June 2nd, 1926.

The Synodical Committee on Ministerial Pensions and Relief met in St. Paul's Church with the following members present:

Rev. Mosig, New Hamburg; Rev. Holm, Conestoga; Mr. Kalbfleisch, Tavistock; Mr. Reckin, Wiarton; Mr. Westcott, Hamilton; Mr. Homuth, Preston, Mr. Casselman, Montreal.

Mr. Westcott was elected chairman of the Committee, and Mr. Homuth, Secretary.

Moved by K. Homuth, seconded by Mr. Kalbfleisch, that the representative of each conference be chairman of the organization of such conference, to be responsible for the organization in each congregation, and the collection of funds, and to cooperate with the chairmen of the other conferences in every way. Carried.

Moved by K. Homuth, seconded by Rev. Mosig, that Mr. Kalbfleisch of Tavistock be appointed special treasurer to administer the specially collected campaign expense funds. Carried.

Moved by Mr. Casselman, seconded by Mr. Reckin, that Rev. Mosig supply each chairman of a conference with a list of congregations, and the address of the pastors right after Synod. Carried.

Moved by Mr. Casselman, seconded by Mr. Kalbfleisch, that the Secretary write a series of articles on Ministerial Pensions and Relief, to be published in The Canada Lutheran. Carried.

The report was adopted.

It was resolved that we enter wholeheartedly into the campaign of the Board of Ministerial Pensions and Relief, and that our Synodical Committee be asked to co-operate fully with the General Committee in order that the \$5,000,000 be fully raised.

Rev. J. Koehle resigned as Managing Editor of the Canada Lutheran. Rev. W. H. Knauff was elected in his place Rev. Knauff resigned as associate Editor of the Canada Lutheran, and Rev. J. Alberti was elected in his place.

Mr. A. Gordier resigned as Trustee of the Mission Fund; Mr. Edwin Winkler, of Hanover, was elected in his place.

THE REPORT OF THE BOARD OF GOVERNORS OF THE EVANGELICAL LUTHERAN SEMINARY OF CANADA

As English Secretary of the Board of Governors of the "Evangelical Lutheran Seminary of Canada", I have pleasure in submitting the following report for the year 1925-26.

The Board held four regular meetings, and two adjourned meetings, throughout the year. In addition to the general routine business which naturally comes before the Board in ever increasing detail, owing to the growth of the institution other matters of vital importance were transacted. Dr. Willison was granted a year's leave of absence to do work at Queen's University, to qualify for the academic standard requisite for professor in our College of Arts. The Board congratulates Rev. Willison on the high standing attained throughout his course at Queen's, and for the competitive prize for poetry, which he won.

Mr. Valentine Zoeller of New Hamburg was elected by the Board to fill the vacancy caused by the death of Louis Peine. There was no other change in the personnel of the Board throughout the year. The officers of the Board are: Rev. J. Maurer, D.D., President; Rev. J. Schmieder, German Secretary, and Rev. P. S. Baringer, English Secretary; and Mr. A. L. Bitzer, Treasurer.

At the September meeting Dr. E. Hoffmann resigned as President of the Institution, expressing the wish to be relieved of the very increasing and arduous duties of administration. He, however, continued as professor until he was called to his eternal reward on April 11th.

The resignation of Dr. Hoffmann from the presidency of the institution called for the immediate selection of a successor. Happily, after only a few months, the Board received the welcome news that Dr. A. A. Zinck would accept the call extended him by the Board.

Our institution functioning under a three-fold development has made marked progress throughout the year. The total enrollment of the institution was 84, distributed as follows: Seminary 11, College 38, College School 35.

The reports of the heads of the departments to the Board show marked progress.

Next year will be held the first graduation exercise of Water-loo College when the graduates will receive the degree of B.A. from Western University. Truly we are training up a more educated ministry through the functioning of a B.A. Course.

Naturally the matter of finances receives and needs to receive a great deal of earnest and careful consideration. While it is within the scope of the Secretary's Report to present an abstract of the Treasurer's Report of the Seminary Board, the full printed report which will be submitted will be much more adequate.

It is sufficient to state that every congregation should meet its apportionment in full so that the cause of our institution may not suffer.

For the first time in the history of Waterloo Seminary the Board was obliged to charge a nominal fee for room rent from the College and College School students, Seminarians being exempt, in order to augment our income. This has helped greatly. Beginning with Sept., 1926, there will be an increase in tuition from \$50.00 to \$70.00 per year in the College. This likewise will provide an increase. Yet all this is not sufficient to maintain a proper balance without the utmost that we can do.

We are face to face with the need of securing an endowment for our school. We must think and act along this line shortly.

The Board has taken action in instructing the Secretary to present to the Synod, a resolution for the establishing of a fitting memorial to the late Dr. Hoffmann.

Action has also been taken by the Board looking to the filling of the vacancy in the professorship caused by the death of Dr. Hoffmann. The Board is desirous of calling Rev. E. Neudoerffer to this vacancy provided the Mission Board is willing to relinquish his services. The Board of Governors is in communication with the Foreign Mission Board and may be able to report more definitely to the Synod before its close.

The Board notes with great pleasure the granting of the degree of D.D. to Pastor Fred. Veit, pioneer of the Lutheran Synod of Canada, and faithful laborer in the vineyard of our Lord.

The Board expresses its appreciation for the great fidelity of its faculties for the efficiency of the heads of the departments, for the excellent discipline of the student body, and for the moral and financial assistance which the constituencies of the Lutheran Synod of Canada have rendered in making our institution a going and growing enterprise.

The following resolution of the Board of Governors of the Evangelical Lutheran Seminary of Canada, adopted at a meeting June 1st, 1926, was presented to Synod by the Rev. P. S. Baringer, Secretary of the Board:

"That we attempt to raise \$75,000 to build and endow a Seminary building to be known as Hoffmann Memorial Hall, but that no building operations be begun until \$50,000 have been pledged and not less than \$30,000 cash is on hand."

Delegates Lembke of Desboro and Summerfeldt, were excused from Sunday afternoon.

Synod adjourned at 11.30 a.m., using the Lord's Prayer.

MEETING OF MINISTERIUM

The Ministerium met on Saturday, June 5th, 1926, at 11.30 a.m. in Trinity Church. President Reble opened the meeting with prayer.

Dr. Little presented the following matter for consideration by the Ministerium.

In re of the Canada Synod Catechism, I desire to point out serious doctrinal error in Questions 238 and 240—in the answers given both in the German and English languages. Question 238 reads: What is meant by the Humiliation of Christ? Question 240 reads: What is meant by the Exaltation of Christ? The English answers to these questions are: I. "The Son of God put off His Divine form, power and glory and took upon Him the form of man."

II. "Jesus resumed His Divine form, power and glory, and glorified His human nature into the same."

In these answers a totally unlutheran conception of the Humiliation and Exaltation of Christ is taught. And inasmuch as this Catechism is issued under the authority of Synod it becomes a serious question.

The correct answer to question 238 would be: "Jesus Christ laid aside the full use of His divine power and assumed the form of a servant.

The correct answer to question 240 would be: "Jesus Christ resumed the full use of His divine power and glory and was glorified according to His human nature."

A foolish question is that numbered 499, viz.: Why can you not see the Body and Blood in the Sacrament? To which the absolutely incorrect answer is given: "Because Christ is glorified."

A manifest misprint is found in the English text on page 61, where in describing in what the image of God consists, this statement occurs: "Man's reason was now darkened, his will enslaved."

It was decided that all questions concerning the revision of the Catechism be referred to the Committee on Catechism, and that such a Committee be continued.

It was also decided that all necessary corrections to the text of the Catechism be inserted in the present edition of the Catechism.

The Ministerium adjourned at 12.00 noon, the President pronouncing the Apostolic Benediction.

THIRD SESSION (Continued)

Saturday, June 5th, 1926, 2.00 p.m., Trinity Lutheran Church, Hamilton.

The Minutes of the previous session were read in German and English, and adopted.

REPORT OF THE MINISTERIUM

The Ministerium met at 11.30 a.m., June 5th. It recommends: (1) That all questions concerning the revision of the Catechism be referred to the Committee on Catechism, and that such a committee be continued.

(2) That necessary corrections to the text of the Catechism be inserted in the present edition of the Catechism.

Respectfully submitted, A. A. ZINCK.

The report was adopted.

The President was authorized to appoint a Committee on Catechism. He appointed: Rev. Stockman, Dr. Little and Rev. Ziegler.

The following resolution was adopted:

"As the Seminary Board wishes to erect a fitting and worthy memorial for the deceased Dr. Hoffmann, in the form of a Seminary Hall, at a cost of \$35,000, and to raise further funds amounting to \$40,000 for endowment to cover running expenses and furnishings.

"Be it resolved; that the Seminary Board be authorized to proceed with the erection of the proposed Hoffmann Memorial Hall after the sum of \$50,000 has been pledged for that purpose, of which \$30,000 is to be in cash receipts; and that this money be obtained through private solicitation, without any general appeal to the congregations of Synod, and only after these sums have been assured, that a general appeal to congregations in the way of collections, or every member canvass can be made."

Mr. E. Christiansen reported that Zion Luther League of Pembroke had raised \$300 to endow a prize for a student at Waterloo Seminary, who in the opinion of the Faculty is most deserving of the same. This sum was now presented to the Synod and turned over to the Treasurer of the Seminary Board, by whom interest at the rate of five per cent. per annum is to be paid to the President of the Seminary. The Prize shall be known as the Kohls Memorial Prize, established in memory of Student H. Kohls, who died in 1921. The Synod expressed its thanks for this gift.

REPORT OF THE GERMAN HOME MISSION COMMITTEE

(Translation)

On request by the President of the Synod of Canada, I beg leave to submit the following annual report on the work of our German Missions. It was my privilege in the past synodical year in company with pastor P. Ludwig, General Secretary of the N. W. Board of Home Missions, to visit almost every individual mission congregation. The quarterly reports of the Secretary of the committee, Pastor C. F. Christiansen, as well as the annual reports of the Missionaries themselves, are at my disposal.

Arnprior-Northcote.

The Parish consists of 161 conf. members, of which 80 are paying members. They contribute \$740.00 to the support of the pastor. The light frame building of the church at Arnprior, which has been built nearly 40 years ago, is in great need of being repaired, and some of its members are seriously considering the building of a new church. The committee has advised the congregation not to undertake too much, and the congregation in response has acted wisely, and in forsight. The mistake of the

Bethlehem Mission congregation has probably served as a warning. Everyone admits that something has to be done, and this is praiseworthy. The Ladies' Aid and the Young People's Society have set as their goal the gathering of a fund for the necessary repairs. In the near future Northcote will be forced to renovate their church property. In both congregations under the leadership of the pastor the church-life is taking a normal course. Chesley.

This congregation consists of 129 confirmed and 64 contributing members. These, together with the Ladies' Aid raise \$800.00 as salary for the pastor. This is an advance of \$100.00 over last year's contribution. This affords the committee great joy, because on the one hand it shows greater zeal in the congregation, and on the other because the missionary at last receives his full salary. On activities of organizations one might mention the Young People's Society (of the congregation).

East Zorra-Plattsville.

Confirmed members 98, contributing members 36, annual salary \$540.00.

Notwithstanding the financial increase the missionary does not receive the recommended salary, and in his modesty refrains from making any requests in his behalf. Should a vacancy occur it would be difficult to secure a successor under the prevailing conditions, neither the congregation nor the Mission Committee will be able to render assistance beyond that which they are doing now. Of this my visit has convinced me.

Grattan-Sebastopol-South Algoma.

These three congregations number 230 confirmed members and 60 contributing members who raise \$700.00 of the pastor's salary.

The report of the Missionary does not reveal any essential changes, with the exception that the last and smallest congregation, South Algoma, consisting of 12 members, has renovated their church at a cost of about \$600.00, which is to be commended.

Lady Smith-Schantz.

This parish became vacant at the beginning of December, 1925, by the removal of Rev. P. Kleine. I was present at the time and was able to make recommendations to the congregations. They requested to hear Rev. Blohm of Rankin, which was granted, the same was elected by the congregations, by special consent of the Mission Committee, as it is not the custom to transfer a missionary from one mission to another. In this case the

prospective pastor had asked consideration of his poor health, hoping to find an easier field at Ladysmith than he had had at Rankin. The committee gave heed to this request. We hope that the good brother may be blessed with perfect health so he may soon be able to hold services at both places. Of the 246 confirmed members 71 contribute towards the missionary's salary the sum of \$857.00, so that the same is a little better than normal. On account of the missionary's ill health it has not been contested.

Massey-Chalk River.

Has 123 confirmed and 61 contributing members. These are to raise \$625.00 towards the missionary's salary, according to the missionary's report this amount has not been raised the past year. He will have to urge that the full amount be raised so that the Mission Committee will not be required to act. In general the Massey congregation has been very active. They have acquired a second chapel in the village, and have moved the parsonage from the country into town. In consequence Pastor Koehle will, within a few weeks, move into the parsonage. He officiates at both places regularly in the German and English language, therefore, no reduction in his salary should be made.

Palmer Rapids-Denbigh-Raglan-Maynooth.

The two preaching stations, Quadeville and Bangor, have become extinct. The churchly inclined people have united with the congregations at Raglan and Maynooth, the missionary would have had to devide his strength between the six places and would not have been able to do justice to any of them. As it is, the people have service every third Sunday, as Palmer Rapids and Raglan are in close proximity and enable the missionary to serve both the same day. It still remains our weakest mission station. However, our missionary labors zealously and faithfully in both languages. The four congregations number 270 confirmed and 100 contributing members, these raise \$664.00 of the pastor's salary, as a consequence of the liberally increased contributions of Denbigh. If the other congregations could be supplied with increased services they most likely would follow Denbigh's example. In such a case the support given by the Mission Board could be greatly reduced.

Rankin.

Rankin consists of the three congregations, Green Lake, Bonnecher and Bethlehem. The same day that the vacancy at Ladysmith was filled, Rankin became vacant, although candidates are available, the members do not appear very anxious in filling this vacancy, especially as Pastor Grauer, who during the

illness of Pastor Blohm acted as supply, has also offered his services during this vacancy. Greenlake and Bethlehem have taken advantage of this offer whereas Bonnecher has been cared for during this interim by Pastor Voss of Eganville. The Mission Committee recommended Student William Schultz of the Waterloo Seminary. Mr. Schultz visited the field during the Easter vacation with the result of a mutually favourable impression. The Mission Committee in conjunction with the three congregations have therefore extended a call to Mr. Schultz, and he has accepted. Mr. Schultz expects to enter upon his activities about June 20th. On account of the vacancy the annual and quarterly reports have not been received. The following items have been taken from the report of January 1st, 1926.

The Rankin parish, according to the report, consists of 247 confirmed and 74 contributing members, which raise \$700.00, or slightly more. In addition to this the parish supplies \$200.00 for fuel, and horse feed, so that with the allowance of the Mission Board the normal salary is provided. Within the near future this parish ought to become self-sustaining as the people are willing to assume all responsibilities.

Bethlehem is deep in debt on account of the new church which cost double the amount which had originally been estimated. They were compelled to seek the aid of the Synod, they were granted the privilege to receive contributions, however,, only a few of the synodical congregations have sent in an offering. Pastor and members should have asked contributions of all the congregations. Had this been done and had they responded as liberally as those who sent in contributions, the debt could have been reduced by half and the great need would have been supplied. It will be one of the pre-eminent cares of the new missionary, how to devise ways and means for reducing the debt. We assure him that he will not knock at our doors in vain. Henceforth Mission congregations will be required to submit their plans for new churches to the Mission Committee for approval, in order to prevent the repetition of such a case.

Wiarton-Owen Sound.

The last of our Mission stations. Mr. L. Kurdhofer, of the Waterloo Seminary has been called to Wiarton with the understanding that he canvass Owen Sound for the purpose of gathering those of our faith into a congregation. This undertaking has been successful, and though the congregation is still very weak, nevertheless, we hope, that the congregation being located in a fairly good size town like Owen Sound, its membership will soon increase. At the present this newly organized congregation is unable to assist in providing for the pastor's salary. For this

reason Wiarton has increased the salary 10%, by this action the Missionary's salary is made about normal. The two congregations number 109 confirmed and 66 contributing members, and have pledged themselves to raise \$440.00.

Auburn, Baden, Bridgeport are not on the list of our Mission stations, and are cared for otherwise.

Port Elgin. Before this congregation disolved, an attempt had been made to introduce the English language, as advised by the Synod. Rev. Geelhaar was sent to explore the field. His report was not encouraging. The congregation has now ceased to exist, I have, as instructed, protected the interests of the Synod at this dissolution. The church books have been transferred to me, into which a few items still had to be entered, also a Pennsylvania Agenda; and today I received a check for \$300.00 which sum has been realized through the sale of the church, which is to be transferred to the Mission of our Synod. There is also a communion set available for any congregation in need of it. If I am permitted to make a recommendation I would suggest to this hon. body to ask the Mission Committee to pay an annual visit to every mission congregation. This can be done without any synodical expense, and would prove to be of great benefit to our entire mission field. (Normanby) Ayton, May 31st, 1926.

The Synod authorized the publication of a twenty-four page issue of the Canada Lutheran for one year, and ordered this action to be communicated to the Nova Scotia Synod for sanction.

Prof. Henkel reported verbally on the Work of the Summer School Committee. The Synod voted to pay the expense in excess of Ten dollars on railroad tickets of the Pastors and Delegates of the Eastern Conference, and of Sault Ste. Marie, to the Synodical Conventions.

Synod adjourned at 5.10 p.m., using the Lord's Prayer.

FOURTH SESSION

Monday, June 7th, 1926, 9.00 a.m., Trinity Lutheran Church Hamilton, Ont.

Matin Service was read by Pastor R. Pfeiffer.

On motion the roll call was omitted.

The German and English minutes were read and adopted.

On motion the Rev. J. Alberti was added to the Catechism Committee.

Rev. W. H. Knauff introduced the Rev. H. Brezing of Niagara Falls, who came as Fraternal Delegate of the New York Ministerium. He was welcomed by President Reble. He brought greetings from his Synod, and congratulated the Canada Synod on the success of the first year in the history of the merged body. He expressed the sympathy of the Ministerium over the death of Dr. Hoffman. The President thanked Pastor Brezing and asked him to convey to the Ministerium the good wishes of the Canada Synod.

The newly ordained Pastors Schultz and Vorkoper were now formally received into Synod and signed the Synodical Constitution.

REPORT OF THE COMMITTEE ON CONFERENCE PROCEEDINGS

Article 5 was stricken out. The report was adopted as follows:

Hamilton, June 5, 1926.

Ev. Luth. Synod of Canada.

Gentlemen:—Your Committee on Conference Matters begs to submit the following report.

(1) The Books of the Stratford, Hamilton, Kitchener and Hanover conferences were made available, that of the Eastern Conference not being submitted.

- (2) According to the constitution of Synod each Conference President should send in a report, but only the President of the Stratford Conference has reported.
- (3 From the books of the Stratford, Hamilton, Kitchener and Hanover conferences we note that each of them has held two conferences, namely, Fall and Spring.
- (4) As the Hanover Conference has, as yet, not held district conferences, we would recommend that they join in establishing this custom.
- (5) We note with pleasure in the minutes of the Kitchener Conference the interest displayed by Mr. Karl Homuth, member of the Provincial Parliament for South Waterloo in presenting the motion that the fees be remitted in the passing of the bill for the changes necessary in the Seminary charter. The Kitchener Conference recommends to this body that the Synod through its Secretary express the gratitude and appreciation of the Synod for Mr. Homuth's action.

The following resolution was now adopted; that this Synod looks with favour on the meeting of the German Conference of the United Lutheran Church upon the territory of this Synod...

COMMITTEE ON MEETING OF CHURCH COUNCILS.

Your Committee has to report that the Convention of the Church Councillors of the former Central Conference, was held in St. James' Church, New Dundee, Ont., July 1st, 1925. Eight pastors and fifty-one delegates were present. The officers of the Convention were re-elected: President, Rev. O. Stockmann; Secretary, Rev. J. O. Schmidt.

The following subjects were discussed at the meeting: "Christian Unity", essay of Mr. Holz, Mannheim. "Value of the, German Mother Tongue", address by Mr. Burschatzky, New Hamburg.

This meeting showed again by the fair number of participators, and the interest taken in the discussions, that it met a requirement, therefore your committee recommends that Synod encourage the continuation of the same or the formation of new ones, where joining with the existing one is not advisable.

REPORT OF THE COMMITTEE ON CO-OPERATION WITH OTHER LUTHERAN BODIES IN CANADA

This Committee, acting under instructions from the President of Synod, visited the Ontario District of the Missouri Synod on August 19-20, 1925, and discussed with them the possibility of further negotiations with regard to holding conferences or a colloquium as requested by the Eastern Conference of the Canada Synod.

On the request of pastors of the Eastern Conference of our Synod, and in view of the cordial reception given your Committee at Dashwood, we recommend that Synod appoint a committee to meet with a similar committee appointed by the Ontario District of the Missouri Synod, to carry on further negotiations looking toward closer relations between the two bodies, and in case it is deemed wise, to arrange for holding the colloquium requested.

- 3. In view of the arduous work of the German Secretary of Synod, and the very careful way in which it was done, your committee recommends that an honorarium of \$100 be given the Secretary.

REPORT OF COMMITTEE ON CONSTITUTION OF CANADA LUTHER LEAGUE

Hamilton, Ont.,

June 3rd, 1926.

To the Hon. Synod of Canada.

We your Committee appointed to look into the matter of harmonizing the Constitution of the Luther League of Canada, with that of the Synod, beg leave to report:

- (1) That the Canada Luther League, as at present constituted is patterned after the plans laid down by the Luther League of America, which is the official Y. P. organization of the U.L.C.
- 2. That the said Canada Luther League will in all probability unite with the Jugendbund under the name of The Luther League of the Evangelical Lutheran Synod of Canada, at Kitchener, Labor Day next.
- 3. We recommend that this Committee be appointed to stand until after said merger, when the Constitution will be finally adopted, as until then no final report can be given.

REPORT OF COMMITTEE ON CORRESPONDENCE

Your Committee has given careful consideration to the correspondence referred to it by the honorable President and begs leave to make the following report.

- 1. The Canada Synod has been requested to share once more in the work of mercy carried on by the National Lutheran Council. The total amount asked for from the Synods of the U.L.C. is \$50,000, and our share of this amount is designated to be \$1,062.55. Aid is to be given this year chiefly to the crippled Lutheran Church in Russia, and to our orphaned missions in heathen lands. Your committee recommends that our congregations be asked to make an offering for this cause, averaging perhaps ten cents per confirmed member, and that this offering be made as soon after the meeting of Synod as may be convenient to the individual congregations.
- 2. The Secretary of the U.L.C. calls the attention of the Synod to the necessity of electing at this convention our delegates to the general body. Fifty-eight parishes are on the roll of the Canada Synod at the present time. We are entitled, therefore, to six clerical and six lay delegates. Your committee recommends that this number be elected.
- 3. With reference to the proposed amendment to the Constitution of the U.L.C. (1924 minutes, page 48), your committee recommends that the Canada Synod vote approval.
- 4. The Executive Committee of the U.L.C. urges active cooperation of Synod in matters of publicity particularly in view of the fact that the U.L.C. has contracted with the N.L.C. for special service which, it appears, is at our disposal. We recommend that our official reporters be charged with the duty of turning news of nation-wide interest into these channels.
- 5. The Executive Committee of the U.L.C. has taken action stressing the desirability of raising the apportionment in full for the year 1927. Your committee recommends that this matter be referred to our Executive Committee for suitable action.
- 6. A communication from St. Paul's, Toronto, dated May 31st, 1926, and signed by the Secretary of the congregation, states that at a congregational meeting objection was taken by several members to a number of matters bearing upon the Constitution of our Synod and its adoption at the Merger Convention in Tavistock. While the letter does not state that the objections made by several members received the support of the congregation as a whole, your committee has nevertheless given the subject matter of the letter detailed consideration.

- (a) The opinion is expressed that "the constitution should have been submitted to the congregation for approval before being adopted by the convention." Your committee offers the information that the Model Constitution for Synods was accepted as a basis for union in 1923, that the important changes deemed necessary for our local needs were fully discussed in 1924, and action taken thereon recorded in full detail in the printed minutes of the Central Synod of that year, and that a complete copy of the proposed constitution was mailed to the pastors of all congregations one month before the final adoption took place in 1925.
- (b) The letter states that "it was felt that all important matters should be presented to the congregations in agenda form before a convention." Your committee recommends that Synod instruct the secretaries to prepare a bulletin containing all important reports of officers and committees and to place the same into the hands of all pastors and delegates two weeks before the meeting of Synod.
- (c) The letter further declares that "the apportionment system should be abolished in favour of free offerings", but that if this is not feasible the basis of figuring out the apportionment for each congregation should be so changed as not only to include the number of confirmed members, but also the average contribution for current expenses, the possession of a "manse", the location of the church in city or country and other matters. Your committee were agreed that the apportionment system is not the ideal of genuine Christian benevolence, and we also believe that the basis on which the apportionment for each congregation is figured out, is not fair to all alike, because, while each congregation is apportioned the same per member, the congregations themselves are not the same, but differ from one another in every conceivable way. A system that is efficient in meeting the requirements of our missionary and benevolent operations and at the same time just to all will find, we venture to say, immediate acceptance. We suggest that interested persons seriously attempt to solve this difficult problem and present their findings and plans to Synod.
- (d) The letter says of Art. X,, Sec. 4, of the constitution that "it appears that the purpose of the article seriously endangers the liberty of the congregation," and asks for an interpretation. Your committee finds that this paragraph of the Constitution embodies the judgment of the courts of Canada and of other countries, and is the law of the land. We can sense in it nothing that endangers the liberty of any congregation belonging to the Synod. On the other hand we cannot understand how, in case of strife or division the Synod could recognize as the lawful

congregation that part which rejects the Synod's faith or revolts against the constitutional provisions or it obligations as a member of Synod.

- (e) Our interpretation of Art. X, Sec. 5, as it bears upon congregational constitutions that conflict with the constitution of Synod, and that were in force before adoption of the constitution of Synod is, that congregations should strive to bring their constitution into harmony with that of their Synod, but if it seems to be more desirable to change the constitution of Synod, this also can be done in a manner prescribed by the constitution itself.
- (f) Finally the question is asked whether under Art. XI. "inability to pay apportionment amounts to a violation of the constitution." Your committee was of the opinion that such inability does not amount to willful disregard or violation of the constitution. Ultra posse nemo obligatur.

When we turn back in the pages of our history and look into the minutes of this venerable body, it so happens that we find a struggling mission congregation of Pioneer Lutherans in the City of Toronto joyfully reporting the raising of \$3.00 per confirmed member for benevolences, in addition to their self-sacrificing contributions for building and current expenses, and this 60 years ago. Brethren, let us be slow to plead inability, but quick to catch the inspiration which the example of the past, rich in faith and good works, holds for all of us.

REPORT OF MEETING OF LAY-DELEGATES

Mr. A. Ramsperger was elected Chairman, E. B. Christiansen, Secretary.

- 1. Group insurance for clergy was discussed. Delegates believed it a great benefit, if congregations would take this up, and thought it would be possible to carry this through if the appeal were made. Resolved, that if such a group insurance plan were desired by the pastors, that the Laymen would take it up in their congregations.
- 2. Information regarding the Lutheran Brotherhood was requested. Several delegates gave information as to its advantages in congregational work—made possible the formation of a Men's Bible Class, otherwise impossible. One delegate declared that heretofore practical Church work had been left to women, and even the children. The work of the Lutheran Brotherhood could be made a great factor in aid of Pastors' work. Resolved, that the pastors be requested to organize such a work in their congregations where possible.
- 3. Regret was expressed that response to the apportionment had generally been so poor during the past year. Several delegates reported that Printed annual reports showing individual giving tended toward improvement in this respect. It was respectfully suggested that some pastors might make a greater effort toward this end. General introduction of Duplex Envelopes was suggested as a help toward improvement. Resolved that pastors be requested, to more forcefully and more often present the cause of the apportionment to their congregations explaining its working, the duty of the congregation to make an effort toward its payment in full, the great harm and embarassment caused by failure to do so, and also the need of regular monthly remittances, and that delegates undertake hearty cooperation toward this end.

REPORT OF MUSIC COMMITTEE

Dear Brethren:—Your Committee respectfully desires to report that during the past year the members of the Committee have given assistance and advice to pastors and organists in musical matters whenever requested to do so. Such requests have been numerous enough to make us feel that Synod is aware of our existence.

A particularly noteworthy service was rendered to St. James Church, North East Hope, when Mr. O. G. Smith, accompanied by the other members of your committee and members of his choir gave a lecture on the music of the hymns and liturgy of the Common Service Book which was illustrated throughout with the help of the chair. St. James' entire congregation were present and your committee received many expressions of appreciation. A real service was rendered which is continuing to bear rich fruits. Your committee is willing to co-operate in a similar manner with other congregations or groups of congregations and welcomes invitations to assist in work of this kind.

Your committee regrets very much that it is necessary to call the Synod's attention to the fact that the public services usually held in connection with conventions and conferences are frequently conducted in such a careless, haphazard and undignified manner as to defeat the purpose of true worship. We are sometimes compelled, particularly on occasions as mentioned, to attend services so poorly planned and conducted in such a manner as to be an offence to God and a hindrance rather than a help to communion with Him. The Committee believes that it is within its province to recommend that Synod deplore this

state of affairs, disapprove of all unseemly and undignified conduct in the public worship of the Church, and urge a more lively realization of our professed purpose to conduct such worship in the Name of God and for the edification of His people.

REPORT OF ENGLISH HOME MISSION COMMITTEE

The English Home Mission Committee of the Canada Synod held a number of meetings during the year at the call of the President. The Mission at Welland-Bridgeburg, has been vacant during the entire year and the Mission at Guelph during the greater part of the year. These missions have been kept supplied by the Seminary.

At the first meeting of the Committee, Sept. 30th, 1925, the Rev. A. C. E. Grotke, was appointed to make a preliminary investigation of Woodstock. This was done. Pastor Grotke's report was to the effect that the situation would not justify the planting of a mission at that point.

At the meeting of the Committee, Nov. 11th, 1925, application was made to the General Board for a supplementary grant of \$5 per service for supplying the missions at Guelph and Welland-Bridgeburg. This the Board allowed.

At the meeting held Nov. 20 the Committee recommended the appointment of the Rev. S. Cooper as Missionary at large for Sault Ste. Marie and North West Ontario. This the Board granted.

On February 18th, 1926, the General Board was requested to pay the taxes on the lots held in trust by Trinity congregation, Hamilton, in East Hamilton. This was agreed to by the Board.

On Feb. 26th the Committee endorsed the request of the Mission at Guelph for a special grant of \$150 from the General Board toward the payment of its taxes. This was granted by the Board.

At a meeting of the Committee, March 19th, 1926, Student E. Heimrich was recommended to the Board to take charge of the North End Mission in Kitchener during the months of June, July and August, at a salary of \$100 per month, and Student

Gerald Ernst to supply the Guelph Mission during the same period at a similar salary, of which the Mission was to pay half and the Board half. These recommendations were both granted by the Board.

At a meeting of the Committee, April 12th, the sale of the lots in East Hamilton, and the rearrangement of the Church building at Guelph into a combined Church and parsonage were recommended. Both these recommendations received the endorsement of the Board.

At a meeting held May 20th, Student A. Gordier was recommended to take the place of Student Gerald Ernst at Guelph, who had decided to go to his-home in Nova Scotia. The Board was also requested to add \$500 to its appropriation to the Welland-Bridgeburg Mission.

At a meeting held June 3rd, Student A. Mehlenbacher was recommended to serve Welland-Bridgeburg during June, July, August and September, at a salary of \$100 per month, \$50 from the Board and \$50 from the Mission.

We, your Committee, submit the following budget for the year beginning July 1st, 1926.
