

PRESENT SEWER CONNECTIONS, ALSO THE ADJUSTING, LOWERING, AND REMOVAL OF TIMBERS OF PRESENT OUTLETS, IN THE FOLLOWING NAMED STREETS, AVENUES AND PUBLIC WAYS, IN THE VILLAGE OF WINNETKA, COUNTY OF COOK AND STATE OF ILLINOIS: IN CHERRY STREET AND CHERRY STREET EXTENDED, FROM A POINT IN LAKE MICHIGAN SIX HUNDRED THIRTY-ONE (631) FEET EASTERLY FROM THE EASTERLY LINE OF SHERIDAN ROAD TO SHERIDAN ROAD, EXCEPT THE PRESENT BRICK SEWER NOW LOCATED IN CHERRY STREET EAST OF SHERIDAN ROAD; IN CHERRY STREET, FROM SHERIDAN ROAD TO WALNUT STREET; IN WALNUT STREET, FROM CHERRY STREET TO WILLOW STREET; IN WILLOW STREET, FROM WALNUT STREET TO LINDEN STREET; IN LINDEN STREET, FROM WILLOW STREET TO ASH STREET; IN ASH STREET, FROM LINDEN STREET TO CHESTNUT STREET; IN CHESTNUT STREET, FROM ASH STREET TO OAK STREET; IN OAK STREET, FROM CHESTNUT STREET TO BIRCH STREET; IN BIRCH STREET, FROM OAK STREET TO PINE STREET; IN PINE STREET, FROM BIRCH STREET TO RAILROAD AVENUE; IN RAILROAD AVENUE, FROM PINE STREET TO THE NORTH LINE EXTENDED OF LOT FORTY-SIX (46) OF COUNTY CLERK'S DIVISION OF THE SOUTH EAST ONE-QUARTER OF SECTION SEVENTEEN (17), TOWNSHIP FORTY-TWO (42), NORTH, RANGE THIRTEEN (13), EAST OF THE THIRD PRINCIPAL MERIDIAN, COOK COUNTY, ILLINOIS; IN SHERIDAN ROAD, FROM CHERRY STREET TO A LINE TWO HUNDRED THIRTY-FIVE (235) FEET NORTHERLY FROM AND PARALLEL TO THE NORTHERLY LINE OF ELM STREET EAST OF SHERIDAN ROAD; IN OAK STREET, FROM SHERIDAN ROAD TO A POINT TWENTY-FIVE (25) FEET EAST OF THE EAST LINE OF CEDAR STREET EXTENDED; IN POPLAR STREET, FROM OAK STREET TO A POINT ONE HUNDRED EIGHTY-SEVEN (187) FEET SOUTH OF THE SOUTH LINE OF OAK STREET EXTENDED; IN WALNUT STREET, FROM OAK STREET TO A POINT ONE HUNDRED FIFTY (150) FEET SOUTH OF THE SOUTH LINE OF ELM STREET EXTENDED; IN ELM STREET, FROM SHERIDAN ROAD TO A POINT ONE HUNDRED EIGHTY-ONE (181) FEET WEST OF THE WEST LINE OF CEDAR STREET EXTENDED; IN CHERRY STREET, FROM WALNUT STREET TO THE EASTERLY LINE EXTENDED OF THE CHICAGO AND NORTHWESTERN RAILWAY COMPANY'S RIGHT-OF-WAY; IN CEDAR STREET, FROM CHERRY STREET TO A POINT TWENTY-FIVE (25) FEET NORTH OF THE NORTH LINE OF ASH STREET EXTENDED; IN CEDAR STREET, FROM CHERRY STREET TO OAK STREET; IN OAK STREET, FROM CEDAR STREET TO A POINT ONE HUNDRED (100) FEET EAST OF THE EAST LINE EXTENDED ON MAPLE AVENUE; IN MAPLE AVENUE, FROM CHERRY STREET TO A POINT TWENTY-FIVE (25) FEET NORTH OF THE NORTH LINE EXTENDED OF ASH STREET; IN MAPLE AVENUE, FROM CHERRY STREET TO OAK STREET; IN OAK STREET, FROM MAPLE AVENUE TO THE EAST LINE EXTENDED OF THE CHICAGO AND NORTHWESTERN RAILWAY COMPANY'S RIGHT-OF-WAY; IN FAIRVIEW AVENUE, FROM CHERRY STREET TO ASH STREET; IN ASH STREET, FROM FAIRVIEW AVENUE NORTH OF ASH STREET TO A POINT FIFTY (50) FEET EAST OF THE EAST LINE EXTENDED OF POPLAR STREET; IN POPLAR STREET, FROM CHERRY STREET TO A POINT ONE HUNDRED EIGHTY-SEVEN (187) FEET SOUTH OF THE SOUTH LINE EXTENDED OF ASH STREET; IN ASH STREET, FROM POPLAR STREET TO A POINT FIFTY (50) FEET EAST OF THE EAST LINE EXTENDED OF WALNUT STREET; IN ASH STREET, FROM WALNUT STREET TO A POINT TWENTY-THREE (23) FEET WEST OF THE EAST LINE EXTENDED OF MAPLE AVENUE; IN CEDAR STREET, FROM ASH STREET TO A POINT TWENTY-FIVE (25) FEET NORTH OF THE NORTH LINE EXTENDED OF WILLOW STREET; IN FOREST STREET, FROM WILLOW STREET TO A POINT TWO HUNDRED TWENTY-ONE (221) FEET SOUTH OF THE SOUTH LINE EXTENDED OF DILLER STREET; IN RIDGE AVENUE, FROM WILLOW STREET TO A POINT ONE HUNDRED SEVENTY-SEVEN (177) FEET NORTH OF THE NORTH LINE EXTENDED OF CHERRY STREET; IN RIDGE AVENUE, FROM WILLOW STREET TO A POINT ONE HUNDRED THIRTY-TWO (132) FEET SOUTH OF THE SOUTH LINE EXTENDED OF MT. THE EAST LINE EXTENDED OF LINDEN STREET; IN CHERRY STREET, FROM LINDEN STREET TO A POINT TWENTY-FIVE (25) FEET WEST OF THE WEST LINE EXTENDED OF RIDGE AVENUE; IN CHERRY STREET, FROM CHESTNUT STREET TO A POINT TWENTY-FIVE (25) FEET WEST OF THE WEST LINE EXTENDED OF LINDEN STREET; IN OAK STREET, FROM CHESTNUT STREET TO A POINT TWO HUNDRED THIRTY-FIVE (235) FEET EAST OF THE EAST LINE EXTENDED OF CHESTNUT STREET; IN CHESTNUT STREET, FROM OAK STREET TO SPRUCE STREET; IN ELM STREET, FROM CHESTNUT STREET TO A POINT THREE HUNDRED FIFTEEN (315) FEET EAST OF THE EAST LINE EXTENDED OF CHESTNUT STREET; IN SPRUCE STREET, FROM CHESTNUT STREET TO A POINT SEVENTY-SEVEN (77) FEET EAST OF THE EAST LINE EXTENDED ON CHESTNUT STREET; IN ELM STREET, FROM BIRCH STREET TO A POINT TWENTY-FIVE (25) FEET WEST OF THE WEST LINE EXTENDED OF CHESTNUT STREET; IN SPRUCE STREET, FROM BIRCH STREET TO A POINT TWENTY-FIVE (25) FEET WEST OF THE WEST LINE EXTENDED OF CHESTNUT STREET; IN ELDER LANE AND ELDER LANE EXTENDED, FROM A POINT IN LAKE MICHIGAN FIVE HUNDRED NINETY-SIX (596) FEET EASTERLY FROM THE EASTERLY LINE OF SHERIDAN ROAD EXTENDED, TO WILSON STREET; IN WILSON STREET, FROM ELDER LANE TO A POINT TWENTY-FIVE (25) FEET NORTH OF THE NORTH LINE EXTENDED OF ELDER LANE; IN SHERIDAN ROAD, FROM ELDER LANE TO WINNETKA AVENUE; IN WINNETKA AVENUE, FROM SHERIDAN ROAD TO A POINT TWO HUNDRED TWENTY-FIVE (225) FEET EAST OF THE EAST LINE EXTENDED OF CHURCH ROAD; IN SHERIDAN ROAD, FROM ELDER LANE TO CHERRY STREET; IN WILLOW STREET, FROM SHERIDAN ROAD TO A POINT ONE HUNDRED EIGHTY-SEVEN (187) FEET WEST OF THE WEST LINE EXTENDED OF POPLAR STREET; IN FAIRVIEW AVENUE, FROM WILLOW STREET TO A POINT ONE HUNDRED SEVENTY (170) FEET NORTH OF THE NORTH LINE EXTENDED OF WILLOW STREET; IN HAWTHORNE LANE, FROM SHERIDAN ROAD TO A POINT TWENTY-THREE (23) FEET WEST OF THE EAST LINE EXTENDED OF WALNUT STREET; IN WOODLAND AVENUE, FROM HAWTHORNE LANE TO A POINT THREE HUNDRED SEVENTY-SEVEN (377) FEET NORTH OF THE NORTH LINE EXTENDED OF HAWTHORNE LANE; IN FAIRVIEW AVENUE, FROM HAWTHORNE LANE TO A POINT TWENTY-FIVE (25) FEET SOUTH OF THE SOUTH LINE EXTENDED OF THE ALLEY IN BLOCK THREE (3) OF DALE'S ADDITION TO THE VILLAGE OF WINNETKA; IN FIR STREET, FROM FAIRVIEW AVENUE TO A POINT TWO HUNDRED FORTY-SEVEN (247) FEET WEST OF THE WEST LINE EXTENDED OF WALNUT STREET; IN MYRTLE STREET, FROM ELDER LANE TO SUNSET ROAD; IN SUNSET ROAD, FROM MYRTLE STREET TO THE EAST LINE EXTENDED OF POPLAR STREET; IN SUNSET ROAD, FROM MYRTLE STREET TO A POINT TEN (10) FEET WEST OF THE WEST LINE OF LOT TWO (2) OF NICHOLAS SIMONS AND OTHERS' SUBDIVISION; IN ESSEX ROAD, FROM ELDER LANE TO WARWICK AVENUE; IN WARWICK AVENUE, FROM ESSEX ROAD TO A POINT TWO HUNDRED TEN (210) FEET SOUTH OF THE SOUTH LINE EXTENDED OF WINNETKA AVENUE; IN WOODLAND AVENUE, FROM ELDER LANE TO A POINT FIFTY (50) FEET NORTH OF THE NORTH LINE EXTENDED OF WINNETKA AVENUE; IN THE PUBLIC PATHWAY IN TRIER CENTER NEIGHBORHOOD, FROM WOODLAND AVENUE TO THE EASTERLY END OF THE PRESENT STORM WATER SEWER IN HILL ROAD; IN HILL ROAD, FROM THE WEST END OF THE PRESENT STORM WATER SEWER IN HILL ROAD AT THE WEST LINE OF TRIER CENTER NEIGHBORHOOD, TO WILSON STREET; IN WILSON STREET, FROM HILL ROAD TO THE NORTH LINE EXTENDED OF WINNETKA AVENUE; IN MYRTLE STREET, FROM HILL ROAD TO A POINT ONE HUNDRED FIFTY-SEVEN (157) FEET NORTH OF THE NORTH LINE EXTENDED OF HILL ROAD.

The Council of the Village of Winnetka do ordain:

SECTION 1. That a local improvement be made within the Village of Winnetka, County of Cook and State of Illinois, the nature, character, locality, and description of which local improvement are as follows, to wit:

From and discharging into Lake Michigan at a point in the center line extended of Cherry Street Six Hundred Thirty-one (631) feet easterly from the easterly line extended of Sheridan Road, at an elevation of 6.3 feet below datum, a cast iron pipe sewer having an internal diameter of 20 inches shall be constructed westerly along said center line and said center line extended of Cherry Street to a point 531 feet easterly from the easterly line extended of Sheridan Road where the elevation of said sewer shall be 6.3 feet below datum. From and discharging into the aforesaid sewer at the last mentioned point at an elevation of 6.3 feet below datum the present 20-inch internal diameter cast iron sewer shall be lowered westerly

along said center line and said center line extended of Cherry Street to a point 401 feet easterly from the easterly line extended of Sheridan Road, where the elevation of said sewer shall be 6.3 feet below datum, thence westerly the said present 20-inch internal diameter cast iron sewer shall be lowered along said center line and said center line extended of Cherry Street to and connecting with the present manhole 322 feet easterly from the easterly line extended of Sheridan Road, where the elevation of said sewer shall be and where the elevation of the bottom of said manhole now is 17.2 feet above datum; thence the present 26-inch by 39-inch egg shaped brick sewer extends westerly along said center line and center line extended of Cherry Street to a manhole to be located 10 feet westerly from the easterly line extended of Sheridan Road, where the elevation of said sewer is 19.2 feet above datum; from and discharging into the last mentioned manhole at an elevation of 19.2 feet above datum a brick sewer of cylindrical shape having an internal diameter of 36 inches and made with a double ring of sewer brick laid edgewise shall be constructed southwesterly to a manhole 23 feet north of the south line extended of Cherry Street and 22 feet easterly from the westerly line extended of Sheridan Road, where the elevation of said sewer shall be 23.8 feet above datum; thence west along a line 23 feet north of and parallel to the south line and said south line extended of Cherry Street to a manhole 23 feet west of the east line extended of Fairview Avenue, where the elevation of said sewer shall be 24.6 feet above datum; thence west along said line 262 feet to a manhole where the elevation of said sewer shall be 24.89 feet above datum; thence west along said line to a manhole 23 feet west of the east line extended of Poplar Street where the grade of said sewer shall be 25.2 feet above datum. From and discharging into the last mentioned manhole at an elevation of 25.5 feet above datum, a brick sewer of cylindrical shape having an internal diameter of 33 inches and made with a double ring of sewer brick laid edgewise shall be constructed west in Cherry Street along a line 23 feet north of and parallel to the south line and said south line extended of Cherry Street 222 feet to a manhole, where the elevation of said sewer shall be 25.87 feet above datum; thence west along said line to a drop manhole 27 feet west of the east line extended of Walnut Street, where the elevation of said sewer shall be 26.2 feet above datum; from and discharging into the last mentioned drop manhole at an elevation of 26.34 feet above datum, a brick sewer of cylindrical shape having an internal diameter of 30 inches made with a double ring of sewer brick laid edgewise shall be constructed south in Walnut Street along a line 27 feet west of and parallel to the east line and said east line extended of said Walnut Street, 220 feet to a manhole where the elevation of said sewer shall be 27.66 feet above datum; thence south along said line to a manhole 23 feet north of the south line extended of Ash Street where the elevation of said sewer shall be 29.0 feet above datum; thence south along said line 220 feet to a manhole where the elevation of said sewer shall be 29.53 feet above datum; thence south along said line to a manhole 23 feet north of the south line extended of Willow Street where the elevation of said sewer shall be 30.0 feet above datum; from and discharging into the last mentioned manhole at an elevation of 30.0 feet above datum, a tile pipe sewer having an internal diameter of 24 inches shall be constructed west in Willow Street along a line 23 feet north of and parallel to the south line and said south line extended of Willow Street 215 feet to a manhole where the elevation of said sewer shall be 31.25 feet above datum; thence west along said line to a manhole 17 feet west of the east line extended of Cedar Street where the elevation of said sewer shall be 33.35 feet above datum; thence west along said line 360 feet to a manhole where the elevation of said sewer shall be 38.0 feet above datum; from and discharging into the last mentioned manhole at an elevation of 39.0 feet above datum, a tile pipe sewer having an internal diameter of 24 inches shall be constructed west along said line to a drop manhole 17 feet west of the east line extended of Forest Street, where the elevation of said sewer shall be 47.87 feet above datum; thence west along said line to a drop manhole 23 feet west of the east line extended of Ridge Avenue where the elevation of said sewer shall be 49.48 feet above datum; thence west along said line 220 feet to a manhole where the elevation of said sewer shall be 50.14 feet above datum; thence west along said line to a manhole 23 feet west of the east line extended of Linden Street, where the elevation of said sewer shall be 50.8 feet above datum; from and discharging into the last mentioned manhole at an elevation of 51.2 feet above datum, a tile pipe sewer having an internal diameter of 24 inches shall be constructed northwesterly on a curve of 20 feet radius convex southwesterly, to a point 23 feet east of the west line extended of Linden Street and 23 feet south of the north line extended of Willow Street; thence north in Linden Street along a line 23 feet east of and parallel to the west line and said west line extended of Linden Street 187 feet to a manhole, where the elevation of said sewer shall be 51.61 feet above datum; thence north along said line to a manhole 15 feet north of the south line extended of Ash Street, where the elevation of said sewer shall be 52.02 feet above datum; thence west in Ash Street along a line 15 feet north of and parallel to the south line and said south line extended of Ash Street 206 feet to a manhole, where the elevation of said sewer shall be 52.76 feet above datum; thence west along said line to a manhole 15 feet west of the east line extended of Chestnut Street where the elevation of said sewer shall be 53.5 feet

above datum; from and discharging into the last mentioned manhole at an elevation of 53.55 feet above datum, a tile pipe sewer having an internal diameter of 22 inches which shall be constructed north in Chestnut Street along a line 15 feet west of and parallel to the east line and said east line extended of Chestnut Street 204 feet to a manhole where the elevation of said sewer shall be 53.83 feet above datum; thence north along said line to a manhole 17 feet north of the south line extended of Cherry Street where the elevation of said sewer shall be 54.12 feet above datum; thence north along said line 220 feet to a manhole where the elevation of said sewer shall be 54.46 feet above datum; thence north along said line to a manhole 17 feet north of the south line extended of Oak Street where the elevation of said sewer shall be 54.8 feet above datum; from and discharging into the last mentioned manhole at an elevation of 55.75 feet above datum, a tile pipe sewer having an internal diameter of 20 inches shall be constructed west in Oak Street along a line 17 feet north of and parallel to the south line and said south line extended of Oak Street, 222 feet to a manhole where the elevation of said sewer shall be 56.56 feet above datum; thence west along said line to a manhole 17 feet west of the east line extended of Birch Street where the elevation of said sewer shall be 57.4 feet above datum; from and discharging into the last mentioned manhole at an elevation of 57.46 feet above datum, a tile pipe sewer having an internal diameter of 20 inches shall be constructed north in Birch Street along a line 17 feet west of and parallel to the east line and said east line extended of Birch Street, 223 feet to a manhole where the elevation of said sewer shall be 57.98 feet above datum; thence north along said line to a manhole 23 feet north of the south line extended of Elm Street where the elevation of said sewer shall be 58.5 feet above datum; from and discharging into the last mentioned manhole at an elevation of 58.5 feet above datum, a tile pipe sewer having an internal diameter of 18 inches shall be constructed north in Birch Street along said line 217 feet to a manhole where the elevation of said sewer shall be 59.12 feet above datum; thence north along said line to a manhole 17 feet north of the south line extended of Spruce Street; where the elevation of said sewer shall be 59.7 feet above datum; thence north along said line 220 feet to a manhole where the elevation of said sewer shall be 60.1 feet above datum; thence north along said line to a manhole 17 feet north of the south line extended of Pine Street, where the elevation of said sewer shall be 60.4 feet above datum; from and discharging into the last mentioned manhole at an elevation of 60.4 feet above datum, a tile pipe sewer having an internal diameter of 15 inches shall be constructed east in Pine Street along a line 17 feet north of and parallel to the south line and said south line extended of Pine Street, 200 feet to a manhole where the elevation of said sewer shall be 61.7 feet above datum; thence northeasterly to a manhole on the north line of Pine Street extended and 10 feet east of the west line of Railroad Avenue extended where the elevation of said sewer shall be 62.1 feet above datum; thence northerly in Railroad Avenue along a line 10 feet easterly from and parallel to the westerly line of Railroad Avenue 380 feet to a manhole where the elevation of said sewer shall be 65.02 feet above datum; from and discharging into the last mentioned manhole at an elevation of 65.02 feet above datum a tile pipe sewer having an internal diameter of 12 inches shall be constructed northerly along said line 380 feet to a manhole where the elevation of said sewer shall be 67.95 feet above datum; thence northerly along said line to a manhole the northerly edge of which said manhole shall be on the northerly line extended of Lot 46 of County Clerk's Division of the Southeast one-quarter of Section 17, Township 42 North, Range 13 East of the Third Principal Meridian, Cook County, Illinois, where the elevation of said sewer shall be 71.03 feet above datum; from and discharging into a manhole 22 feet east of the west line extended of Sheridan Road and 23 feet north of the south line extended of Cherry Street at an elevation of 23.8 feet above datum, a tile pipe sewer having an internal diameter of 24 inches shall be constructed northerly in Sheridan Road along a line 22 feet easterly from and parallel to the westerly line and said westerly line extended of Sheridan Road, 285 feet to a manhole where the elevation of said sewer shall be 24.40 feet above datum; thence northerly along said line to a manhole 23 feet north of the south line extended of Oak Street where the elevation of said sewer shall be 25.0 feet above datum; from and discharging into the last mentioned manhole at an elevation of 25.9 feet above datum a tile pipe sewer having an internal diameter of 20 inches shall be constructed northerly along said line 320 feet to a manhole where the elevation of said sewer shall be 25.9 feet above datum; thence northerly along said line to a manhole 30 feet north of the south line of Elm Street extended from the west where the elevation of said sewer shall be 27.0 feet above datum; from and discharging into the last mentioned manhole at an elevation of 27.0 feet above datum a tile pipe sewer having an internal diameter of 12 inches shall be constructed northerly along said line to a manhole the northerly edge of which said manhole shall be 235 feet northerly from the northerly line of Elm Street extended from the east, where the elevation of said sewer shall be 28.0 feet above datum; from and discharging into a manhole 22 feet easterly from the westerly line extended of Sheridan Road and 23 feet north of the south line extended of Oak Street at an elevation of 25.3 feet above datum, a tile pipe sewer having an internal diameter of 15 inches shall be constructed west in Oak Street along a
