NEW MEXICO GETS FUNDS TO IMPROVE ROADWAYS

Under the terms of a comprehensive road law enacted by the recent session of the state Legislature, New Mexico has established a new highway commission, which has already adopted a highway plan calling for the construction of 3,540 miles of inter-county highway. The Legislature has assented to the federal aid road act and has provided ample funds to meet the federal appropriations, which amount to over \$1,000,000 to June 30, 1921.

ECONOMY CLASSES ARE HELD FOR HOUSEWIVES

Executive Committee Plans Meat Demonstration at Central School.

The regular weekly meeting of the Woman's corps of the Wilmette Home Guard was held on Tuesday, July 10. Reports of the various committees were read and they were accepted by the members of the unit.

Mrs. R. J. Mulvey, chairman of the distribution committee, reported that the demand from workers for materials was greater than the local supply, which shows the interest taken by Wilmette Women in this work. Flannelette has been bought and will be distributed for the making of convalescent robes of the latest design, the patterns having been furnished by the Navy League.

Mrs. R. E. Ward, chairman of the Navy League committee, reported on the work finished and delivered to the Chicago headquarters by the Wilmette branch. Five wash cloths, eight surgical sponges, one pair of wristlets, one helmet, two sweaters, five scarfs, three pairs of pajamas and twenty-two hospital shirts were shipped this week.

Mrs. W. D. Lawrence, chairman of the home economics committee, reported on the lectures and chalk talks given to the economy classes this week at the Central school. Another meat demonstration will be given for this division in the near future.

FUNERAL SERVICE HELD FOR WILLIAM WIGHTMAN

Former Wilmette Man Dies Suddenly in St. Paul, Minn.

Funeral services were held this afternoon for William Wightman at the home of Mrs. Wightman's mother, Mrs. Katherine Schwall, 1416 Wilmette avenue. Interment was at Niles Center.

Mr. Wightman died on July 9 in St. Paul, Minn., where he went to undergo treatment for gallstones. Mr. Wightman was 37 years old. He was born in Evanston and was a graduate of the Evanston High school.

While attending high school he won an enviable reputation as an athlete. During the indoor baseball season his services were in great demand by all local nines as a pitcher. He is survived by the widow and a baby daughter.

"Charge and Send."

A movement tending towards economy and expenditure of labor is the encouragement of customers to serve as their own delivery equipment, particularly in the matter of small purchases. It is charged against woman shoppers, particularly, that they order "charged and sent" such articles as yeast cakes, tooth brushes, thread. A motion picture campaign has been set in operation and that popular form of amusement turned to the business of popular education to develop individual responsibility for reducing the expense of operation for business houses.

The only way to the conscience of the shopper in the way of reduction of delivery demands is to make a difference in cost of the article carried and that sent.

MOTOR PARTY FINDS BODY NEAR GLENCOE

People in Motorboat Discover Body of Woman in Lake Off Glencoe, Sunday Afternoon.

MYSTERY SOLVED WHEN HOSTESS READS PAPER

Identified as Mrs. R. L. Brightwell of Kansas City, Mo., By Friend.

The big death puzzle which confronted Glencoe and Evanston authorities with the finding of a woman's body in the lake, off Glencoe, Sunday, was solved by Mrs. Ted McCarty, 3917 Pine Grove avenue, Chicago.

The body was identified as that of Mrs. R. L. Brightwell of Kansas City, Mo. She was visiting Mrs. McCarty in Chicago and on several occasions, while despondent, she made threats of taking her life. Descriptions of the woman found were published in the Chicago newspapers and, after reading these, Mrs. McCarty hurried to Evanston to identify the body.

R. L. Brightwell, her husband, and Mrs. E. M. Smith of Coshocton, O., her mother, were notified and they arrived in Evanston on Wednesday to claim the body. Mr. Brightwell was unable to give any reasons for his wife taking her life and he said detectives had been working to locate her for some time.

The body was cremated at Grace-land cemetery on Thursday morning and the ashes were shipped to Coshocton, O.

The discovery of the body was made by a party aboard a motorboat passing Glencoe a half mile from shore. The Glencoe police notified Capt. Olaf Egelund, in command of the United States life saving station, and he, with his crew, went out and brought the body back.

The body was taken to Schaeffer's morgue in Evanston, where it was identified by Mrs. McCarty.
