AN ORDINANCE

PROVIDING FOR THE ISSUANCE OF FILTRATION PLANT BONDS TO THE AMOUNT OF NINETY THOUSAND DOLLARS (\$90,000,00) AND PROVIDING FOR THE PAYMENT THEREOF.

The Council of the Village of Winnetka do ordain: SECTION 1. That for the purpose of acquiring the necessary site and erecting thereon suitable buildings and appurtenances to be used as a Filtration Plant, by the Village of Winnetka, in the distribution of the water supply of said Village, there are hereby authorized to be issued Filtration Plant bonds to the amount of Ninety Thousand Dollars (\$90,000.00), consisting of finety (90) bonds of One Thousand Dollars (\$1,000.00) each, to be dated July 1. 1919, each bearing interest, evidenced by coupons, at the rate of five per centum (5%) per annum, payable semi-annually. Two Thousand Dollars (\$2,000.00) in amount of said bonds shall become due on the first day of July in each of the years 1920 to 1924 inclusive, Four Thousand Dollars (\$4,000.00) in amount of said bonds shall become due on the first day of July in each of the years 1925 to 1929 inclusive, Six Thousand Dollars (\$6,000.00) in amount of said bonds shall become due on the first day of July in each of the years 1930 to 1934 inclusive and Six Thousand Dollars (\$6,000.00) in amount of said bonds shall become due on the first day of July in each of the years 1935 to

Both principal and interest of this bond are hereby made payable in gold coin of the United States of the present standard of weight and fineness at the office of the Village Treasurer in the Village of Winnetka, Cook County, Illinois.


