### No Bail

If the example of Judge John F. Boyer of Evanston were to be more generally followed there would be a decrease in the number of cases of arrests of intoxicated automobile drivers, and not because of laxity on the part of the police. As has been abundantly evidenced to north shore and Chicago recently the payment of a fine or money as recompense to the family of the victim of an intoxicated man at the wheel of an automobile is a punishment far from being fitted to the crime. Money to those who have plenty of it is a small consideration. Physical comfort is, on the other hand, a matter of very great importance. A period in jail is much more likely to exercise a salutary influence over the careless driver than a fine of however great proportions.

We can never hope for a noticeable amelioration of the conditions that prevail in the public streets until there is a different disposition on the part of the courts and a different standard of individual responsibility developed through the insistence of public opinion upon the offender against the public safety being required to pay for the damage that he causes in some other coin than that which passes through the pocket. Other communities have tried other methods and found them effective. It is about time that Chicago and the environs should awaken to the need for a change of policy.

### The Forest Preserve

Possession of the Skokie valley by the public is assured in the decision upon its purchase as a part of the forest preserve, an assurance that is pleasing to the people of the environs of Chicago who have seen the possibilities of getting out into the open growing fewer and fewer.

We have been in danger of permitting the industrial spirit of the great cities to rob the public of those privileges of fresh air, sunshine and

the opportunity to get near to nature to an alarming degree. We have allowed the commercialism of the centers of population to control the lives of the people who compose them, all in the interest of increasing that commercial prosperity at whatever expense. We have begun to see the error of our ways and are setting about by various means to redeem some of the benefits that we have surrendered. The institution of the forest preserve with its open spots in the country for the free enjoyment of those who spend the greater part of their days in the crowded manufacturing plants or the yet more crowded homes of the congested districts of the city, is a step towards the introduction into the lives of the people of the city of the healing influences of the open road and the open sky.
