## REALTORS PLANNING FOR NATIONAL MEET

North Shore Real Estate Board Expected to Name Representative to Attend National Session at Denver

### RECEIVE ANNOUNCEMENT

National Secretary Outlines Character of Sessions; All Boards are Interested

Though no action has been taken by the North Shore Real Estate Board in the matter of sending a delegate to attend the meeting of the Executive Committee of the National Association of Real Estate Boards, it is expected the north shore realtors will ponder the advisability of such action at the board session next week.

The sessions of the national executive committee are to be held in Denver, September 21, 22 and 23. The executive committee is made up of representatives of the various real estate boards in the cities of the country. It is possible the North Shore board will vote to have a representative at the important gathering.
