**SKOKIE TRACT CERTAIN TO BE FOREST PRESERVE**

**Cook County Forest Preserve Commissioners Pass Effective Ordinance; Residents Help.**

North shore residents are perhaps the most keenly interested in the action of the Cook County Forest Preserve Commissioners this week in passing an ordinance authorizing purchase of the Skokie to be added to the County Forest Preserve. The ordinance also institutes condemnation proceedings to acquire property where price agreements cannot be reached. The tract extends throughout the entire north shore lying immediately west of the villages. It begins with the Avoca Road and extends north to the county line. Its western line is the embankment of the Wisconsin division of the Northwestern railroad.

The action of the commissioners is expected to effectively block a re-

ported movement by property owners in the tract to have the land drained and cut up for commercial and residence purposes.

Several north shore leaders were directly instrumental in influencing the action of the commissioners.

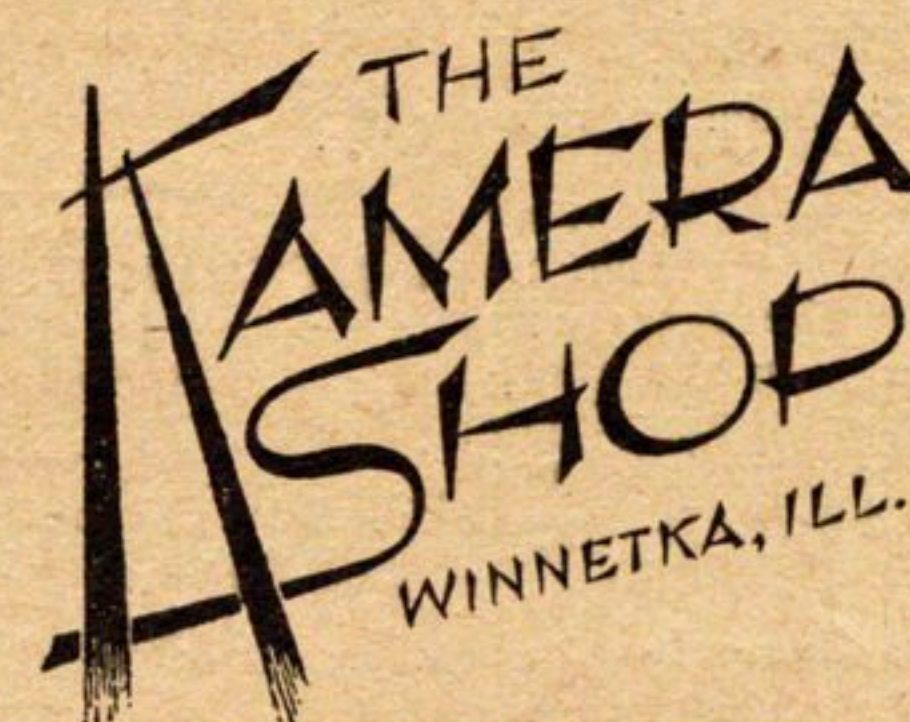

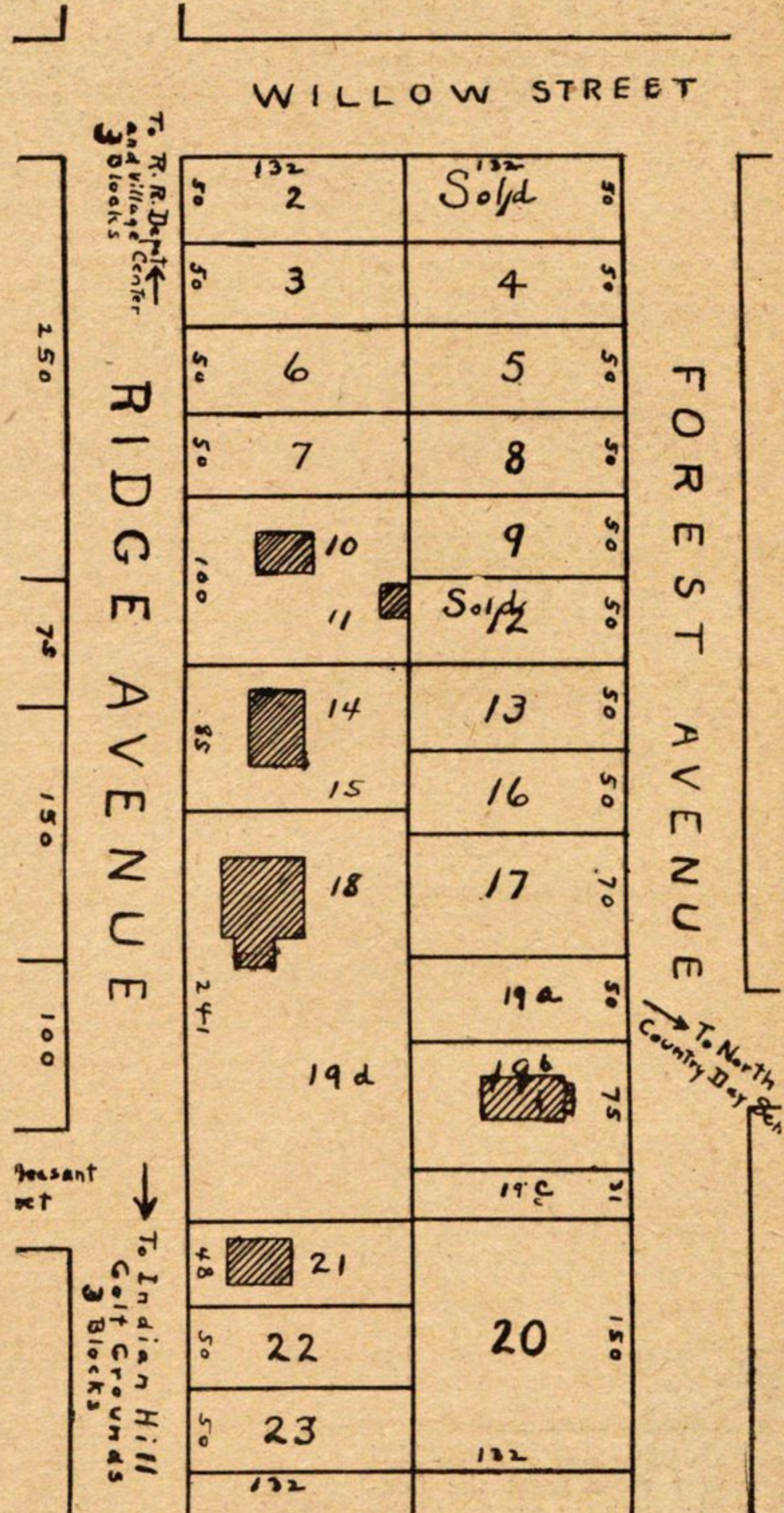
