

## WANT COUNTRY TOWNS TO NAME SCHOOL HEAD

Representative Castle Points Out the Reasons Many Voters Desire Change in Selection of County Superintendent

That Cook County's Superintendent of Schools should be elected by the voters in the county outside the City of Chicago is the belief of many residents in the suburban communities in this vicinity. Howard P. Castle, representative from the Seventh District in the House of Representatives in the Illinois General Assembly broached the subject in the following communication:

"I believe there is a pretty general feeling that since the county superintendent of schools of Cook county has little, if anything, to do with the Chicago schools, his time and that of his assistants being entirely taken with the supervision of the schools outside of Chicago, that he should be elected by the votes only of the people outside of Chicago. As you know, it is practically impossible and always will be unless the law is changed to elect anyone county superintendent of schools, except some man from Chicago.

"Section 5 of Article VIII of the constitution is as follows:

"There may be a county superintendent of schools in each county, whose qualifications, powers, duties, compensation and time and manner of election and term of office shall be prescribed by law."

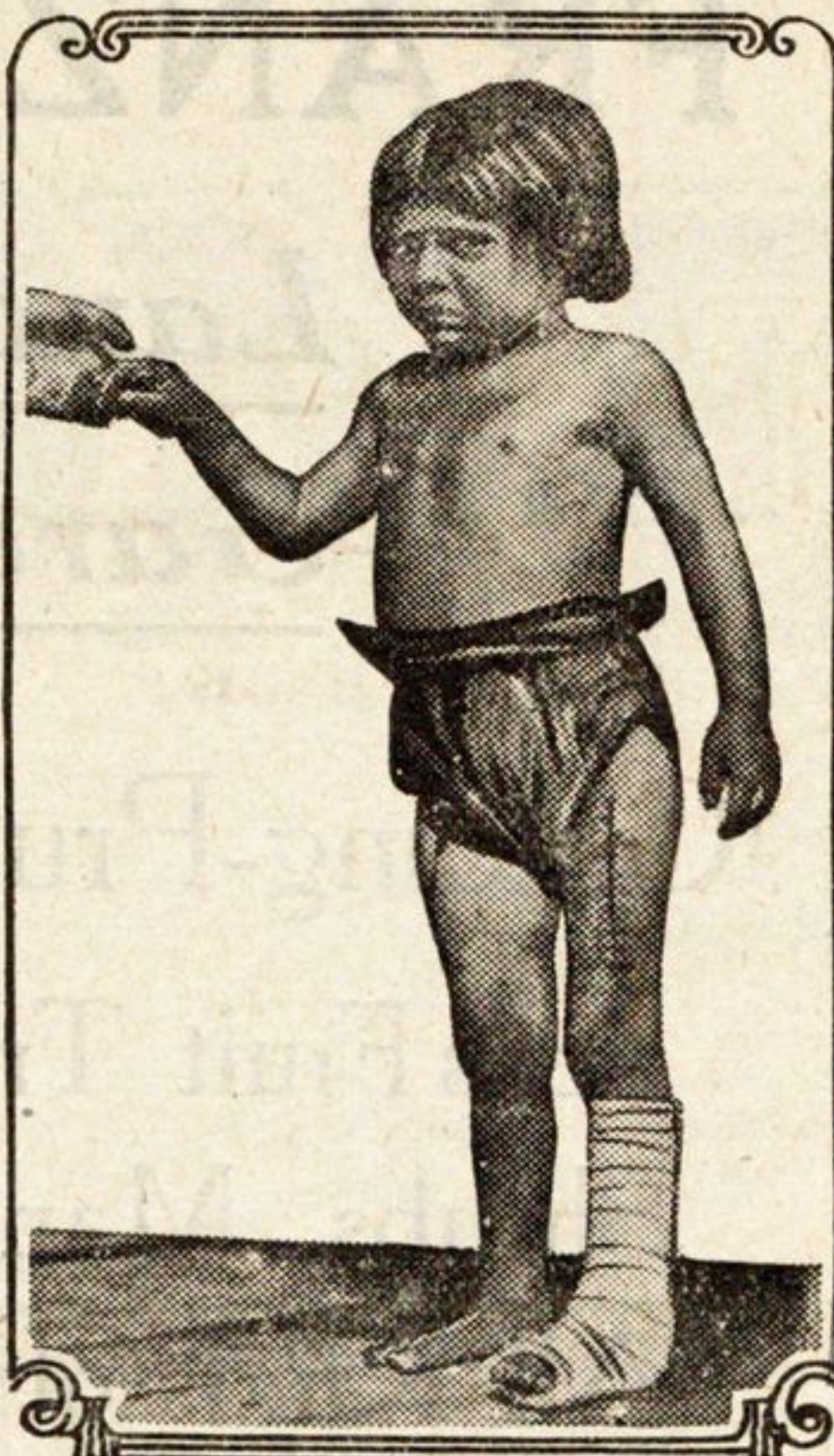
"In view of this provision, I believe it to be constitutional therefore for the legislature to provide by law that in a county like Cook containing a city of 100,000 or more population, the superintendent shall be elected by the legal voters outside of such city, this being one of his legal qualifications.

"The bill will undoubtedly meet with vigorous opposition on the part of many Chicago members of the General Assembly and will have no hope of passage unless the people of the country towns get unitedly behind it and it shall receive the support of down state members."

The California department of the American Legion has received copies of a resolution adopted by the Central Labor Council, San Bernardino, Cal., recommending adequate appropriations for the bureaus caring for disabled veterans, appropriations to build and maintain necessary hospitals and passage of the Rogers-Capper bill to consolidate the government bureaus dealing with the affairs of ex-service men, as indorsed by the Legion.

## RICKETS DID THIS.



Before this five-year-old Vienna girl was operated upon in the American Convalescent Home her leg was even more horribly deformed from rickets and she was in constant instead of intermittent pain. Now at least her leg is straight again, and by degrees she is relearning to walk. Rickets is the aftermath of under-nutrition, and it is to cut down the harrowing prevalence of such disease as this among the children of Europe that eight American relief organizations are making a joint appeal under the name of the European Relief Council for funds to succor the millions that face a winter of horror. They are the American Relief Administration, the American Red Cross, the American Friends' Service Committee (Quakers), the Jewish Joint Distribution committee, the Federal Council of Churches of Christ in America, the Knights of Columbus, the Y. M. C. A. and the Y. W. C. A.

F. W. Galbraith, Jr., national commander of the American Legion, has ordered the Kansas department of that organization to make a thorough investigation of the recent outrage at Great Bend, Kan., in which two organizers of the Non-Partisan league were tarred and feathered. Although the mob of residents of that vicinity included a number of ex-service men, there was no organized support from Legion posts, according to press correspondents. Colonel Galbraith ordered all Legion posts to refrain from interference with the political activities of the Non-partisan League several months ago.

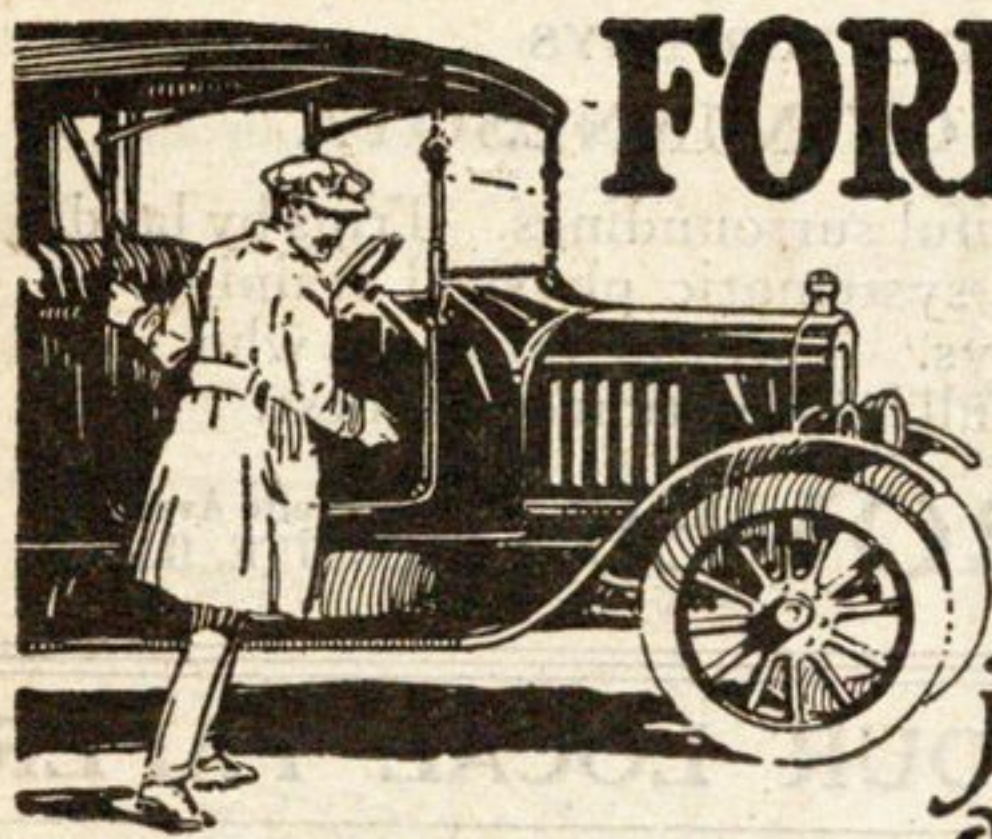

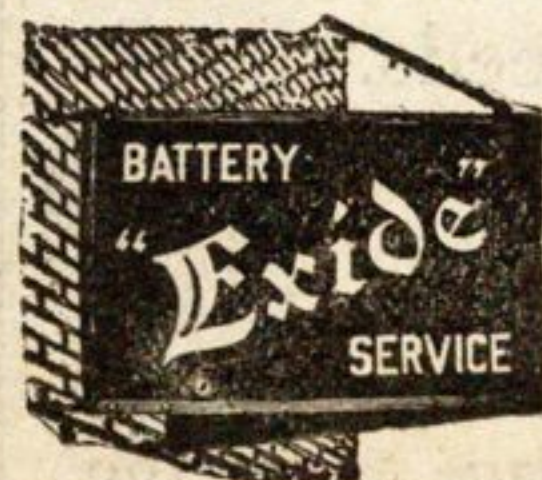
