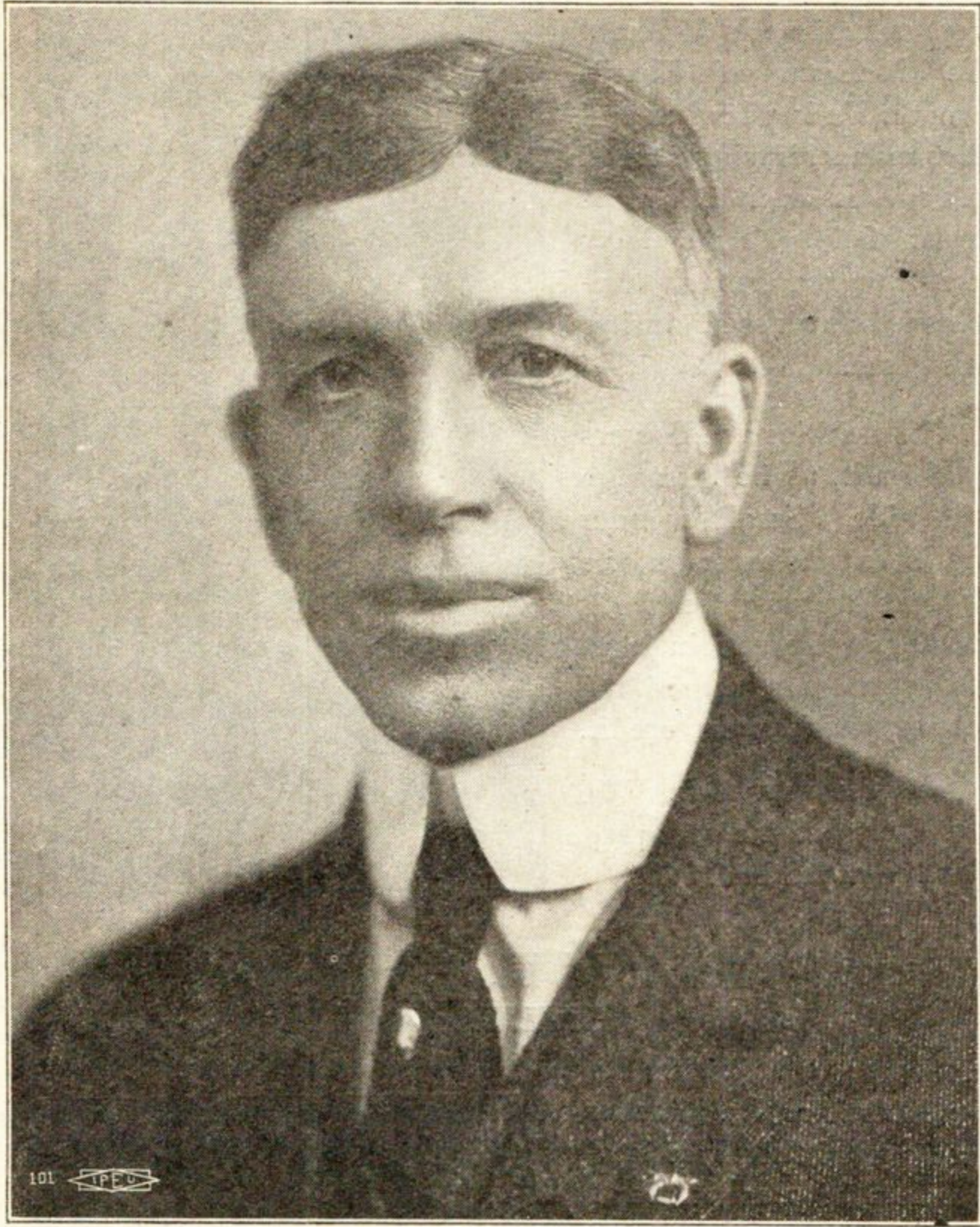


Seeks County Commissioner Post

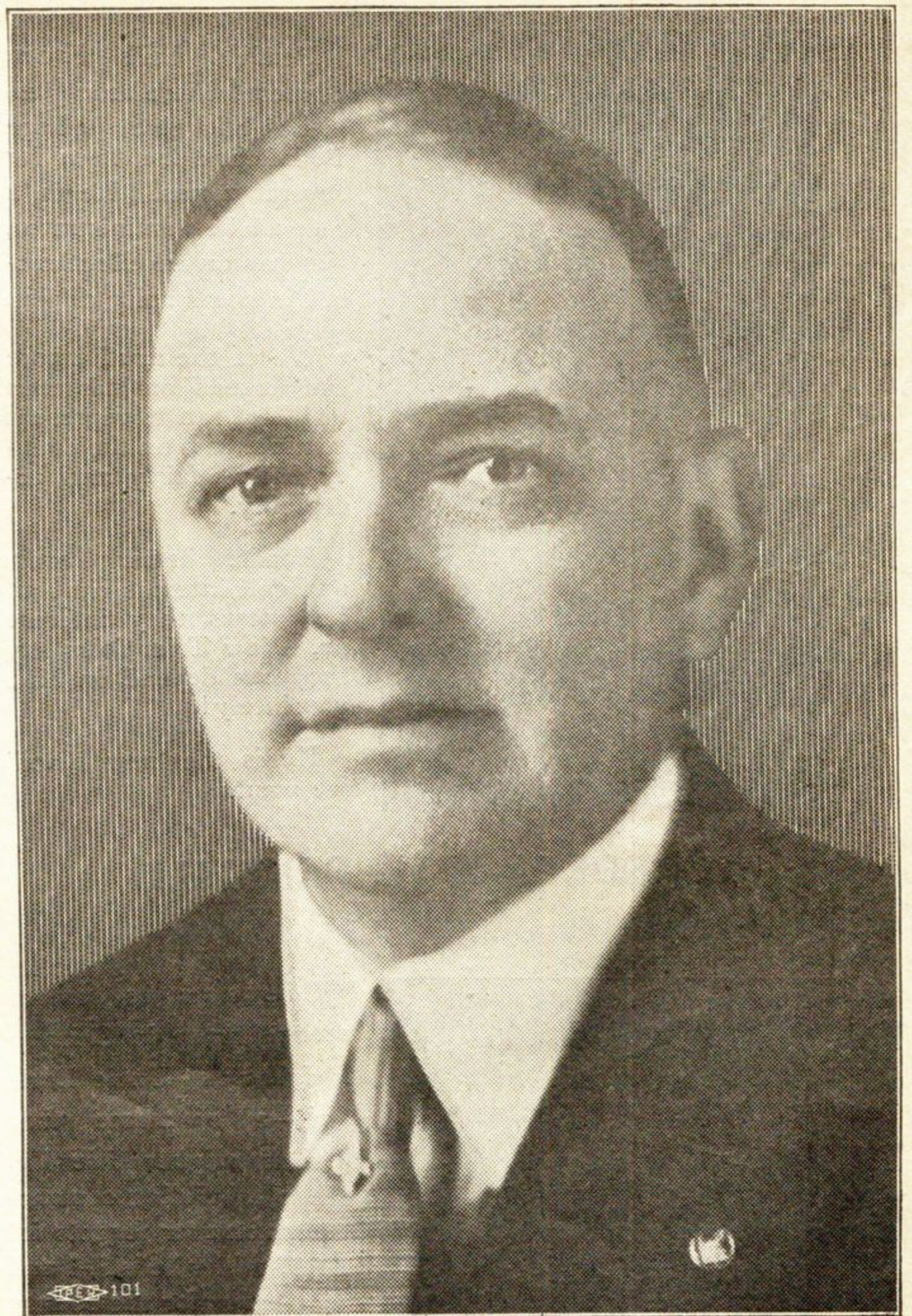
