We of the north shore can depend on this man and McLean to represent our interests on the county board, fairly and acceptably.


Roads, better roads, and golf interest him and he knows they interest us. New Trier folks say they can depend on him, absolutely!


DUDLEY D. PIERSON

WILLIAM BUSSE MOUNT PROSPECT


This man Busse lives out in Mount Prospect. He is a farmer, merchant and banker.
