growing village. After careful consideration of the structure of the present building and what is really involved in any remodeling, it was unanimously voted that there is no practical way to remodel the present plant. If one thinks just of the ground area, there seem to be ways to do it. When one begins to consider the wall and roof changes involved in any new floor plan, every such plan is seen so far to demolish walls and roof as to become uneconomical and unsatisfactory. There was longer discussion of this point than of any other, and the meeting was greatly indebted to the careful studies that some committees have been making of this question.

Seek Architect's Services

The church directed the trustees to enter into a contract with Mr. Charles Z. Klauder of Philadelphia as architect, with the hope of securing some preliminary sketches and plans during the coming year. The church also arranged for the appointment of committees to make studies of the problems of size, location, auxiliary rooms and finances. All these steps are preliminary. It was not, and could not be, determined how large the church will be, just where to place it, or what auxiliary rooms will be needed. It was not, and could not be, determined how it will be financed, or when active operations

will begin. These questions all remain for the church to study and answer. It is expected that the church will approach them all in the same open-minded way and with the same sense of responsibility to the community that were manifest at the meeting."
