Anchorage Churches Find Wilmette Co-operative Method Effective

INQUIRIES FROM EAST

Three New Jersey Towns Seek Details

Wilmette's Co-operative Church Advertising, a permanent feature of The Lake Shore News for the past two and one-half years, is the basis of similar advertising enterprises now in vogue or early prospect in numerous communities in the United States.

Renewed interest was lent the new plan of church publicity in word this week from Rev. Lansdowne, Episcopal clergyman of Anchorage, Alaska, to the effect that the three church organizations in that arctic community -Episcopal, Presbyterian and Catholic-had instituted the Wilmette Cooperative Church Advertising plan.

Plan Is Effective

Rev. Lansdowne read of the plan last July in the New York Churchman, a national church weekly. He soon after wrote the Rev. Hubert Carleton, rector of St. Augustine's Episcopal church of Wilmette requesting detailed information concerning the enterprise. Mr. Carleton responded by mailing several copies of The Lake Shore News containing Church Advertising and Announcements. The plan, Rev. Lansdowne reports, is working out effectively and is received with enthusiasm by the community.

Norwich, N. J. Interested

Requests for information concerning the Church Advertising Plan continue to be received by Wilmette ministers and the editor of The Lake Shore News as the result of nationwide publicity given the local enterprise through prominent religious magazines.

This week Rev. Carleton received a letter from the rector of an Episcopal clarch at Norwick, New Jersey, requesting business details of the Church Advertising Plan, including such questions as: "Who wrote the ads? What is the cost? How much space is taken, and for what period of time?" Rev. Carleton, an avowed enthusiast over the Church Advertising plan, immediately sent the inquiring rector six copies of The Lake Shore News, one for each of the ministers of the six churches in the New Jersey city.

The editor of The Lake Shore News this week received a letter from the Rev. Ross F. Wicks, pastor of the church of Newark, New Jersey, in which Mr. Wicks writes:

Another Pastor Inquires "I have read about your paper and the page given over to Church News and advertising. Would be glad and

thankful for sample copy." Another communication relating to Wilmette Church Advertising was received by the editor this week in response to a letter sent to Charles H. Nuttle, secretary of a newly appointed church Advertising committee at Morristown,, New Jersey.

In a previous letter addressed to the Rev. Francis Carr Stifler, pastor of the Wilmette Baptist church, Mr. Nuttle requested details of the plan and sample copies of The Lake Shore News These furnished by the editor, Mr. Nuttle replied in acknowledgement:

NEW BUSINESS BLOCK FOR LINCOLN AVENUE

Issuing eleven building permits in the past week, the Winnetka Village Department of Public Works began the new year with a rush. The eleven permits granted in the seven days represent buildings which have an estimated cost of \$113,000.

The largest single permit was issuer to McGuire and Orr, who have already started construction on a \$22, 500 business block at 576-78-80 Lincoln avenue. The new building will be one story in height and will be constructed of brick and stone. A permit for the construction of a \$16,000 two and onehalf story brick residence was granted to Zimmerman, Saxe and Zimmerman. The home will be located at 331 Sheridan road.

Two \$12,000 permits, authorizing the construction of two residences, were issued to Johnston Brothers. One house will be built at 859 Lincoln avenue and the other at 863 Lincoln avenue. Both will be brick veneer construction. A two-story frame and stucco dwelling will be erected at 315 Sunset road by H. W. Weld at an estimated cost of \$15,000.

Another \$12,000 permit was taken out by Mrs. M. Inbusch for the construction of a frame and stucco residence at 944 Euclid avenue. A. C. Perrin, 512 Hawthorne lane, received two permits authorizing the erection of a garage and a two-story frame dwelling. The combined cost of the two buildings comes to \$12,000. At 636 Walden road the village authorities consented to the erection of a two-story frame and shingle dwelling by Joseph M.
