

**Here Is the Bill**

68TH CONGRESS,  
1ST SESSION. **H. R. 672**

IN THE HOUSE OF REPRESENTATIVES.  
DECEMBER 5, 1923.

**A BILL**

Mr. CHINDBLOM introduced the following bill; which was referred to the Committee on Public Buildings and Grounds and ordered to be printed.

To authorize the acquisition of a site and the erection of a Federal building at Winnetka, Illinois.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*  
3 That the Secretary of the Treasury be, and he is hereby,  
4 authorized and directed to acquire, by purchase, condemna-  
5 tion, or otherwise, a suitable site in Winnetka, Illinois, and  
6 to cause to be erected thereon a suitable building, with fire-  
7 proof vaults, heating and ventilating apparatus, and ap-  
8 proaches, complete, for the accommodation of the post office,  
9 at a total limit of cost, including site, of \$150,000.

is one of the suburbs of Chicago which is doubling its population each decade. And

WHEREAS, the Village of Winnetka recently adopted a Zoning Ordinance restricting the erection of business buildings except in certain designated portions of the municipality, and has also approved a Village Plan, including provisions for the control and betterment of the central and more public parts of the village. And

WHEREAS, because of the adoption of the aforesaid Zoning Ordinance and said Village Plan there has been a great increase in the erection of business buildings in the village, and steps are being taken to do away with old and unsightly structures and to replace them with those

which will be both architecturally beautiful and at the same time well adapted for modern use. And

WHEREAS, a new Village Hall is to be erected soon on a site which has been especially prepared for this purpose, and a fine new Masonic Temple has been built near the center of business district, and a new school house has been built and another planned. And

WHEREAS, because of the above described building activities it will soon become difficult to secure a fit and proper site on which to erect a proper Post Office Building in the village.

THEREFORE BE IT RESOLVED, that copies of this resolution be sent to the Honorable William B. McKinley and the Honorable Medill McCormick, United States Senators from Illinois. Also to the Honorable Henry R. Rathbone, Congressman at Large for Illinois, and to the Honorable Carl R. Chindblom, Congressman for the Tenth Congressional District of Illinois, with the request to each and all

of the aforesaid gentlemen that they use every endeavor to secure the appropriation above described.

The above preamble and resolution passed and approved by a unanimous vote of the Winnetka Chamber of Commerce this Fifth day of December, 1923.
