

# Japanese Quake Refugee Makes Home in Wilmette

Shoji Osato, well-known artist-photographer, with his wife and two children, is now living on the lake shore near the border-line between Wilmette and Kenilworth. Mr. Osato has lived in the United States for twenty years, spending his time studying the art of portrait photography, of which he is now a master.

Last year he represented in Japan one of the biggest pictorial news services in the United States. He enjoyed the unusual honor of being the official photographer at important state functions, taking pictures of members of the royal family and other notables. He left Japan immediately after the earthquake, bringing to America many authentic and vivid photos of that terrible catastrophe.

He makes a specialty of photographing children and adults in their appropriate home surroundings. His photographs of Winnetka and Lake Forest children have the unusual merit of attractive naturalness and artistic sim-
