Your Insurance

THE INSURANCE NEEDS OF CONTRACTOR:

Compensation-Essential to every employer. The various compensation laws provide that an employer must pay an injured employe a certain portion, as provided under the law, of his regular wage if the employe is injured during employment, irrespective of how the injury may have occurred. Many states impose penalties for the failure of the employer to protect his employes as provided by the compensation law. This form is unlimited as to the amount of payment.

Employer's liability-This form of insurance (in those states which have not adopted a compensation law) provides for the protection of the employer against claims for liability imposed by law on account of bodily injuries or death accidentally suffered by any employe of the assured. The policy provides for medical, investigation and claim expense and the settlement o claims, together with the defense o suits, whether groundless or not. Lim its are \$5,000 for injury to one person and \$10,000 for one accident resulting in injury to more than one person. Higher limits are available at a small additional cost.

Explains Public Liability

Public liability-Provides indemnity against claims in connection with the operations of the assured on account of accidents to any person not employed by the assured. This form should be brought forcibly to the attention of the contractor. All employes of sub-contractors, city engineers, inspectors, salesmen representing concerns supplying light, power, machinery, building material, etc., children and trespassers are the public, and it should be explained to him that, so far as he is concerned, all persons not his employes constitute the public. Like employer's liability, public liability is written with limits of \$5,000 for injury to one person and \$10,000 for the house. 
