The Chamber of Commerce was represented by R. H. Schell, its president, and Frederick B. Thomas represented the North Shore Real Estate board. In connection with the license ordinance the Village office has made a survey of license fees in Berwyn, Oak Park, Lake Forest, Highland Park, Wilmette, Evanston and Chicago. The suggestions of those present at the public hearing will be taken into consideration when the license law is finally drawn up, it was said.

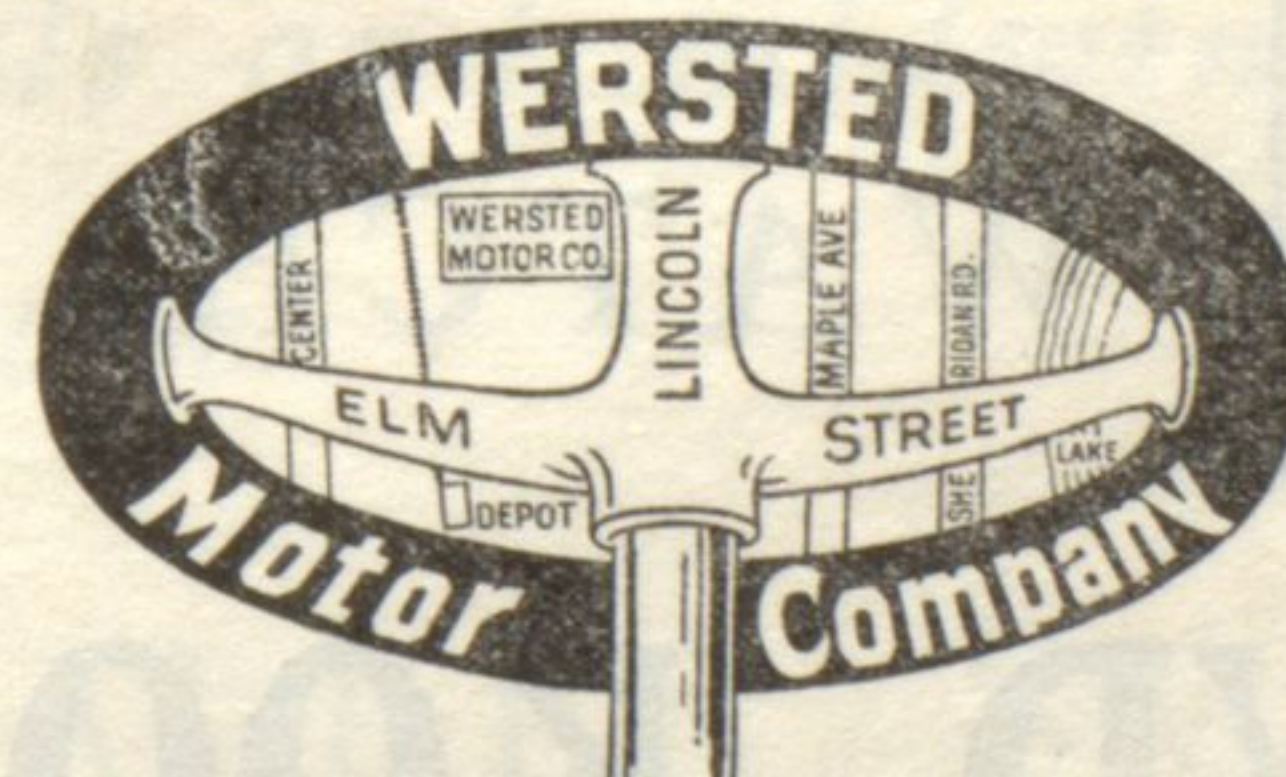
