

Income Tax Facts

(Provided by Mabel Reinecke, collector of Internal Revenue, Chicago.)

WHO? Single persons who had net income of \$1,50 or more or gross income of \$5,000 or more, and married couples who had net income of \$3,500 or more or gross income of \$5,000 or more must file returns.

WHEN? The filing period ends March 15, 1926.

WHERE? Collector of internal revenue for the district in which the person lives or has his principal place of business.

HOW? Instructions on Form 1040A and 1040; also law and regulations.

WHAT? One and one-half per cent normal tax on the first \$4,000 in excess of the personal exemptions mal tax on the next \$4,000. Five per cent normal tax on the balance of net income. Surtax on net income in excess of \$10,000.

School children of 1500 cities and towns in the United States will be asked to sign a pledge jointly with their parents to obey the "Ten Commandments of Safety" which are part of the intensive campaign to help cut down the tremendous automobile death toll of the nation, according to an announcement today by Marcus A. Dow, director of the Stewart-Warner Safety Council for the prevention of automobile accidents. The child's teacher also is to sign the pledge. Affixing the child's name on the pledge is accompanied by a serious talk on safety by the teacher. The parchment pledge is given to the child to keep as a permanent safety reminder,
