## EXPLAIN POLICIES

County Board Presidential and County Treasurer Candidates Answer Questions

Candidates for election at the County Primaries on April 13 have been sending in very full and comprehensive replies to the questionnaires sent out by the Winnetka League of Women Voters, as to their policies in viarious important matters. Their letters will be mimeographed in full and distributed to members of the league before the primaries. Anyone else desiring access to this first hand material about the candidates can obtain a copy by communicating with Mrs. Walter Benson, president of the league. Extracts from the letters from the candidates for President of the Cook County Board of Commissioners, and for County petent men of good character." Treasurer are printed below. Next week the replies from candidates for Sheriff, County Judge, and County Clerk will be printed.

William Busse Candidates for President, Cook County Board of Commissioners. William Busse, Mount Prospect, Cook County, Ill., Republican, Deneen faction. Occu pation: merchant and banker, president William Busse and Son (merchants), and chairman Board of Directors, Mt. Prospect State bank. Education: public schools of Cook county. Public offices: member and president County board; president Village of Mount Prospect; member school board, 12 years. Party offices, County central committee.

Platform: "It has always been my firm belief that the holder of a public office should give the same careful attention to his duties that he would to his private business.

"If I am nominated and elected, ! shall do my best to see that the af-

fairs of Cook county and the Forest Freserve district are managed in an efficient and economical manner and that the program for that purpose, heretofore installed, be maintained and further extended as experience warrants, to the end that taxation will be reduced wherever possible.

"I will also do all in my power to see that the dependants of the county have the best possible accommodations and care in accordance with the latest scientific and humane methods.

"I shall urge that all public improvements, including the good roads program, erection of a new criminal court building and county jail, and the full development of the Forest Preserves, etc., be completed as rapidly as possible.

to the duty to enforce the criminal laws rests with the executive officers of the various cities, villages and towns, and the sheriff and state's attorney of the county, will advocate the refusal of licenses to undesirable roadhouses in unorganized territory, over which the County Board has jurisdiction and the making of any necessary appropriation to law enforcing officers to wipe out and prevent crime, and also to adequately police the Forest Preserves and highways with com-

Position regarding road houses: "I certainly would approve the immediate revocation of the license of any road house found to be violating any law. Before granting or renewing any license, the moral character of each applicant should be established to the satisfaction of the whole board, after a thorough investigation as to the applicant's fitness has been made such as is contemplated by law. Because this procedure was not followed and the present licenses issued to the holders in a group, my associates upon the board, Messrs. Miller, Pierson and Penfield from the country towns and Goodnow from the city, and myself voted against the issuance of these licenses. After licenses are issued, I believe that a close watch should be kept by the law enforcing officers to see that each road house is obeying the law."



The carrying on of our program of popularizing the Forest Preserves by adding to their conveniences, seemliness, accessibility. Continuance of our fine highway building program. Continuance of efforts towards replacing any remaining inertia in the service with an energy as greatly vibrant as has been and is the essential spirit from the creative force of which has come the greatness of this metropolitan area embraced within the County of Cook."
