> At a former meeting, a few days ago, several thousand dollars were pledged by Kenilworth citizens towards this fund, but all such subscribers were released at the Monday evening meeting, when the other more equitable manner of raising the money was decided upon.

> Furthermore, it was explained by Mr. Bonnet, that, in the event the condemnation proceedings should reach a point wherein the court renders favorable decision for the villages, and the valuation of the tract in question is established, it will then be necessary for the two villages to raise the larger, or purchase sum, and it is then that the more liberal donations will be called for. That is, it was explained, is particularly true, in Kenilworth, whereas, should the proceedings result in the villages acquiring the tract for park purposes, it will in reality be a park under the jurisdiction of the Wilmette Park board and therefore paid for by Wilmette.
