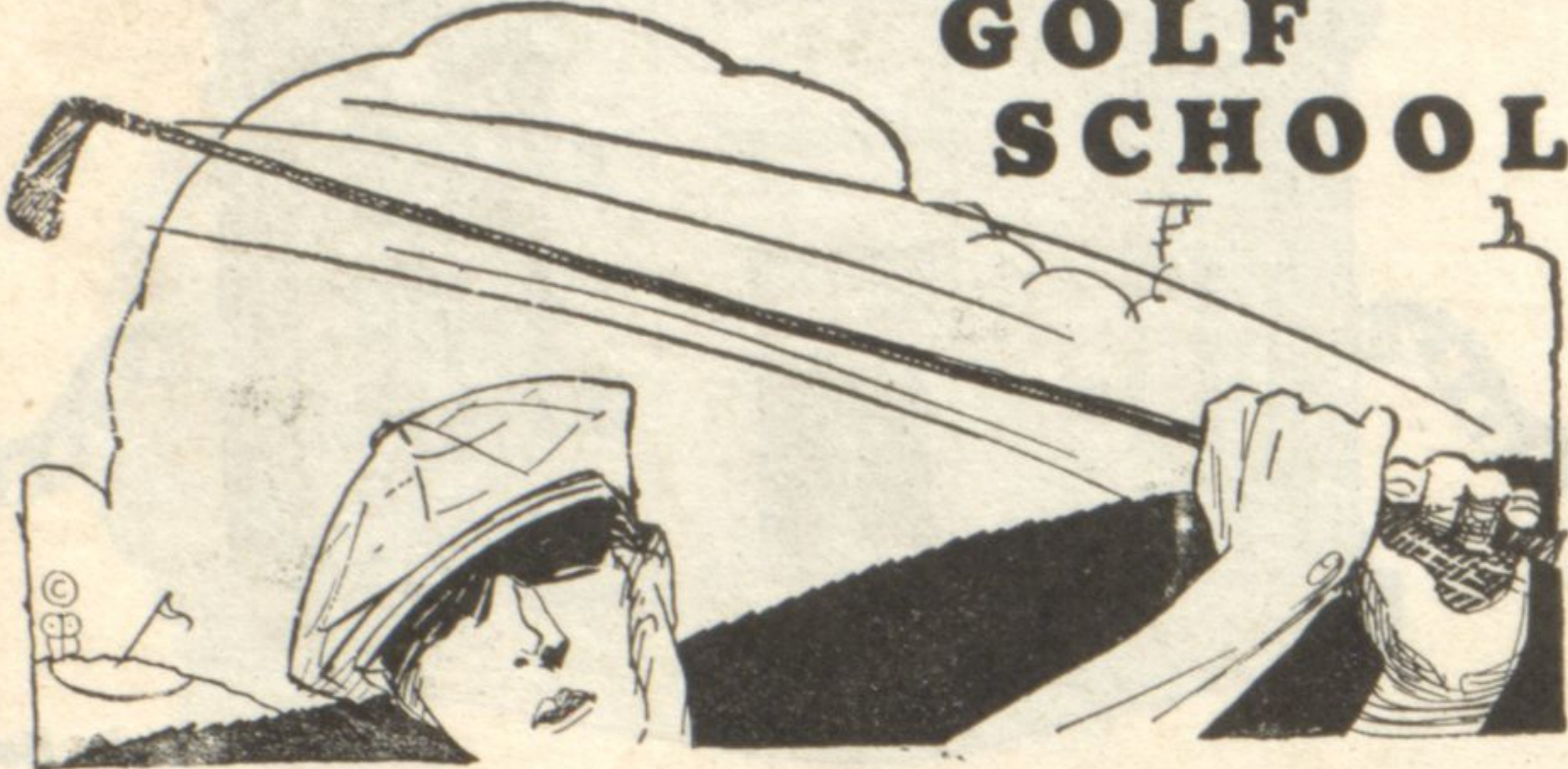

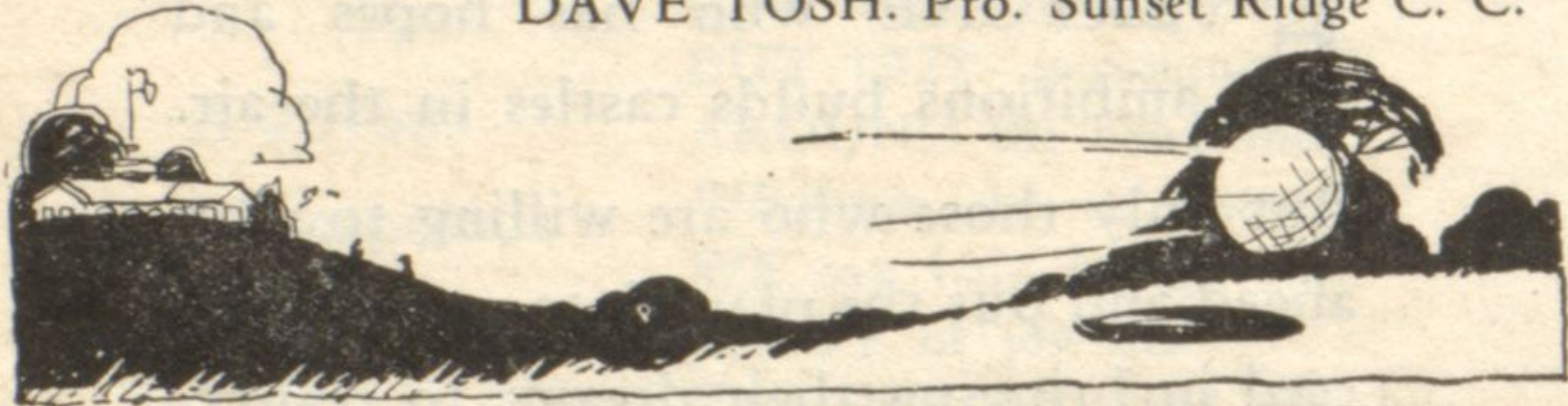

**Federal Grand Jury Gets Mary Curruti Booze Case**

Mrs. Mary Curruti, whose restaurant at 905 Linden avenue, Hubbard Woods, was raided by the Winnetka police a few weeks ago and a quantity of liquor seized, was bound over to the Federal grand jury, Wednesday afternoon, December 29, by the United States Commissioner, in Chicago. W. M. Peterson, chief of police and Officer Harry C. Enault, of Winnetka, who participated in the raid, were witnesses in the Wednesday proceeding in which the defendant was charged with illegally possessing intoxicating liquor.

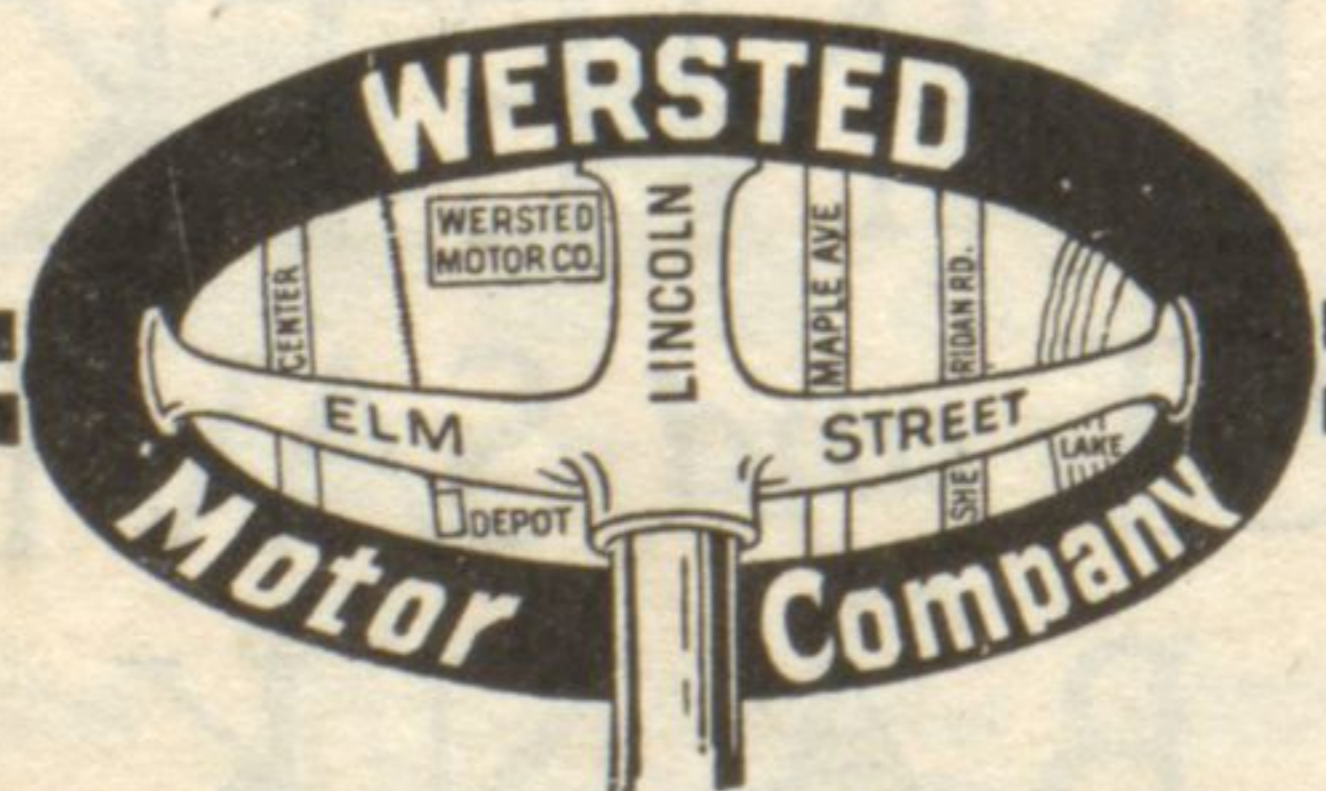
