**Winnetka Legion
Post Is Host to
State Commander**

Winnetka Post No. 10, American Legion, which is doing its share towards a membership goal of 70,000 in the state of Illinois, by September 1, has enrolled twelve new members since the beginning of the membership drive the first of this week, and on Thursday evening was honored by a visit from State Commander, Ferre C. Watkins.

The meeting was held at Matz hall, Community House, where there was a large attendance of the members and their friends. The meeting was called to order by Dr. Frank E. Blatchford, post commander, who, following invocation by Rev. Thomas A. Goodwin, turned the meeting over to special chairman, J. M. Dickinson, Jr.

William H. King, of Winnetka, was next introduced, and spoke of the civic work the Legion is doing in the communities throughout the state and particularly the rehabilitation work of veterans.

Mr. King was followed by State Commander Watkins, who spoke on "The Future of the Legion and What It Stands For." Prominent among these he said are proper preparedness and rational patriotism. He said the Legion no longer wishes anything from

the public at large, but now feels that its strength permits it to give something back to that public in the form of civic development.

For instance, he said that this year the Legion is establishing a memorial at state headquarters, at Bloomington, and the post in the state of Illinois performing the most meritorious work for its respective community, will be cited for that work by the placing of a bronze plaque in the memorial building.

He said the character of the civic work which the various posts are doing is rendering police protection in such communities where such protection does not exist; fostering and directing boy scout activities; conducting Americanization instruction for foreigners; performing their naturalization ceremonies; stressing American history instruction in the schools; patriotism and work of similar character.

The orphanage for children of war veterans, sponsored by the Legion, at Normal, he said is now taking care of over two hundred children.

The goal of 70,000 members set by the state of Illinois would make of Illinois the largest state department in the country, State Commander Watkins said.

Winnetka post, in addition to the twelve new members which it has enrolled this week, also reports that over seventy percent of its old members have already paid their dues for the coming year.

SPECIAL ASSESSMENT NOTICE**

NOTICE IS HEREBY GIVEN TO ALL PERSONS INTERESTED that the Village of Winnetka, Cook County, Illinois, having ordered that a supplemental special assessment be made to pay the estimated deficiency in the cost of the work and interest for the construction of a local improvement in the Village of Winnetka, County of Cook and State of Illinois, the ordinance for which said improvement provided as follows, to wit: For the improvement of Oak Street from and connecting with the present pavement at the west line extended of Glendale Avenue to a line parallel with and twenty-two (22) feet west of the east line extended of Hibbard Road; also Cherry Street from and connecting with the present pavement at the east line extended of Glendale Avenue to a line parallel with and twenty-two (22) feet west of the east line extended of Hibbard Road; also Ash Street from and connecting with the present pavement at a line parallel with and twenty-two (22) feet east of the west line extended of Rosewood Avenue to a line parallel with and twenty-two (22) feet west of the east line extended of Hibbard Road; also Glendale Avenue from and connecting with the present pavement at the south line extended of Oak Street to and connecting with the present pavement at a line parallel with and twenty-two (22) feet south of the north line extended of Willow Street, including the three alley returns on the east side of said Glendale Avenue as far back as the east line extended of Glendale Avenue, and excepting the pavement herein proposed at the intersections of said Glendale Avenue with Cherry Street and Ash Street; also Berkeley Avenue from and connecting with the pavement herein proposed at a line parallel with and twenty-two (22) feet north of the south line extended of Oak Street to and connecting with the present pavement at a line parallel with and twenty-two (22) feet south of the north line extended of Willow Street, excepting the pavement herein proposed at the intersections of said Berkeley Avenue with Cherry Street and Ash Street, by excavating, filling, grading, grubbing, rolling and preparing the sub-grade to receive the proposed pavement, constructing brick masonry manholes, catch basins, manhole catchbasins and a valve vault, constructing tile pipe drains, tile pipe culverts, Portland cement concrete tile pipe culverts and concrete headwalls for culverts, adjusting present manhole covers and valve vault covers, removing trees, grading the parkways, and paving with a one (1) course reinforced Portland cement concrete pavement with integral curbs, protecting, curing and cleaning said pavement, and connecting said proposed pavement with present pavements, including all trenching, backfilling, the removal of all surplus excavated materials, and cost of engineering services, all in the Village of Winnetka, County of Cook and State of Illinois, and which special assessment proceeding was known as General Number 392764 in the Superior Court of Cook County, Illinois, the ordinance for the same being on file in the office of the Village Clerk of said Village, and the said Village having applied to the Superior Court of Cook County, Illinois, for a supplemental special assessment to pay the estimated deficiency in the cost of the work and interest in said local improvement according to the benefits, and a supplemental special assessment therefor having been made and returned to said Court, General Number 451521, the final hearing thereon will be held on the twenty-eighth day of February, A. D. 1927, or as soon thereafter as the business of the said Court will permit. All persons desiring may file objections in said Court before said day, and may appear on the hearing and make their defense. Said ordinance provides for the collection of said supplemental special assessment in five (5) annual installments with interest thereon at the rate of five per centum (5%) per annum.

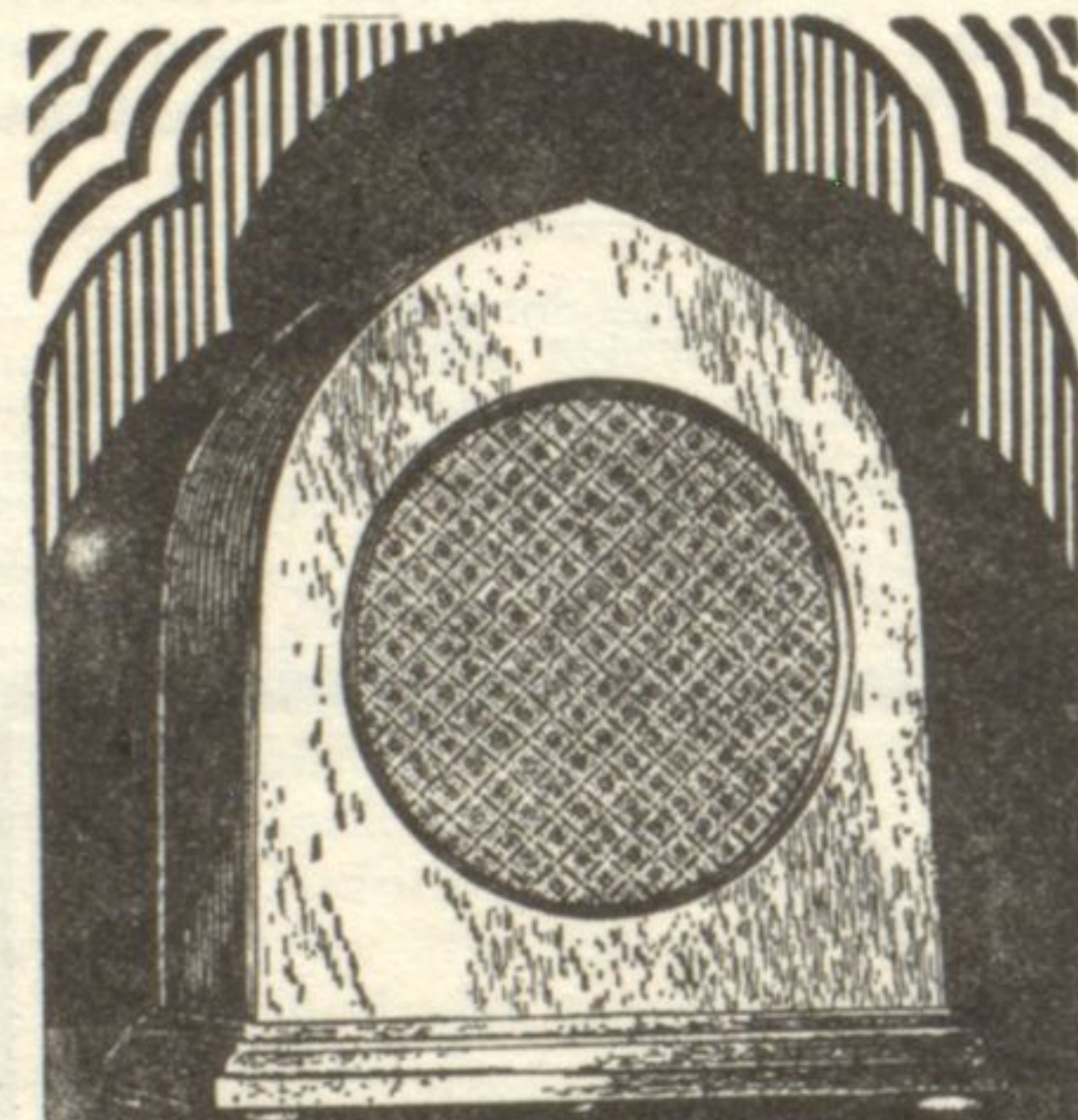
