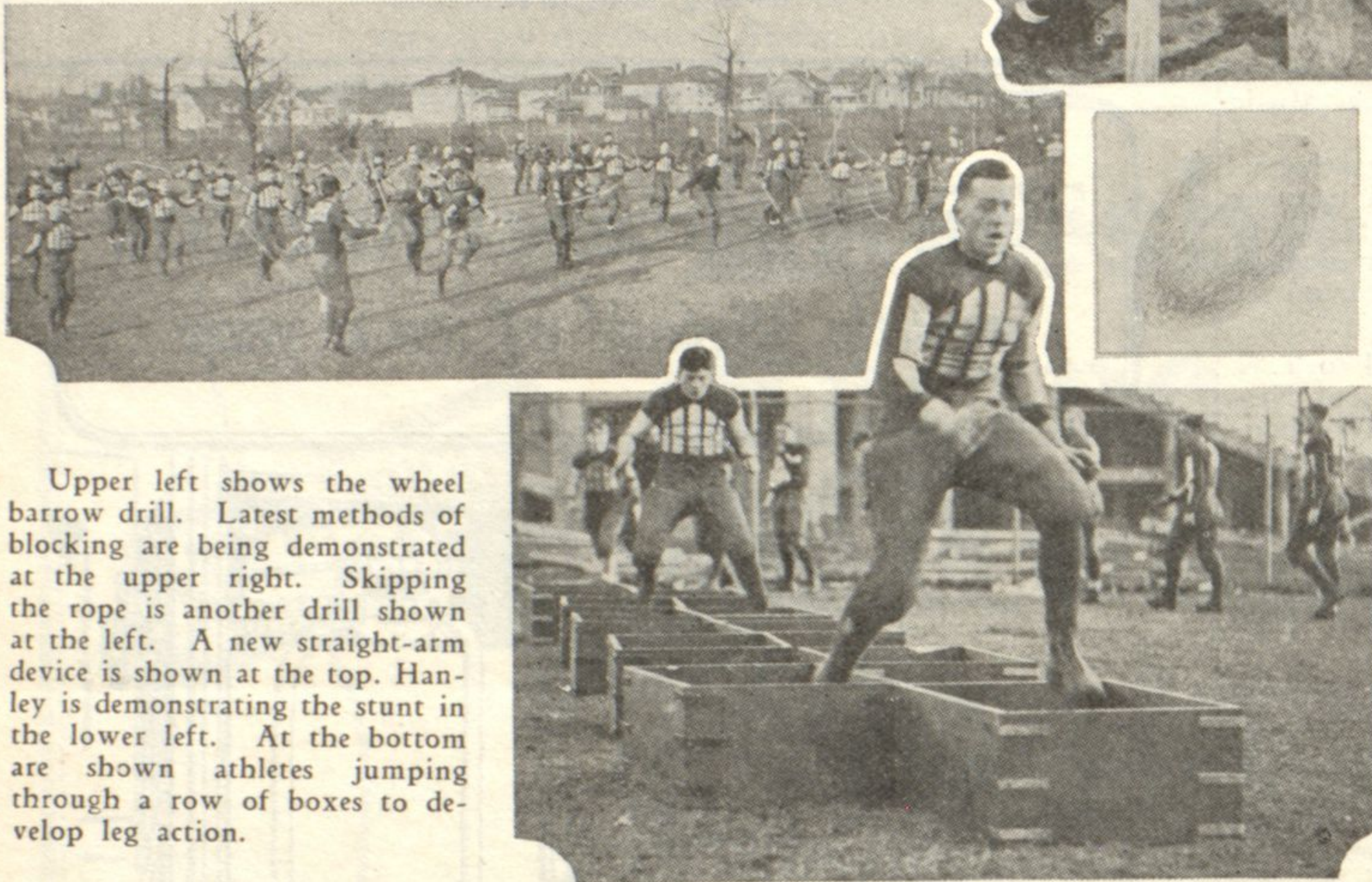
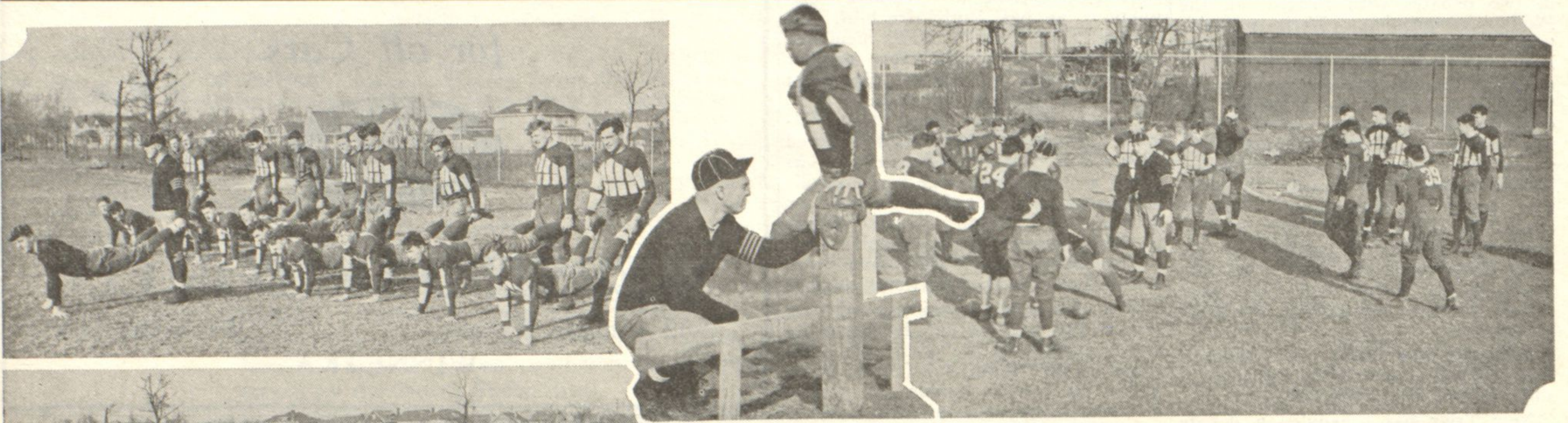
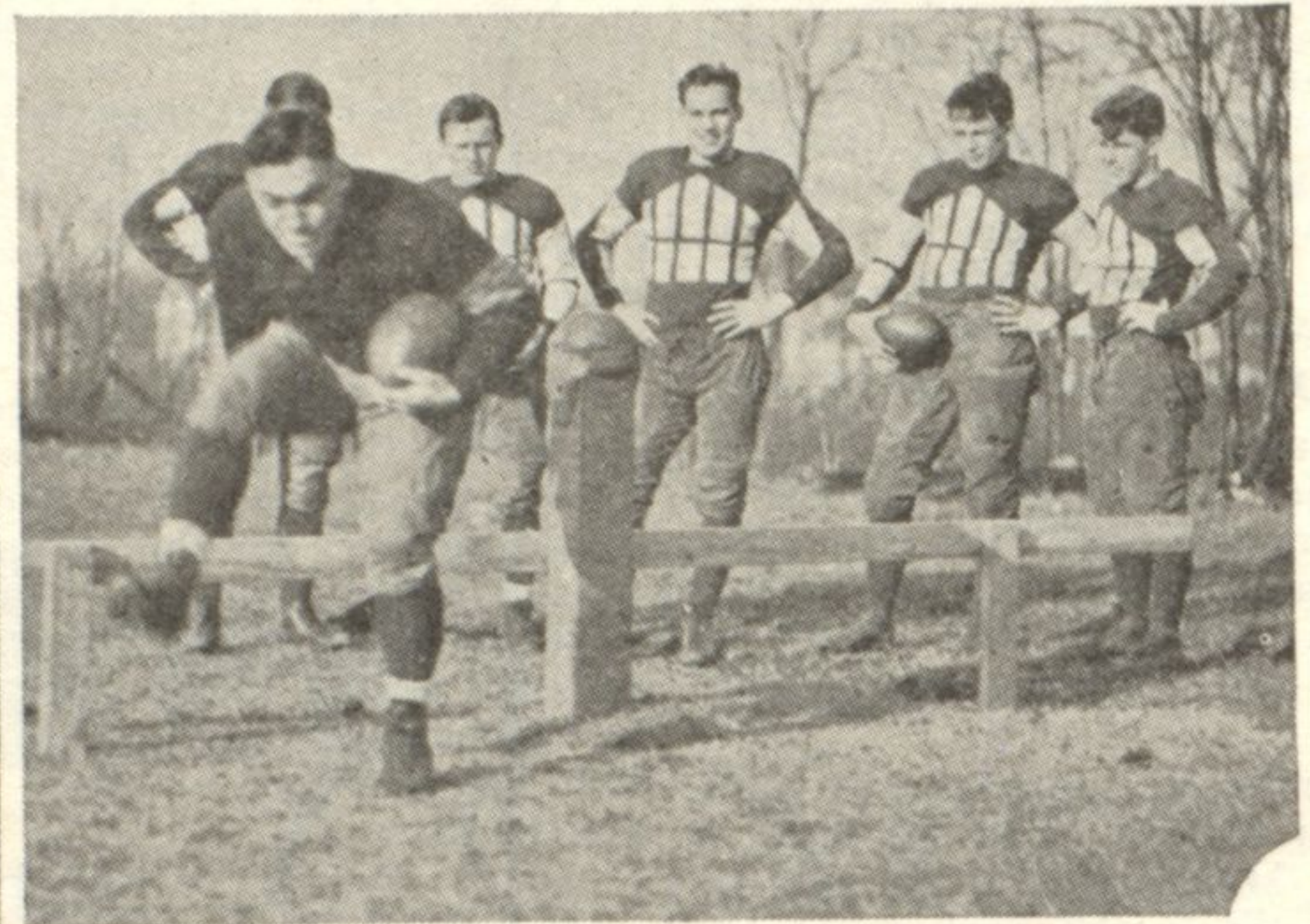


Hanley Introduces New Training Methods in Spring Grid Drill
