Charles Babcock, brother of Mrs. John Nevins of 345 Elder lane, returned Monday after spending three months in Florida with his father.

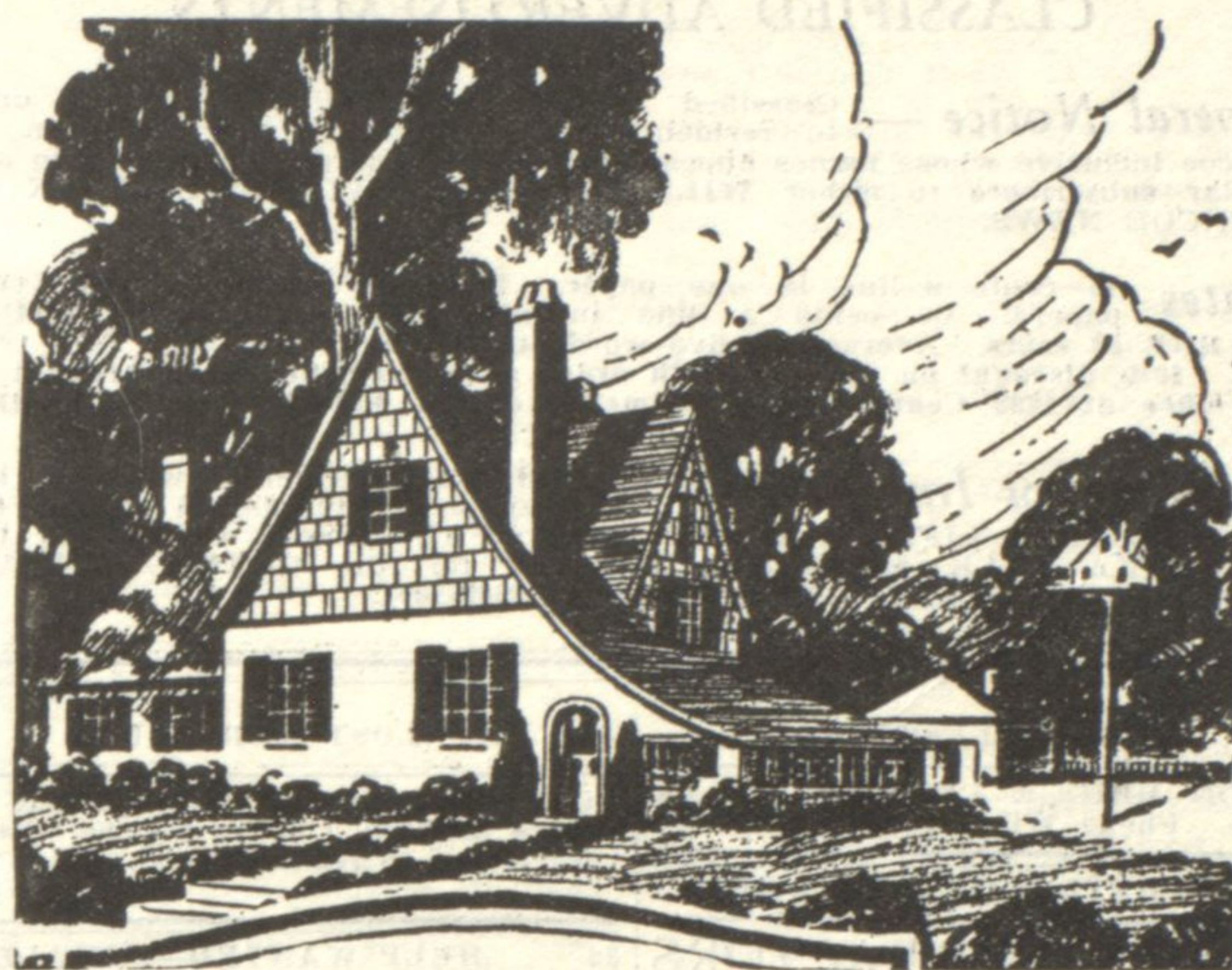
Mr. and Mrs. Horace Armstrong of 365 Sheridan road will entertain twenty guests at dinner at Glenview Golf club Tuesday evening.
