




public. The present code should be carefully studied, obsolete provisions eliminated, recent amendments incorporated and certain revisions made to meet present conditions, and the new code printed as provided in the budget submitted herewith. A revised building code and also an ordinance regulating the installation of oil storage tanks and oil burners have been prepared and are ready for consideration.

8. It is suggested that the Council give consideration and approval to a comprehensive financial program to be used for guidance during the next five years, in order that all questions involving the expenditure of public funds may be determined on a basis of their relationship to the ultimate financial condition of the Village government. It is believed that this program should be Mrs. Anna Lee Bacon Is based on the theory that ordinary municipal service should be limited to the revenue derived by the Village from general taxation and from other similar sources, properly applicable to corporate activities; and that any revenue derived from the operation of our municipal electric utility should only be allocated to particular public improvements which could not otherwise be secured, maintaining at all times adequate reserves for depreciation, working capital and capital outlays needed by the utilities for keeping their service at a high-grade level, at rates not substantially higher than in surrounding territory.

It is believed to be very essential that more attention be paid to the matter of publicity regarding Village affairs. The Village Manager has made an effort to furnish the local papers with information concerning the work of the Council and the service rendered by the several Village departments, through weekly conferences with representatives of the next Monday.

press. It is felt, however, that a more complete and satisfactory plan should be adopted, whereby the public would be informed of specific problems and of the accomplishments of the Village government, this information coming directly from elective officials or one or more interested citizens, appointed to handle this important function.

On behalf of the administrative organization of the Village, I wish to express appreciation for the encouraging support and kindly cooperation and advice of the President and Board of Trustees in the work of the past year. Especially, do I wish to express my high regard for the retiring President, Mr. John S. Miller, who for the past eight years has given most generously of his time and ability, in ways which possibly only those actively connected with Village work fully appreciate.

I wish to take this opportunity also of again acknowledging the able assistance and cooperation rendered in the administrative work of the Village by the heads of the several departments and by the ank and file of Village employees, without whose cooperation and faithful assistance, any measure of success in the work of the past year would not have been possible.


