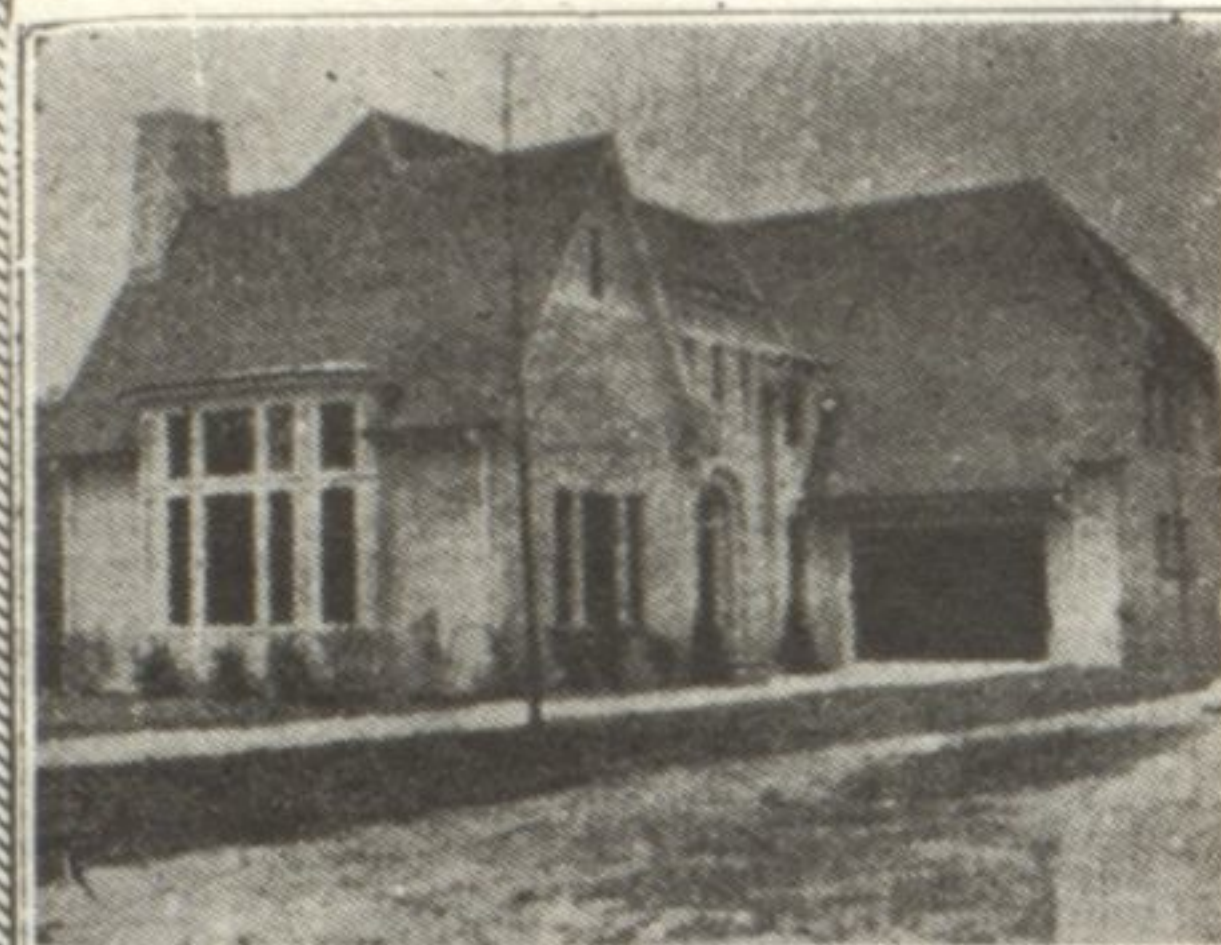

Special Assessment Notice

NOTICE IS HEREBY GIVEN to all persons interested that the Village of Winnetka, Cook County, Illinois, having ordered that a local improvement be made in Euclid Avenue, from the existing pavement at the north line extended of Scott Avenue, north to the north limits of the Village of Winnetka, by grading, curbing and paving with reinforced Portland cement, including excavation, removal of all surplus materials and cost of engineering services, all within the Village of Winnetka, County of Cook and State of Illinois, the ordinance for the same being on file in the office of the Village Clerk of said Village, and the said village having applied to the Superior Court of Cook County, Illinois, for an assessment of the cost of said improvement according to the benefits, and a special assessment therefor having been made and returned to said Court, General Number 461231, the final hearing thereon will be held on the twenty-ninth day of August, A. D. 1927, or as soon thereafter as the business of the said Court will permit. All persons desiring may file objections in said Court before said day, and may appear on the hearing and make their defense. Said ordinance provides for the collection of said assessment in six (6) annual installments, with interest thereon at the rate of five per centum (5%) per annum.
