NOTICE IS HEREBY GIVEN to all persons interested that the Village of Winnetka, Cook County, Illinois, having ordered that a local improvement be made in Edgewood Lane, from and connecting with the existing concrete pavement at the west line extended of Green-wood Avenue, to a line six (6) inches east of and parallel with the west line of Grove Street, by grubbing, clearing, excavating, filling, grading, rolling, leveling and hand raking parkways, constructing tile pipe drains, tile pipe culvert with end walls, inlets of tile pipe incased in concrete, with cast iron grates, ad-justing manholes and valve vault, fur-nishing new manhole covers, removing tree and concrete headwall, and paving with a one (1) course reinforced concrete pavement without curbs, including re-turms in Grove Street as far back as the north and south lines extended of Edge-wood Lane, all within the Village of Winnetka, County of Cook and State of Illinois, the ordinance for the same being on file in the office of the Village Clerk of said Village, and the said village having applied to the Superior Court of Cook County, Illinois, for an assessment of the cost of said improvement accord-ing to the benefits, and a special assess-ment therefor having been made and re-turned to said Court, General Number 461232, the final hearing thereon will be held on the twenty-ninth day of August, A. D. 1927, or as soon thereafter as the business of the said Court will permit. All persons desiring may file objections in said Court before said day, and may appear on the hearing and make their defense. Said ordinance provides for the collection of said assessment in ten (10) annual installments, with interest thereon at the rate of five per centum (5%) per annum.
