# GLENCOE BUILDING IN OCTOBER OVER \$80,000

### Monthly Records Throughout the Year Maintained with Even Greater Prospects

Another month's record of building activities has been proudly filed away in Glencoe's official archives, a duty which has come to be habitual with the officials of that village during the past year.

With an October total of twenty permits issued, representing an investment in both new and remodeling work of more than \$82,000, the record for October is equally gratifying with that of the prospect for the present month in which it is said the first of Glencoe's two new apartment and business blocks is to be started and which promises to swell the November total to perhaps new high records.

#### To Break Ground Soon

Ground is to be broken within the next two weeks, it is said, for the new \$125,000 apartment building to be erected on the north side of Hazel avenue, west of Vernon avenue, by Jevne Haugan and his associates, and as soon as the widening of Vernon avenue in this section is started, Frederick A. Cooper announces that he is ready to begin work on his new \$225,000 apartment building at the northeast corner of Hazel and Vernon avenues.

The proposed new theater building on the north side of Park avenue, east of Vernon, is awaiting only the drafting and passage of necessary ordinances pertaining thereto, it is said; the two new churches now underway by the Christian Scientists and the North Shore Congregation, Israel; the new school auditorium; the scores of new residences completed; the building of the \$500,000 muncipal water works plant, now underway, and the many large subdivisions, nearby, rapidly shaping into form for final development, all are reasons why Glencoe, as it approaches the close of the present prosperous year, is justly proud of her sustained October record.

### Four New Residences

During the month just past, permits were issued for four new residences, totalling \$61,000. There were eight permits for remodeling jobs costing \$16,815 and there were also eight permits for new garages, costing \$4,228. The monthly records also show that eight storage tanks for fuel oil were installed during the past thirty days.

Permits for the new residences were issued to Albert P. Kloepfer for a two story house with attached garage, constructed of frame and brick veneer, at 403 Jackson avenue, costing \$16,000.

To Charles A. Odegaard for a two story frame brick veneer residence at 260 Vernon avenue, costing \$15,000.

One to George W. Killner for a brick veneer residence at 212 Maple Hill road costing \$15,000, and one to Harry A. Herst for a two story house of tile and brick veneer at 527 Skokie road, costing \$15,000.

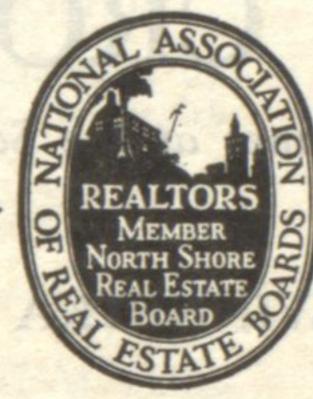

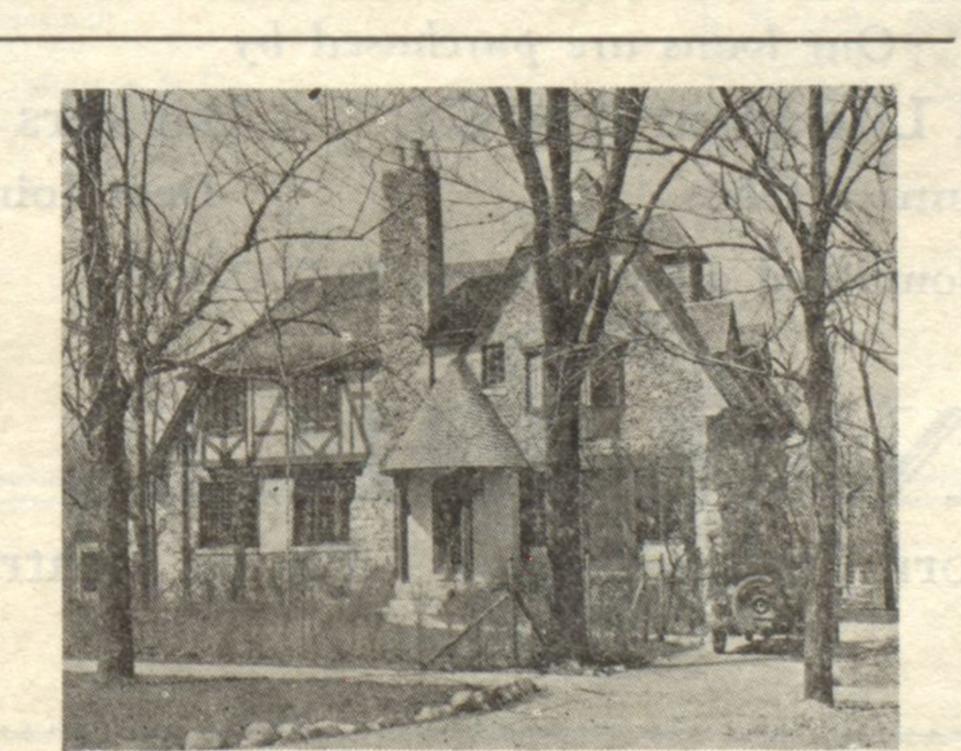
