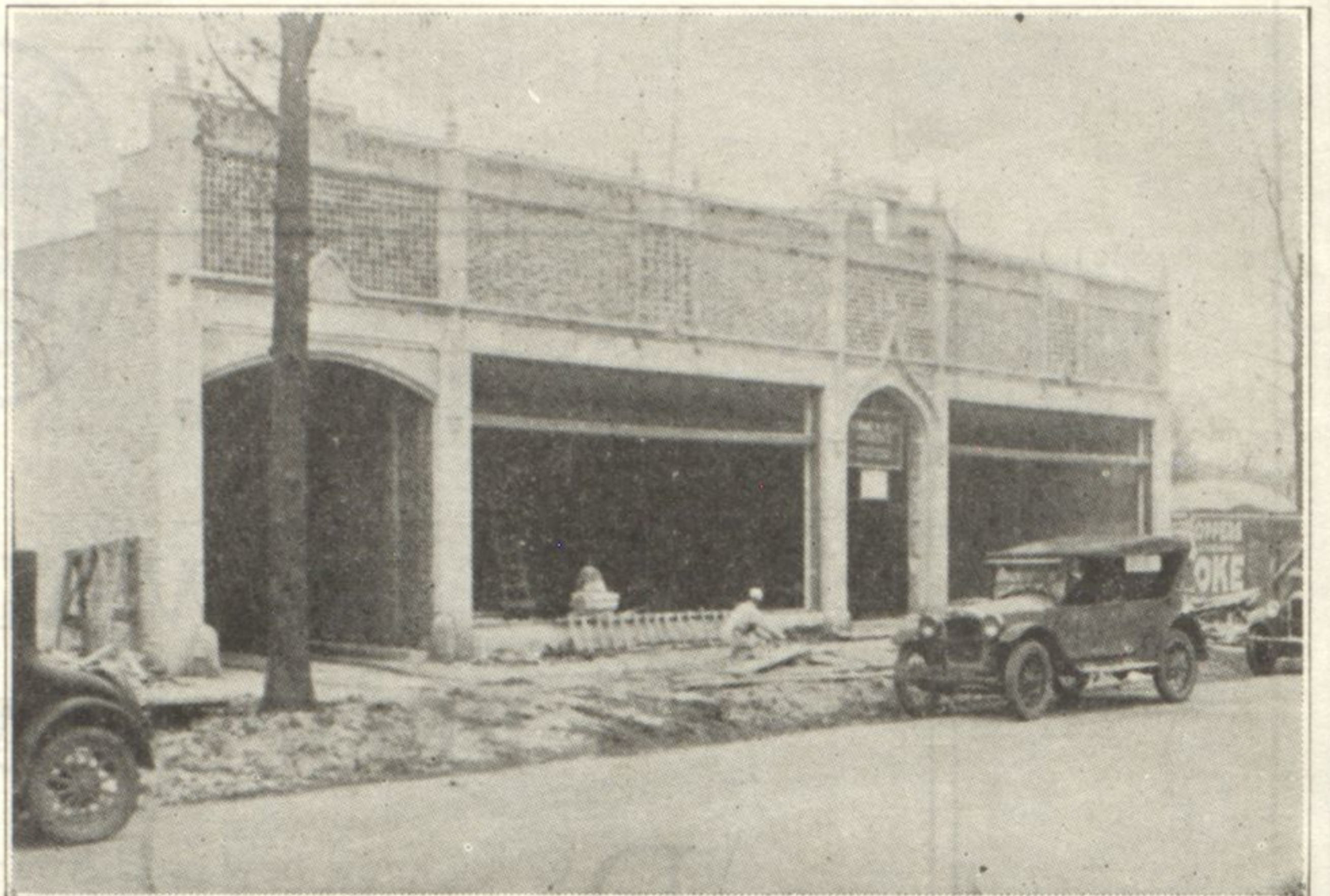

North Shore's New Ford Home



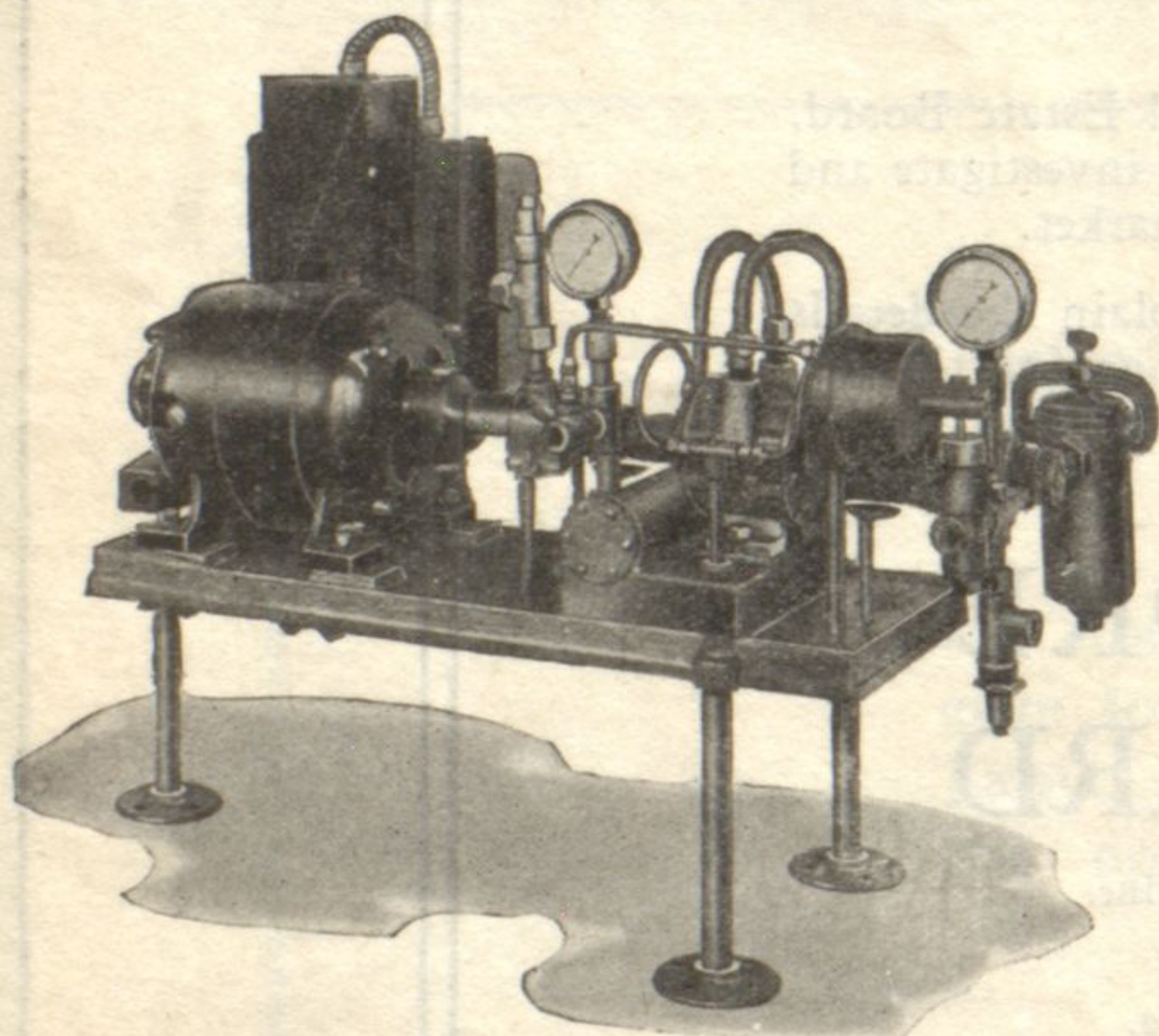

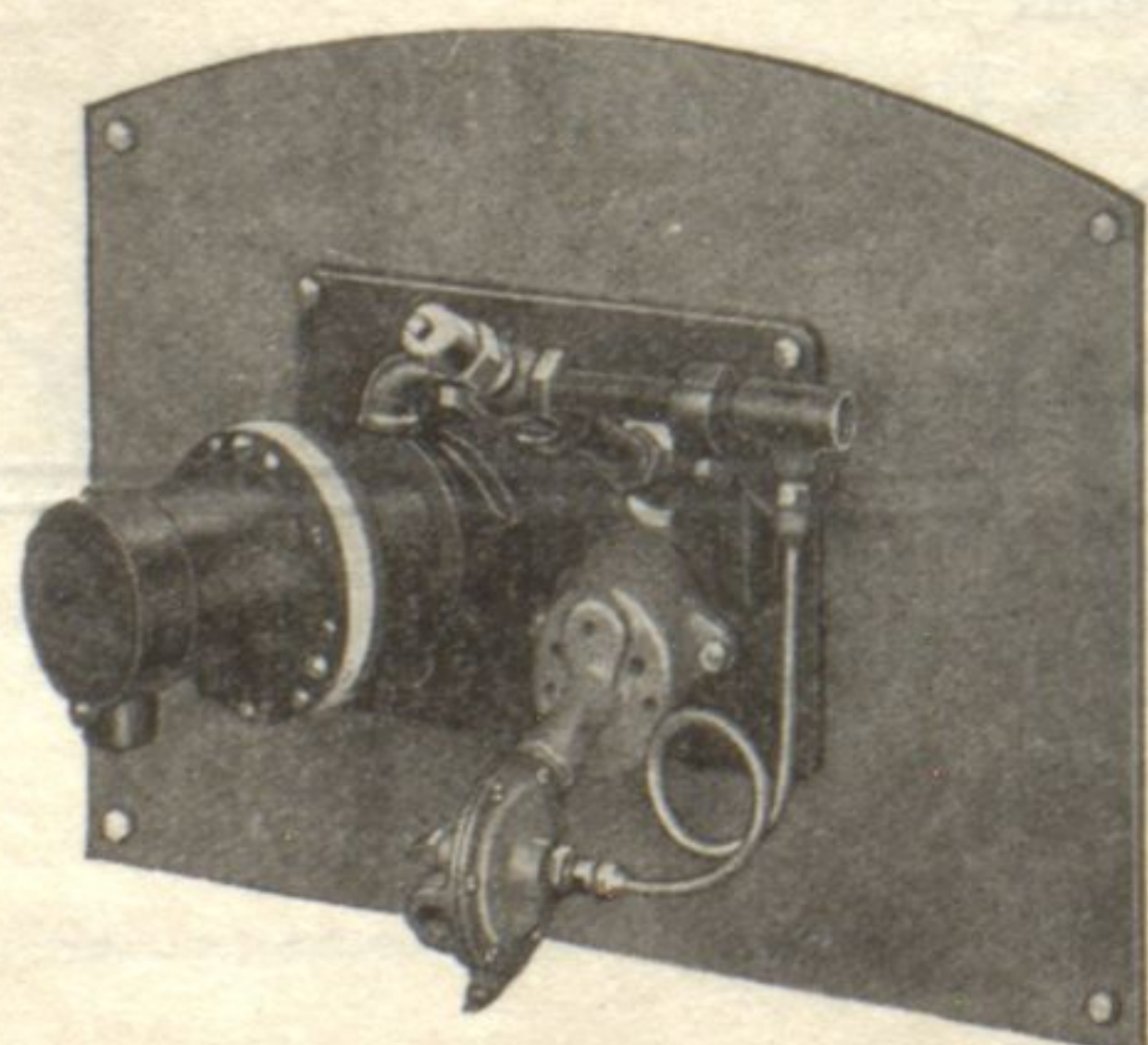
