There never has been the call for clubs in such volume as at the present time, and the Chicagoans who form the nucleus for various organizations which have been formed in the last couple of years or who are forming newer organizations certainly have shown discrimination in selecting the section in which they desire to go. The cry has been "To the North," and that's the thing that prompts this

Here are a few names in clubdom, which isn't exactly news, because these clubs many months ago announced their plans and are ready to start construction of pretentious clubhouses: Shawnee club, at Michigan and Lake avenues in Wilmette, Vista del Lago club on the lake in No Man's Land, and Breakers Beach club on the lake in No Man's Land. These are only a few, for almost monthly we hear of some new club which is to locate on the north shore.

#### Haddon Club Arrives

The latest we hear about is the Haddon Hunt and Hurdle club, a brand new organization which is to locate in Lake County to the north of our fair villages. This is to be a \$1,000,000 organization.

The Haddon Hunt and Hurdle club, named for Col. W. C. Haddon, ranking officer of the 84th division, U. S. army, who is developing it, will occupy a 350 acre tract on both sides of the Des Plaines river, about seven miles north of Libertyville.

Twenty Acre Polo Field

Ground plans call for a twenty acre polo field, a three mile bridle path, space for trap shooting, an artificial lake big enough for match outdoor hockey games. an eighteen hole golf course, etc.

The stable and kennel facilities will be of generous proportions. The stable will accommodate 110 horses. The kennels will house ninety-five dogs.

The main club building, designed in the English Tudor style, will follow the old English manor house idea.


