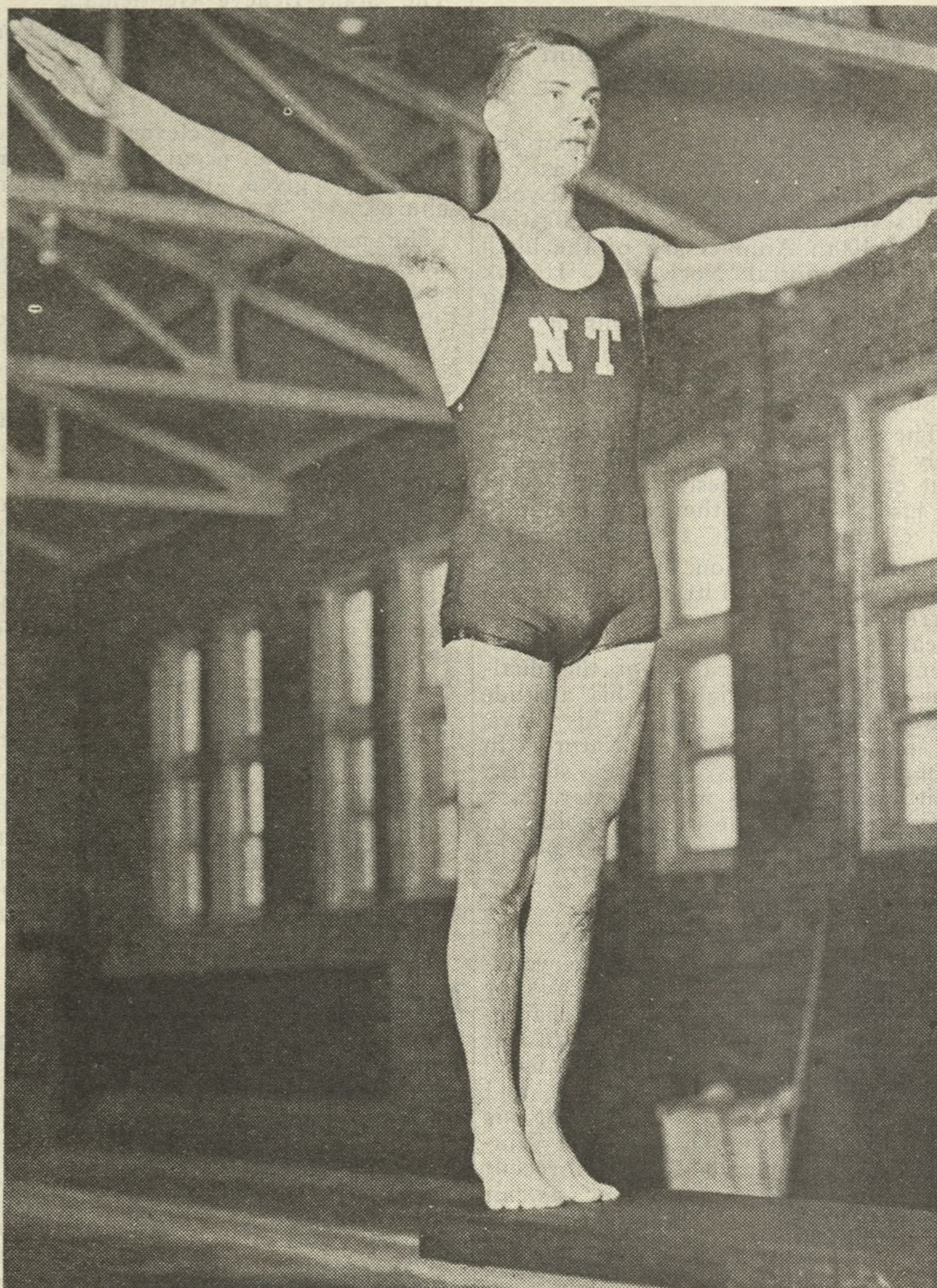
Doing a "Back Jack"

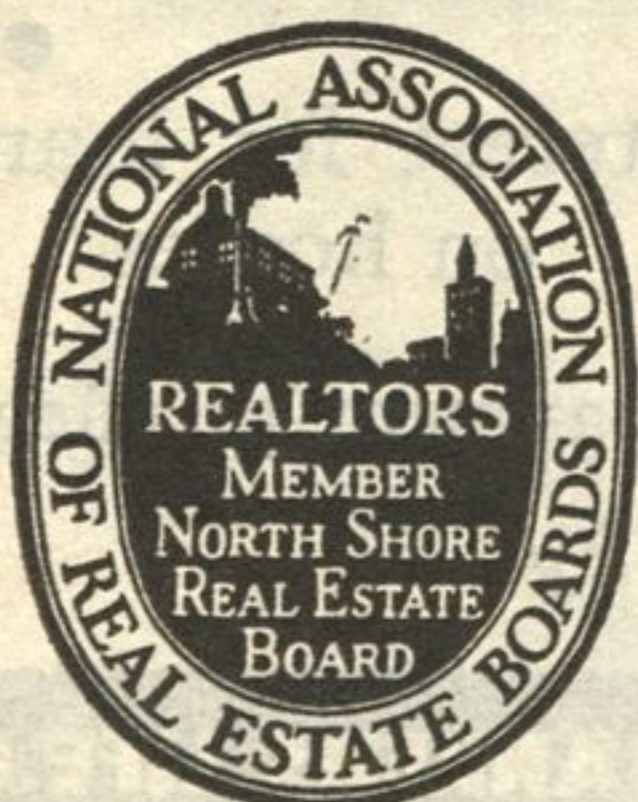
