Congregational Church to Have Novel Program; Unique Departure from Old Custom

In observing the Easter festival, the Winnetka Congregational church this year offers some departures from former customs.

Weather permitting, the young people of high school age will begin the day with a sunrise prayer meeting on the beach belonging to George B. Massey, just south of Lake Front park. The hour will be 7 o'clock.

A special innovation will be the holding of two sessions of the regular Easter morning worship. This is in order that all may be accommodated and is a practice that no doubt will be continued at least until the new church is built. The two services will be essentially alike in every way except that one will be held at 9:30 and one at 11 o'clock. The Rev. James Austin Richards will be the preacher and the whole service will be in the Easter spirit. Worshippers are asked to choose which ever session suits them best. Those who attend the first service will be asked not to leave it through the Library or through Community House, but pass out the east and the north doors of the church. Any arriving early for the second service are asked to enter through Community House where if necessary they can comfortably wait until the church is ready for them to take their places.

Service for Small Children At 9:30 o'clock in Matz hall Dr. W. F. Davies will conduct a special service of worship for those from the fourth grade through to the first year of high school. Sophomores, juniors and seniors will attend the adult services. Kindergarten and primary grades will meet in their rooms a usual.

At 3:30 o'clock in the afternoon there will be a special baptismal service at which parents may present their children for Christian baptism. At 5 o'clock will come the Easter

Vesper service with Easter music and sermon by Rev. Thomas A. Goodwin on "Realizing Immortality."

On Easter Sunday morning there will be a service of worship at 9:30 o'clock for those pupils in the Winnetka Congregational Church schoo from the fourth grade through to the first year of high school. This service will be held in Matz hall.

The Primary and Kindergarten wil go to their own rooms as usual a 9:30 o'clock.

The second, third and fourth year high school pupils will attend the adul service of worship. All regular classes will be discontinued for the day.
