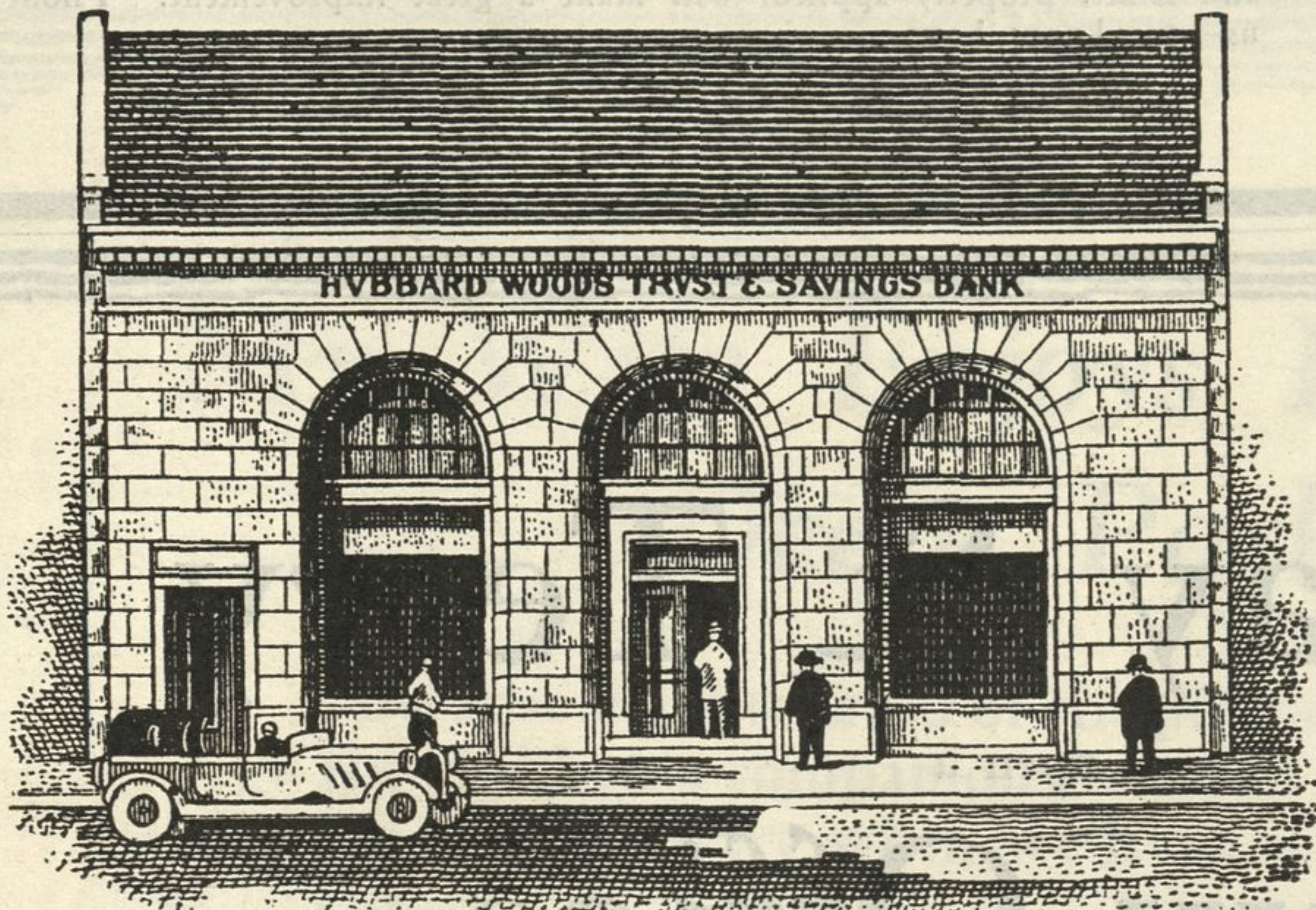

Eighteen Fires Cause Only \$1,935 in Damage

The Winnetka Fire department during the month of March responded to nineteen calls, eighteen of which were for the purpose of extinguishing fires and the other was to rescue a child which had been accidentally locked in the family residence by the maid.

The total damage resulting from the fires was only \$1,935. Efficient work of the department resulted in holding this figure down. Ten hundred eighty-five dollars worth of the damage was to buildings and \$850 to contents thereof.

The value of buildings involved was \$150,900 and the total value of contents endangered was \$22,550.

Seven of the fires were classified as "rubbish" fires; the cause of four fires is unknown; an overheated boiler and an overheated stove each caused one; two resulted from the use of naphtha for cleaning purposes; burning grease, defective electric wiring and a false alarm were recorded as the cause of the three remaining calls.
