LARGEST IN HISTORY

Collector Sanborn Hale Closes Township Books; Large Percentage of Taxes Paid

Tax Collector Sanborn Hale closed the New Trier tax books last Saturday, and Thursday of this week turned them over to County Treasurer George F. Harding.

Collector Hale is pleased to announce that the collections this year have run much larger than in any former year, due credit for which, in a large measure, he gives to the splendid co-operation which he has received from the County Treasurer.

Receives Splendid Co-operation According to Collector Hale, Mr. Harding, in scores of instances where tax payers of the township have mailed their checks directly to the County Treasurer, has returned the check to the remitter with request that lit be paid directly to the township collector.

In numerous other instances where the County Treasurer received requests from tax payers for their tax bills, Mr. Harding replied to the request by advising the person making it, to whom he should apply for the tax bill, and at the same time advised Collector Hale of the inquiry and the response thereto.

In this manner, County Treasurer Harding has enabled Collector Hale, Mr. Hale states, to make the splendid showing that he has achieved this year, and has rendered a service that has also been of financial benefit to the township.

Collector Hale requests that those who have not paid their taxes, wait until April 25 before applying for their tax bill, as the County Treasurer's office will be rushed with work for a few days in auditing and checking up the incoming books from the various collectors.

Turns in \$63,000

In the past three years Collector Hale announces he has turned more than \$63,000 over to the Township Superviser, which has more than enabled the township to operate without a tax levy, and which, in a large measure, enabled that official this spring to transfer the handsome sum which she did, from the general fund to the road and bridge fund.

Furthermore, County Treasurer Harding, according to Collector Hale, is carrying out his pre-election pledge that he would turn the money over to the various taxing bodies of the township as fast as it is collected.
