8 NEW RESIDENCES FOR GLENCOE COST \$188,500

One New Home at \$45,000 and Another at \$40,000—Total for Permits Reaches \$200,000

With nineteen permits for building improvements totalling almost \$200,000, Glencoe's record for the month of May is in keeping with similar activity which characterized the past month throughout north shore villages.

Eight of the permits were for new residences, one of which cost \$45,000 and another \$40,000. The total of the eight was \$188,500.

Six private garages were built, costing \$2,950; there were three remodeling jobs amounting to \$2,500; a play house costing \$250 and a poultry house, \$650, bringing the total for the month to \$194,800.
