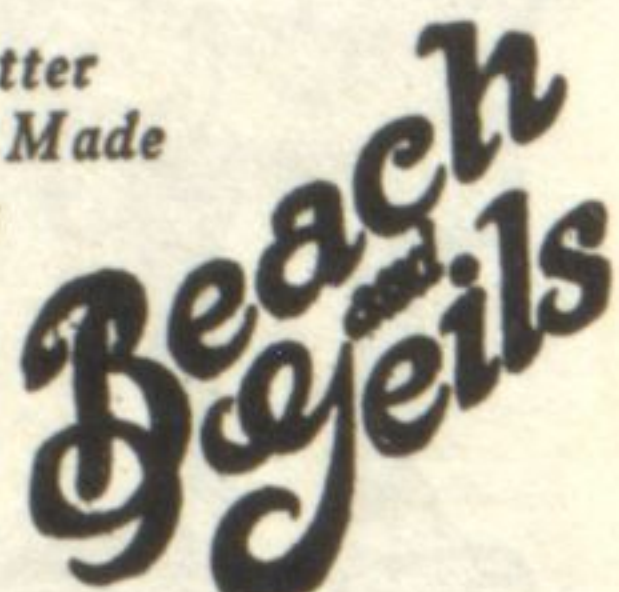

The Voters' Column

The June Special Grand Jury found an alliance between crime and politics and that criminals are nominated to office.

In the last batch of indictments, some being additional charges against those previously indicted, it reported:

Three of Commissioner Hughes' "best in the world" for witnessing without their interference as police, the beating up and kidnapping of workers opposing the candidates of State's Attorney Crowe.

Samuel Kaplan, leader of Eller forces, charge assault to murder. When this thug was ordered brought in, Police Commissioner Hughes said, "What do you want to do? Clout him? I won't have him beaten up."

Peter Pacelli, brother of a state representative, a policeman on State's Attorney Crowe's staff, charge kidnapping.

Harry Hochstein, an Eller follower, charge assault, kidnapping and murder.

Previously indicted were Sam Bardin, bailiff of the Municipal Court, and Martin and Abe Klass, nephews of Morris Eller, and cousins of Judge Eller.

Morris Eller is nominated for Sanitary Trustee by State's Attorney Crowe's following.

When the special prosecutors had to hire and pay Captain John Stege to bring in criminals indicted, they found an alliance among State's Attorney Crowe's official friends to deny Captain Stege authority to make arrests or carry a gun. Police Commissioner Hughes, who is related to State's Attorney Crowe, couldn't give it to a man convicted of a crime 31 years ago.

Municipal Bailiff Bernard Snow, a follower of State's Attorney Crowe, couldn't give it. He says: "I have not taken into consideration the police record of the man I am asked to appoint, but am basing my refusal solely upon the fact that I have no legal authority to appoint any man for any such purpose."

Sheriff Graydon, whose appointment was forced by State's Attorney Crowe over claims of Leonard Brundage, also refused.

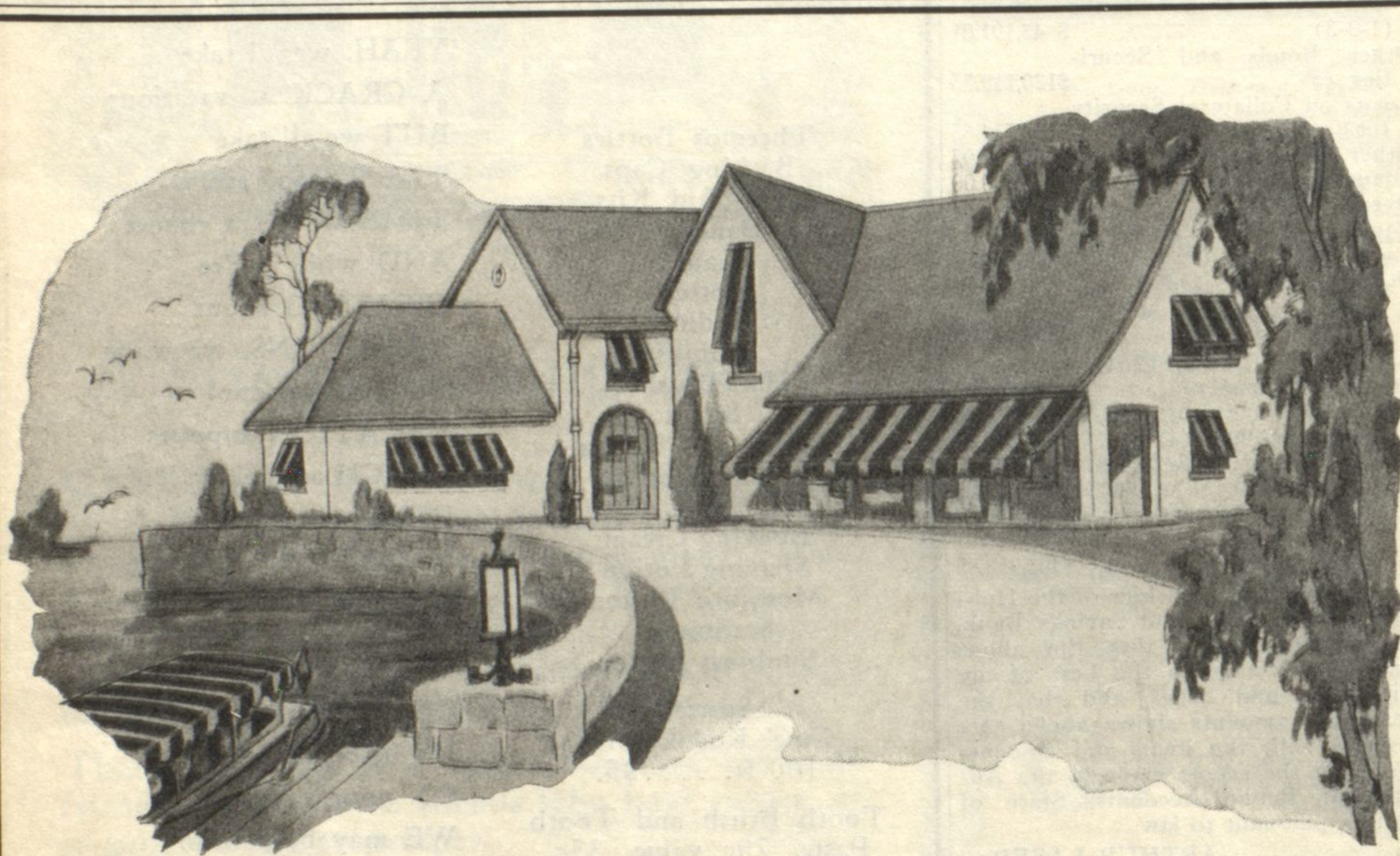
These disclosures have not yet enlightened the judges as to the integrity of the State's Attorney. Answering charges against Judges Eller, Klarkowsky and Kerner for waiving penitentiary offenses and giving jail sentences or paroles to criminals, the majority of the judges of the Circuit and Superior court made a finding smothered in an avalanche of 117 printed pages based, not on "law" and "precedent" but on "history" and "statistics." A careful searcher finds the decision as follows:

"The power and right to require waivers is, according to the 'history' of the Criminal Court of Cook County, substantially wholly with the State's Attorney."

They further decided that the decline of felony waivers, since the Crime Commission's charges, "is owing solely to the fact that the State's Attorney is not now 'asking' for them," and add:

"Nothing of what we have said is meant to give the impression that a court should not, when its suspicion is aroused as to the integrity of the State's Attorney or the purity of his motives in a given case, take every precaution to guard against corrupt dealing on his part."

Mr. Loesch and his aids say they will continue their efforts to "arouse suspicion of the integrity of the State's Attorney" until a new State's Attorney performs. Judge Swanson promises if elected State's Attorney that the regular grand jury, the 30 policemen in the State's Attorney's office, and his paid assistants will relieve the people from the burden of fighting crime by private subscription.
