
# Glencoe State Bank Announces Ambitious Building Program




The above cuts show how the new Glencoe State Bank, on which construction work is to start soon, will look when completed. At the left is the Park avenue front of the proposed new building and at the right is the Tudor Court frontage.

The Park avenue front is designed in modern classical architecture, constructed of Indiana limestone topped off with a heavy slate mansard roof,

and with bronze finished entrance doors and windows.

The Tudor Court frontage is designed in modern French mansion style of Indiana limestone with slate mansard roof and wrought iron balconies. It will be divided into three shops for possible use as a beauty parlor, ladies' specialty shop and an antique shop. The second and third floors will be divided into four apartments, each of four rooms and bath and having unsurpassed outlook over the park and the site of the Women's Library club and with cross ventilation from a large court thirty feet in width in the rear of the two buildings.

Construction of the buildings will be modern steel, concrete, brick and



stone, and every modern convenience known to the building industry will be installed in the building.

The front, rear, west walls and roof of the existing bank building will be removed. The new structure will occupy in addition to the site of the present building, the lot adjoining it on the west, making the area of the new building fifty feet frontage on Park avenue, extending through 125 feet to Tudor court. It will be three stories high.

The Park avenue frontage on the first floor and basement will be occupied by the banking room and safety deposit vaults. The second and third floors will be divided into eight suites of professional offices. Entrances to the offices will be on the Park avenue front at the east side of the building. In addition to the wide and convenient stairway the offices will be served by an electric elevator.

Leon E. Stanhope, of 252 Walden drive, Glencoe, is the architect.
