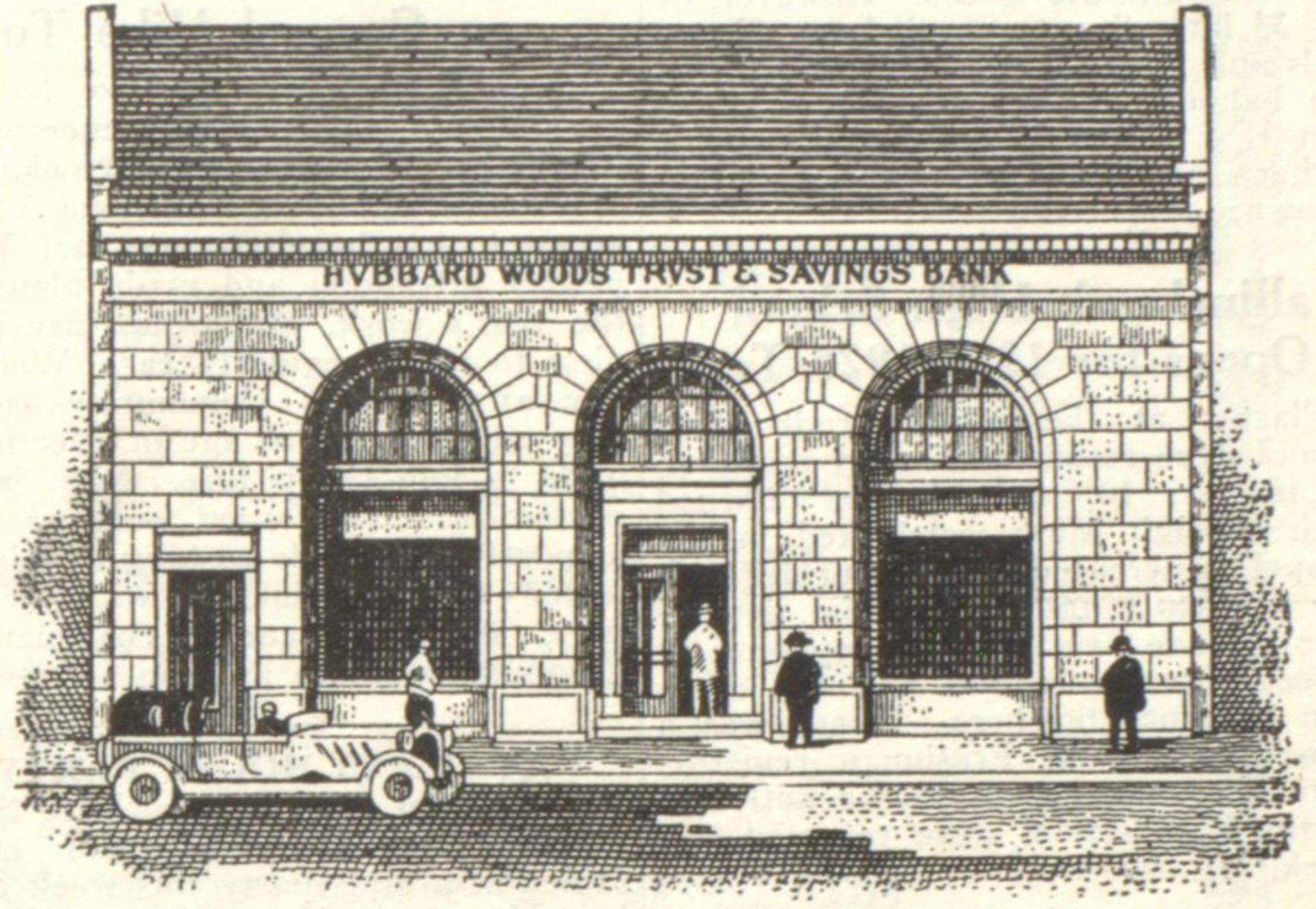
## "Chief" Davies Resumes Work with "Pathfinders"
