SENTENCED.

On Saturday evening last information was laid before one of our local J. P.'s, against one of the prominent members of our local Anti-Tobacco Association, charging him with violating the obligation of that Society. The prisoner was tried summarily when being asked to plead, "guilty or not guilty," the prisoner declined, and raised objections as to the jurisdiction of the court, couching his objections in rather vigorous Volapuk, and otherwise making himself liable for contempt. The magistrate, however, after considerable trouble, restored order to the court, and proceeded to examine the witnesses. The first witness called flatly refused to give evidence until his fees were paid. As his wishes could not be complied with, his evidence was dispensed with, and the examination of a less mercenary witness proceeded with. This witness stated that prisoner was one of the leading members of the Association. He stated also that on a certain day mentioned, he walked into the prisoner's place of business, and saw said prisoner with a half-smoked cigar in his hand, the room at the time smelling of cigar smoke. Prisoner was then heard in his own defence. He again broke out into Volapuk, and charged his accusers with "black-mail" and declared the whole business was a "put up job." Prisoner was here interrupted by a brother member, who immediately received, "a striking reply" to his remarks, in the shape of a rap with a yard stick. The prisoner stated that the fact that he had been seen with a half-smoked cigar in his hand was no proof that he had violated his obligation, and furnished an eloquent defence by saying that "No man had seen him smoke, and—and very few women." A "second Daniel" who had "come to judgment," was then called upon to address the court, and sum up the evidence against the prisoner. He showed that it had been proved that prisoner had been one of the foremost members—in fact a charter member of the Stouffville Anti-Tobacco Association, and that it had, by the clearest evidence, been proved that said prisoner had violated his pledge. "Daniel" also called the attention of the court to the fact that while prisoner contended that "no man had seen him smoke he had inadvertently admitted that "a few women" had seen him do so. In fact the equivocal manner of the prisoner, especially in refusing to plead, betrayed conscious guilt. The speaker then closed the most brilliant address ever heard in court, since the trial of Warren Hastings, by calling upon the magistrate to pronounce sentence. The magistrate declared that in his opinion the prisoner had been fairly tried and found guilty. He then sentenced prisoner to pay a fine of a "pail-full" of oysters within one week, or in default of payment was to be imprisoned for twenty-one days at hard labor.

PRO BONO PUBLICO.

At the instance of our pushing townsman Mr. R. J. Daley, a large number of the business men, principally merchants of the town met in the Council Chamber on Thursday night last to consider the advisability of drawing attention to the advantages offered by this village and surrounding country for the establishment of a canning factory; to put up fruit, vegetable pickles etc. Mr. Jas. Dougherty was appointed chairman, and Mr. F. H. Sangster Secretary of the meeting. Mr. Daley spoke of the good location of Stouffville for such an industry and from his remarks and those of Messrs. A. G. Brown, and J. A. Todd it was learned that there are large quantities of berries shipped annually from Stouffville and adjoining points which could be greatly increased if a good market were provided for their produce. Mr. F. Wilson and J. Urquhart and others spoke in favor of the scheme; in fact the meeting was unanimously in favor of it. Mr. H. Johnson gave a new current to the discussion by advancing the idea that the proposed invitation would come with more force and grace from an organized body such as a Board of Trade, and spoke of the other advantages of such a body. To bring matters to a head Mr. Hamilton, seconded by Mr. Johnson, moved that the meeting be resolved into a Board of Trade. At the request of Mr. D. Stouffer more light was thrown on the subject of the workings and powers of such a body by Messrs. Hartney and Johnson and on the motion being put there was no dissenting voice. The following provisional officers were then elected: President H. Johnson; Vice President U. C. Hamilton; Secretary F. H. Sangster; Treasurer D. Stouffer. A Committee consisting of the President, Secretary, Hartney, Daley and Leaney was then appointed to draft a constitution. The original object of the meeting was not by any means lost sight of, but only deferred for one week, when the Infant Board of Trade will meet a gain and definite steps will be taken to induce some industry to locate in this thriving town. Nearly all present signified their intention of becoming members. The meeting then adjourned till Thursday evening March 29th, when the constitution will be adopted.

UxBRIDGE TOWNSHIP COUNCIL.

The Uxbridge Township Council met on Saturday, March 16th. Members all present. Reeve in the chair. Minutes of last meeting read and approved. A communication from J. Bundy, Claremont, re accident on the 4th Concession of Uxbridge, claiming \$50.00 damage, but the Council claimed they were not liable.

Councilman Dowswell presented a petition signed by Thos. Storry and 16 others, asking that Wm. Todd be appointed pathmaster for the East Division of Goodwood.

Accounts amounting to \$71.09 were examined and passed.

Moved by Williams, seconded by Millard that the Reeve and Ewen be a committee to lease or buy a gravel pit for road division 88, and report at next meeting of this Council.

Moved by Williams, seconded by Ewen, that the Reeve be authorized to buy 6 road scrapers.

Moved by Dowswell, seconded by Millard, that Ewen be a commissioner to examine snow-fence built by Jos. Chapman, on the Centre Road, and if built according to snow fence By-law to grant his certificate to the Reeve for the sum of 25 cts per rod for the same.

Moved by Dowswell, seconded by Millard, that the Clerk be instructed to notify Aaron Griffin to remove his fence off the road allowance on the Centre Road through lot 27, 5th concession.

Moved by Millard, seconded by Ewen, that the Clerk be instructed to get 50 copies of list of Township officers printed and forward one to each postmaster in this Municipality.

Moved by Ewen, seconded by Dowswell, that the petition of Stephen Shall and 8 others be left over until the next meeting of this Council.

Moved by Millard, seconded by Dowswell, that when this Council adjourns it stands adjourned until Saturday, April 18th.
