OBITUARY. Mr. David L. Barclay, of Stouffville died on Thursday last, 29th Sept., at the advanced age of 83 years. To the older generation here and in Pickering the deceased was well known, he having been born in Pickering on the 15th of June 1819, and having lived on his farm in the 7th Con., next that of the late Mr. J. Miller, nearly all his lifetime and up to the time of his removal to Stouffville a few years ago. He was the son of Rev. George Barclay, Baptist Minister, who came from Fifehire, Scotland, and settled in Pickering in the year 1817. The deceased was an old time Reformer, and was one of the patriots who followed Wm. Lyon Mackenzie in his struggles for freedom and for responsible government, and against the domination and the usurpations of the Family Compact. He was a member of the Pickering Company which marched under Capt. Peter Matthews in December, 1837, and which took part in the affray at Montgomery's Tavern. After that skirmish or engagement he escaped and returned to his home bringing with him Matthews' horse. His elder brother, also a member of the same Company, was captured, convicted of treason and sentenced to be transported to Van Diemans' Land for life. In early life, the deceased became a member of the Church of Christ, Disciples, and continued a faithful adherent of that faith until his death. He was twice married, and leaves a widow, who proved a most devoted helpmeet, to mourn his loss. Mr. E. E. Sheppard, of "Saturday Night" and Mr. L. T. Barclay, Barrister, Whitby, are nephews.
