## WHITCHURCH COUNCIL

Regular meeting of council was held at the township hall, May 27th with all the members present and the Reeve presiding.

Minutes of last meeting were read and confirmed.

Communications as noted herein were received and read, viz: W. C. Widdifield, reclaim of John W. Parkins, Ernest Hinchliffe, C. E. with request for appointment as township engineer. A. Sutherland, District Sup't. of Postal service, re-confirmation of roads on rural route No. 3, Aurora. F. A. Gaby chief engineer, H. E. Power commission, re-passing of by-law and signing agreement between the township and the commission. Mrs. A. L. Huggins re-application for Hydro-Electric Lighting. Grant R. Jack, with request for sale or lease to him of unused part of 9th Con line at Musselman's lake. S. G. Snively, advising council of his intention to fence in his property bordering on Lake Wilcox to the west of the 2nd con. road and asking whether council had any legal objection to same. Gilchrist & Walsh, solicitors for Henry Brisbin, owner of lot 3, plan 134, objecting to the opening of a ditch by Wm. Smith through his land on Lake Wilcox road, to within a few feet of Mr. Brisbin's property.

J. A. Clarke presented for one lamb killed by dogs. Collectors statement of uncollected taxes of 1923 was presented.

The clerk was instructed to notify Mr. Jack that council deems it inadvisable to dispose of any of the roadway which he desired to obtain at Musselman's Lake.

Appointing the Reeve and Deputy Reeve a committee to consult the Township solicitors regarding the fence at Wilcox Lake which Mr. Snively proposes to erect.

The collector's roll was returned showing taxes uncollected of \$1790.61, since report \$54.99 with penalty of \$20.18 has been paid. O. Ilcmaki was rebated \$6.18 having been assessed in error. Several other minor adjustments of the roll such as dogs struck off etc., leaving the unpaid tax demand as \$1257.83 which will be sent to the County treasurer for collection.

Council decided to appoint special constables at Lake Wilcox and Musselman's for Saturdays, Sundays and holidays during the summer.

In future council will charge 50c. per lot for giving their approval of lot plans on sub-divisions. E. Davis was granted approval of sub-division plan lots 18-19, con. 3, after slight alterations.

The following stated grants were made for gravelling or otherwise improving and repairing roads at places mentioned under supervision of the Commissioners:

\$25 opp. lot 5, con. 7; \$100 between lots 4 and 5, con. 8; \$50 between lots 10 and 11, con. 10; Councillor Baker, commissioner.

\$75 opp. lot 14, con. 7; \$125 opp. lots 14 to 16, con. 9; \$20 opp. lot 12, con. 10. Reeve Baker, commissioner.

\$100 between lots 30 and 31, con. 7; Councillor Kidd, commissioner.

\$200 opposite lots 6 to 14, con. 2; \$75 between lots 5 and 6, con. 4; Deputy Reeve Leary, commissioner.

\$200 opp. lots 23 to 28, con. 2; \$100 opp. lots 32 to 35, con. 4; Councillor Dennis, commissioner.

Council adjourned until Wednesday, June 25th.

## METHODIST DISTRICT HELD ANNUAL MEETING

The annual Meeting of the Uxbridge District of the Methodist Church was held in Uxbridge recently with a good attendance of ministers and laymen. The officers of the District are—Rev. O. W. Watch, Chairman; Rev. G. E. Coulter, Financial secretary; Rev. H. Newel, Journal secretary; Rev. V. Ellison, statistical secretary. One of the most important matters of business was the concurring in the report of the local Co-operating Committee and the churches concerned whereby—Sunderland Presbyterian and Methodist churches will be united into one charge, in affiliation with the Methodist church, and the Wick Presbyterian and Pinedale Methodist churches will be united in affiliation with the Presbyterian church.

## ONLY FOUR APPEALS

Markham Township Court of Revision had a very light task this year. There were only four appeals against the assessment, two on the east side and two on the west.

J. Pickering appealed against an assessment on house of \$300 which he rented from Mr. Coakwell. Dismissed.

Assessor Forster recommended that the assessment of Timbers & Ramer on garage at Milliken assessed for \$1100 be reduced to \$600, and the roll was amended accordingly.

The appeal against an assessment of \$5000 on 53 acres, lot 42, con. 1, as too high was dismissed.

Fred Johnson's appeal against the assessment of his farm, lot 29, con. 5, of \$7500 on land and \$300 on buildings was sustained and the assessment on land reduced to \$5000.

The names of Martin Fockler and Franklin Hoover were added to the roll as tenants, lot 33, con. 7, east and the names of their wives will also go on roll as married women. Stanley Jarvis, lot 19, con. 6, was added to roll as farmer's son.
