

MARKHAM TP. COUNCIL

Council met at Unionville on Monday with all the members present and Reeve Gohn in the chair.

Communications received: From County Treasurer, stating that the following lands had been sold for taxes: 5.30 acres, part of lot 13, con. 2w., assessed to Seth Woodward; 5.55 acres, part of lot 13, con. 2w., assessed to J. Campbell; 7.93 acres, assessed to Hubbs & Hubbs, part of lot 13, con. 2w.; part of lot 13, con. 6w., assessed to W. Peel; 3/4 acre, assessed to Mrs. Prebble, part of lot 12, con. 6w. The county treasurer stated that none of these parcels can be traced in the registry office and that unless a more definite description can be given, a refund of the purchase money paid, plus percentages, will have to be made which will mean a loss to your municipality.

From J. Urquhart, clerk of Stouffville, re share of school debentures for S.S. 1 and 23, Markham's share No. \$185.77 and No. 23, \$47.08.

From Ontario Hospital, re admission of Alice Madill to hospital on July 5th, a citizen of the township.

From Ernest W. Boulton, asking permission to remove two elm trees from road allowance in front of his place on Church street, Markham, as trees are of no artistic value.

From Queen Mary's Hospital, Peterboro, stating that Mrs. Chas. Morgan, a former resident of Unionville, an indigent, had been admitted to that institution on Sept. 27th, and that Markham township is liable for the charge for her treatment and maintenance.

From F. V. John, assistant Provincial Secretary, enclosing order-in-council appointing Wm. Jas. McCoy of the City of Toronto, accountant, a commissioner to enquire into the financial affairs of the Township of Markham, with all powers provided by the statutes.

In answer to a resolution passed at last meeting of the council that they desired a hearing in regard to the removal of sidewalks by the Hydro-Electric Commission at Thornhill, the Ontario Railway and Municipal Board wrote asking if there was any written agreement between the Township authorities and the Hydro-Electric Commission in regard to sidewalks, and if so to send a copy of such agreement.

Mr. Maynard, one of the trustees of the Police Village of Unionville, asked the council to pass a resolution to empower the treasurer to provide \$1900 for the purchase of a motor fire engine from the Bickle Fire Engine Co., Woodstock. He was told that the council could pass a resolution authorizing an overdraft.

Mr. Maynard said that the trustees had signed a contract with the Bickle Co. to build a chemical engine with two 70-gallon tanks and that Pickering, Clarendon, North York and other municipalities who had purchased similar engines were all satisfied that this was the best engine in the market for the purpose, and the price was very reasonable.

The reeve told Mr. Maynard the council could not authorize an overdraft for the Police Village until a copy of the resolution authorizing the purchase, and a written request in resolution form was made to the council.

The clerk was instructed to get information and write to Queen Mary's hospital, Peterboro, re Mrs. Morgan.

Resolutions were passed:—Appointing J. R. Campbell commissioner to enquire into one Alice Madill, admitted as a patient to Ontario hospital, Whitby, as to her residence in the township.

Instructing the clerk to cancel Dr. Chas. R. McKay's contract with Hydro, his dwelling having been destroyed by fire.

The treasurer was instructed to pay the following road accounts:

A bylaw was passed under the Ditches and Watercourses Act, appointing H. A. Babcock of the City of Toronto, Township Engineer.

Councillor Campbell asked the council to make his road division (No. 4) a supplementary grant of \$150 to complete repairing the roads. He needed the money to fill in some holes on the 9th with gravel and for dragging the roads. Unless this was done they might become impassable. He had spent a little more money than he had intended on the 8th con. for gravel, because he had been able to get some which he did not think would be available next year, and his allowance of \$100 a mile was all spent except for a few dollars.

The reeve thought Mr. Campbell's request a reasonable and sensible one, and if Mr. Campbell would forego the request for gravel on the 9th, he would be in favor of allowing him \$100 more for dragging if the roads should need it.

Deputy Stiver favored the request and Deputy Smith would vote for it provided the council would promise him a similar grant for his subdivision. Councillor Clarry was opposed to making the grant under any circumstances.

A resolution moved by Mr. Stiver and seconded by Mr. Campbell that Mr. Campbell be granted \$100 for dragging the roads in his division was carried with Deputy Smith and Councillor Clarry voting nay.

The council adjourned to meet on Monday, Dec. 1st, at 1 p.m.
