Seven-ton cannons court house sentry

Unless something larger has appeared on a court house lawn in the last half-century, Ontario County and the town of Whitby have two of the largest cannons in Canada. In 1902, when the two seven-inch guns were mounted in front of the county building on Centre street, they were the largest in the country.

The two cannons were built in Woolwich, Eng., in 1856, the year after the county building was erected. Because of the dates "stamped on" the guns, many have suggested that they appeared at the time of the court house opening but actually, they did not arrive in Whitby until 1902, say records of the Ontario County Council.

The two cannon received their first mention in council records in 1901, when a letter was received announcing that the Imperial Government was planning to give the county two obsolete cannons. In fact, the offer covered a choice of two types of cannon.

One type was a smaller gun, weighing less than two tons and the other was the seven-inch RML gun, weighing seven tons, with a seven-ton carriage. Ontario County chose the latter. Never in War.

The guns came to Whitby from Halifax, where they had been mounted at the Citadel but records show that neither weapon was ever fired in war time.

However, the donors of the cannon apparently thought they might some day be fired in Whitby, for records show that complete instructions for firing were enclosed.

These included advice that a fully loaded shell weighed 118 pounds. The shrapnel shell weighed one pound less and either shell was propelled by 30 pounds of powder. The guns are muzzle loaders and records showed that a saluting charge used only 10 pounds of powder. There is no advice on how far all this powder would toss a shell through the 126-inch long rifled barrel.

Moving Guns Getting the guns to Whitby turned out to be almost as interesting as their history. James Carnegie, commissioner at that time, has recorded, for council's benefit, the tribulations encountered in getting the guns here.

At the first leg of the trip, in Halifax, the heavy guns caused a breakdown of equipment and before the loading was completed, the contract price for the job had been raised from \$32 to \$46.85.

Great difficulty was experienced in handling such heavy weights," Mr. Carnegie chronicled, "and in fact one of the contractor's wagons was so badly broken up that he will be a loser rather than a gainer by the transaction."

At this end of the line, says Mr. Carnegie's record, getting the 14 tons of artillery into place in front of the building proved almost as difficult.

Seven-ton Carriage—The record shows that Joseph Heard contracted for the job and found that the seven tons mentioned in the contract meant the weight of the guns. The carriage accounted for another 7 tons.

"The work was so difficult that Mr. Heard, after spending much time and money," says Carnegie's record, "was desirous of abandoning the contract and losing what he had spent." Here, too, the commissioner

found that he had to increase the contract price, in this case, from \$83 to \$80.

"While the expense of loading freight and unloading has been a considerable sum," Mr. Carnegie's report ends, "the county possesses two of the largest cannon between Halifax and Vancouver."

O.P.P. discount murder theory in Uxbridge Township death

A reported "murder" on the outskirts of the Town of Uxbridge on Saturday night caused much alarm as officers from the Ontario Provincial Police Detachment at Whitby and 3 Toronto daily papers attempted to trace the source of the information. The report was later denounced by police.

The incident occurred at the home of Mr. Norman Lee, lot 29, conc. 6, Uxbridge. Members of the family informed the Tribune that a minor "scuffle" had broken out in the kitchen of the Lee house around 8:30 p.m. According to reports, Mr. Lee attempted to evict a man from his residence when he came to see his daughter. During the heat of the argument, Lee fell to the floor and was pronounced dead. Death has been attributed to a heart attack. The family said that the victim had been suffering from a heart condition for some time and had been warned by his physician that any excitement or strain could prove fatal.

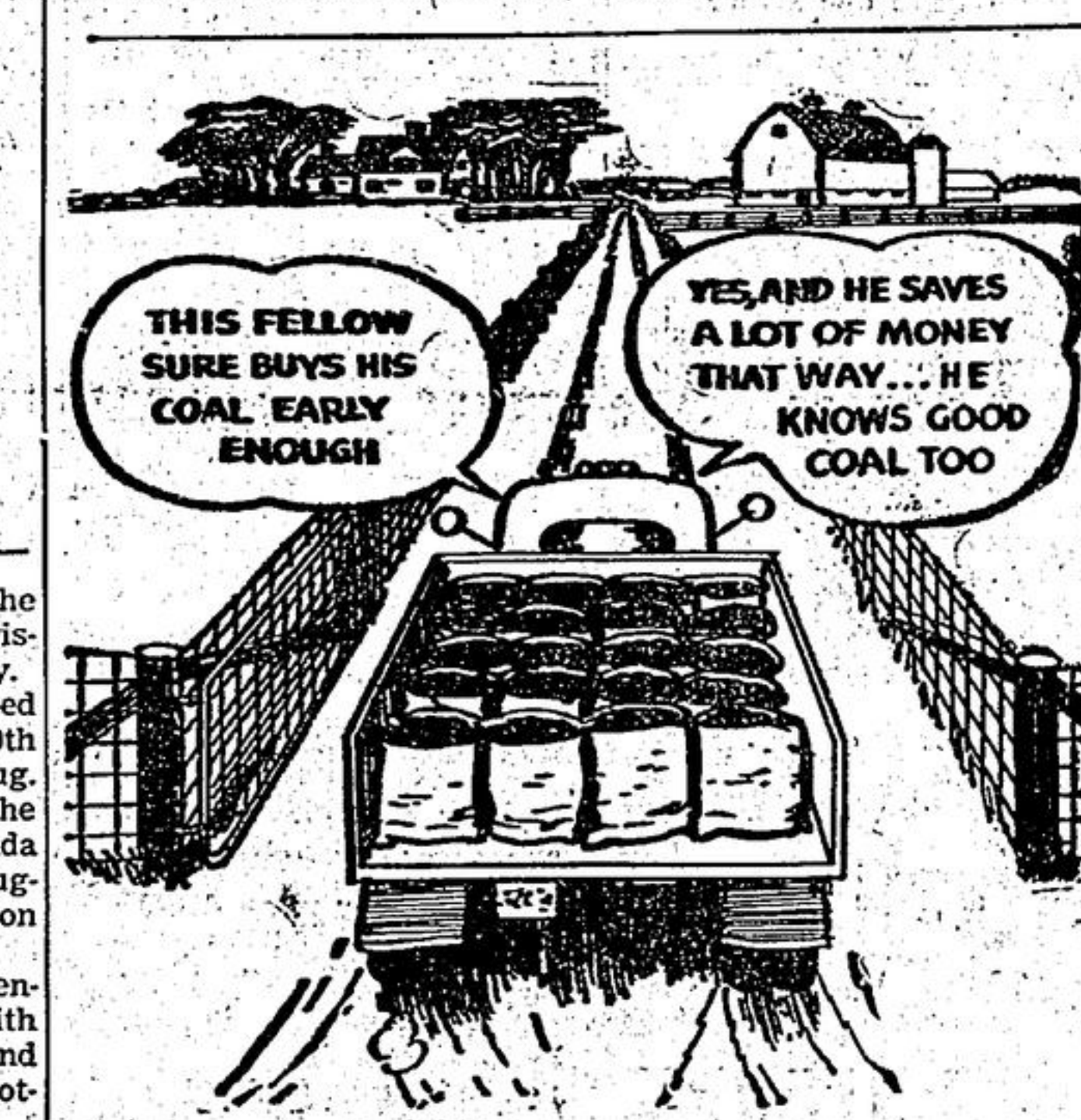
JUNIOR FARMERS COUNTY TOUR
