Speaking at a meeting of council, deputy-reeve Nesbitt charged that in total numbers there were just too many dogs in the township. He said some families kept as many as three. "In many cases there's no one at home to look after them so they just run wild. I say that all such strays should be caught and shot."

Other members failed to act on his recommendation.

James Pickering, 28, although alive when his wife reached him was pronounced dead at the scene thirty minutes later. Markham U. M. Church

Will build Christian education centre

MARKHAM — It is surely a good sign when attendance at church and Sunday School exceeds the accommodation available. This problem, if it can be termed such, has been evident in recent years within the United Missionary congregations at Altona, Stouffville, Gormley, Dickson's Hill and Markham. All have completed or are in the process of undertaking sizeable expansion projects.

The most recent to be announced is at Markham where a new \$25,000 Christian Centre is planned at the rear of the present property on Main Street North. The congregation gave the program its approval at a meeting Feb. 7 and work on the extension will begin very soon.

The structure will measure 30' by 40' with a large auditorium for youth work on the ground floor and accommodation for Sunday School classes in the basement.

The building committee includes Clarence McDowell, Samuel Stadelbauer, Bill Warnock, Garfield Bennett, Denton Brown and the pastor, Rev. Grant Sloss.

Re-open Goodwood port

GOODWOOD — Edward Lanigan, R.R.3, Uxbridge, has requested approval of the township council in his bid to re-open the airport at Goodwood.

Mr. Lanigan told the members that their support would assist him in obtaining the charter he requires to operate. He said that he had rented the property and was in the process of renovating the buildings and improving the runways. He has 14 aircraft and hopes to operate a flying instruction course.

"What I need is evidence of public interest," he said.

The council assured him that they would be pleased to see the airport in operation again. The Clerk was requested to check to see what bylaws were in effect covering this kind of business.

New half million dollar school for Whitchurch

Abandon Sr. school plan

BALLANTRAE — A new Senior School proposal for Whitchurch Township has been abandoned and in its place the Board will erect a fully graded school. The school to be built at the 5th concession and the Bloomington Road, will contain 12 class rooms and have a total area of 34,000 square feet which will include other service rooms and a library. The estimated cost of the project is approximately one and one-half million dollars.

This is a departure by the 1968 Board from the plans adopted in 1967 to build a senior school. Plans for the new building are presently being prepared and it is hoped to have the school ready for next fall.

Committee Appointment

As part of the provincial plan to replace present school boards with one hundred regional boards, the Whitchurch area trustees have named Michael Ogden as representative on the Consultative Committee which will function during the transitional period.

To Sell Property

Valuators have submitted figures to the board for the property purchased in 1967 at the 7th concession and the Vandorf Side Road and members have agreed that this original school site should be advertised for sale. Since purchasing this property last year the Board has installed a thousand dollar drilled well.

Truck halts trains

VANDORF — Sergeant Fred Crawford of Whitchurch Township police and truck driver, Keith Heathington of Oakville, spent a few anxious moments in the Vandorf station as the officer attempted to halt all trains on the local C.N.R. line.

The instructions were telephoned to a despatcher in Toronto after a tractor-trailer, carrying a heavy load of lumber, became stuck across the tracks on Slater's Road, east of Don Mills.

Sgt. Crawford was told

that not one, but two trains were headed in that direction, one from the north and another from the south. The despatcher said he would wire ahead and attempt to hold up both units. Fortunately for all concerned, he was successful. A northbound freight was stopped at Gormley and another travelling to Toronto, was stopped at Pine Orchard.

It took workmen and two truck crews almost an hour to free the truck from its precarious position.

Inquest hearing

Driver cleared in girl's death

CLAREMONT — A Claremont district motorist has been cleared of all blame in connection with a fatal accident Dec. 8 that killed a 16 year old girl as she walked along conc. 9, Pickering, with her mother.

The inquest hearing was held at Whitby.

Constable Angus Way of the O.P.P. said that he arrived at the accident scene shortly after 5 p.m. and found the victim, later identified as Helen Detering, lying on the south shoulder of the highway. He said that she appeared to be dead. The death car, owned and driven by Ross Heron, Claremont, R.R. 2 was parked nearby, the officer said. He described its mechanical condition as good although the left high headlight was out.

Mr. Heron said he was

travelling east at about 45 miles per hour and failed to see the victim until he was too close to avoid hitting her. He said that on impact, she was thrown up on the hood, then fell off to the right. The motorist said that the girl was walking on the pavement with her back to the traffic. This evidence was supported by David Whittington, 20, who said he had seen her earlier.

Mrs. Krista Hilge, operator of the Claremont Nursing Home where the victim and her mother were employed, said that she almost hit the pair herself. She said she offered them a ride but they refused.

Crown Attorney Edward Howell stated that the clothing worn by the girl was dark in color and not easily seen. They ruled that the pedestrians, and not the motorist, were totally at fault.

Boy scout

Receives high award

CLAREMONT — A Claremont Boy Scout has been cited for actions becoming a member of that world-wide organization and will receive the Medal of Meritorious Conduct from the Governor General of Canada.

Haig DeRusha, 13, son of Mr. and Mrs. George DeRusha, has been selected by the Award Committee of the Boy Scouts of Canada to receive this award in appreciation of his actions following a serious accident in Stouffville, July 22.

It was on that date last summer in the Stouffville Park, that a 6 year old boy fell from the top of a rotary slide, striking his head on the cement base below. Haig went to the lad's aid and carried him more than six blocks to the Stouffville Medical Centre. From there, he was rushed by police cruiser to hospital and although still unconscious on his arrival, he made an excellent recovery. When Stouffville Council learned of the incident, a letter of commendation was sent by the Clerk to his parents and his Scoutmaster.

On Monday night, Haig, a grade 8 student at Claremont Public School was honored by District Commissioner Cor Heikamp and presented with a red distinguished service ribbon. Other members of the Claremont Troop attended the ceremony.

The presentation by the Governor General will follow, either in Ottawa or Toronto.

Finish dam in June

STOUFFVILLE — The flood control dam being built on the north side of town by Metro and Region Conservation Authority is now scheduled to be completed by June according to a conservation authority spokesman, Mr. Wm. McLean. Speaking at the regular meeting of the Lions Club, he said that circumstances beyond the contractor's control had delayed the completion.

The new dam, one of a number built throughout the Metro area will control the flow of water in the stream which passes through the centre of town. Not only will it eliminate the possibility of flooding but will also control the flow of water in dry times to cut down on pollution.

The speaker said that the small lake created by the dam would cover 12 acres. It would not immediately become a recreation centre pending further town development and better road access. Fishing would be a feature.
