## Guilty plea to trafficking

## Crown withdraws one charge

STOUFFVILLE — On Jan. 16, Lois Wallace, an eight-year-old Ballantrae girl, died in York County Hospital, Newmarket from an overdose of drugs, later described as M.D.A.

In Ontario Supreme Court, Toronto, Monday, Bryan David Grainge, 19, and Jutta Gina Manthau, 22, both of R.R. 3, Newmarket, entered pleas of guilty to charges of possession of narcotics for the purpose of trafficking.

A third party, Robert James Gallamore, 21, also of R.R. 3, Newmarket, had his charge withdrawn by the Crown.

They were arrested by York Regional Police on the same day as the girl's death. A search of Miss Manthau's home, evidence revealed, uncovered a large quantity of M.D.A. capsules, said to number in the hundreds.

Miss Manthau and Grainge will be sentenced, Oct. 24.

### Two injured in 2-car collision

## Lake not 'bottomless'

### Longtime theory is refuted

STOUFFVILLE — How deep is Musselman's Lake?

The story has long existed that the lake is, in fact, 'bottomless'.

This theory is denied by officials of the Dept. of Lands and Forests and the provincial Ministry of Environment. A survey by Lands and Forests in 1968, sets the

maximum depth at 24 feet.

The 'bottomless' suggestion, an official at York Region said, probably results from its muddy base.

Musselman's a recent study reveals, is known as a kettle lake, created when a large mass of ice was buried in glacial debris. It later melted, forming a sizeable body of water.

## Ratepayers unhappy with Mt. Albert phone exchange

Whitchurch-Stouffville Ratepayer Association members were able to air their beefs with Ma Bell to more than a polite voice on the telephone during their meeting, Thursday.

Two Bell Company employees attended to explain a plan that will give Stouffville customers local calling with all of Metro by 1977.

But this progress will not help half the 20 ratepayers present because they are on the Mount Albert exchange and extremely unhappy about it.

Bernice Kovacs, a Bell area manager and Charles Brown, Commercial Supervisor of Development and Planning, appeared surprised by the

number and seriousness of complaints.

The cost of being a Stouffville resident with a Mount Albert telephone number was the primary lament.

Finley Macdonald, R.R. 3 Stouffville, said his annual bill for long distance calls to Stouffville and area totals close to \$300.

Bob Gayton, also of R.R. 3 Stouffville, objected to the high cost of a private line — approximately \$16 per month.

Others complained it is difficult to get telephone books for the area they want and to explain to out-of-town friends why they are not in the Stouffville directory.

Mr. Brown explained the difficulties and high costs of

changing a group of phones from one exchange to another. He said it might entail the abandonment of \$250,000 worth of cable.

Also, not all the people in Mount Albert want to be hooked to Stouffville, he said. "A majority of the 3,000 subscribers might like to join Uxbridge."

Finally people asked if they could get a rebate on all Stouffville calls.

Mr. Brown said that a new program called the One Way Optional Extended Service is now in a two-year trial period. If it's successful, he said, Mount Albert subscribers might some day pay a flat monthly rate for any and all calls to Stouffville.

Although the Bell repre-

sentatives said the Mount Albert to Stouffville issue had never been presented to them as a "gripping problem," before the ratepayers had made their point.

Mrs. Kovacs suggested they contact her individually.

## Pavemaster fire damage estimated at \$100,000

### Owner has close call saving office records

DICKSON'S HILL — Fire damaged the factory and destroyed the parts room and offices of Pavemaster of Canada Limited on Highway 48, near Dickson's Hill, Thursday.

More than \$50,000 worth of inventory was destroyed in the blaze. Pavemaster owner, Arnold Heron estimated his total loss at \$100,000, provided he can save the walls of the building.

He said the fire began at noon hour when he and his seven employees were at lunch. Smoke was first spotted by employees at the adjacent Stouffville Trailer Sales, who ran over with fire extinguishers.

A call went out to the Whitchurch-Stouffville Fire Department at approximately 12:40 p.m. and a pumper truck was dispatched. When the extent of the fire was realized the tank truck was called.

As flames spread through the concrete block building, the Markham Fire Department was called with two pumper and a tank truck.

Pavemaster employees recovered a few tires and the company's records before smoke filled the building entirely.

Mr. Heron returned from lunch before the fire department arrived and rushed into the building to recover his accounts-receivable ledger. An employee, Eddie Wideman, of Stouffville, followed and helped him get out.

"It is easy to see how people

lose their lives" said Mr. Heron. Mr. Heron had returned Wednesday from a government trade tour in Europe. He visited Yugoslavia, Austria, Sweden and England.

Pavemaster is the only company in Canada which makes asphalt rollers and compaction equipment for road building.

Mr. Heron hopes the plant will be back in operation within eight weeks. A month earlier he had bought a building in Ballantrae but intends to use it only as a parts plant. Assembly sales and service will remain at
