Mayor says

Council increases justified

"The Council recommended moderate increases for themselves and, in my opinion, are worthy of it," commented Mayor Gordon Ratcliff of Whitchurch-Stouffville, in a press interview this week. The Mayor will receive \$7,500, up \$500 from '73, and the councillors, \$4,200, an increase of \$300 over last year. Mayor Ratcliff said the schedule of meetings kept members very busy. He said salaries paid in other. municipalities had been considered in arriving at a decision. With regard to staff employees, the Mayor said the 9.3 percent increase in the cost of living had been taken into consideration. He noted too that there were those who merited increases on their value to the municipality. "We are very fortunate to have such a competent staff," he said.

Question: Was the Whitchurch-Stouffville Ratepayers' Association informed of the meeting, Jan. 31, attended by representatives of the Schickedanz development firm?

Answer: A letter was sent out by the secretary of Planning Committee to the Association president, informing him of the meeting. The councillor for that Ward (Jim Wong) may have informed me of his inability to attend, but I do not recall it.

Question: What is the latest word on the coming of McNeil Industries Limited and Volkswagen to Whitchurch-Stouffville?

Answer: An ammendment to the Town's Official Plan is underway to accommodate the Volkswagen firm. Architectual-drawnings for the McNeil Company should be completed by April 1. The two firms will be working together in an effort to come up with building designs compatible one with the other.

Question: Is there any further word on the new Post Office for Stouffville?

Answer: The Town has heard nothing official. A building permit has not been taken out, nor will it likely be until buildings on the site are removed.


