counsel for Professional Syndicated Industrial Developments Limited, over what material could be entered in evidence.

M.P.P. Bill Hodgson appeared on behalf of the residents.

Mr. Marshall argued the site was unsuitable as septic tanks for that large a development would pollute wells and the Black River, the roads to the area would not be adequate for the volume of traffic, the site is economically unsuitable due to its isolation, there would be no means of controlling obnoxious uses and that the town is already overindustrialized.

Mr. Marshall said the Vivian Road was only 22 per cent passable and is "as poor as you can get." He predicted that traffic on the 6th line would increase 600 per cent and he said it is a dirt road and impassable for at least 15 to 20 days a year. He said this is especially a problem as there is no public transport to the area and no regional plans to improve the road.

Grant Bacchus, of A.D. Margison Associates, formerly regional road

consultants, testified, "Rush hour traffic will be well under road capacity."

Mr. Marshall said the industrial assessment in Whitchurch-Stouffville is one acre to 14.7 people whereas the assessment in Etobicoke is only one to 100 and in Scarborough one to 95 people.

Under questioning from Mr. Mandel, Gordon Brush, principal planner for Area Services testified the development is in accordance with good planning but when asked by Mr. Marshall if the 14-1 assessment was pretty high, he admitted, "It would appear that way, yes."

Town solicitor Paul Mingay rebutted, "They are asking us to accept assessment ratios in vogue in urban centres."

Mr. Marshall claimed 96 per cent of the people in the area were opposed to the project and he questioned the validity of the expert witnesses as he said it seemed improbable that not one of them found any detrimental aspects to the plan.

According to one town official, "We approved it but we're more or less neutral."



No regional signs for some hamlets

STOUFFVILLE — Many of the local hamlets will not be receiving York Regional signs.

Town Council'

received a letter from Wayne Bando, Operations Engineer for York Region, which said, "A number of the hamlets which were mentioned do not qualify for a sign, since they do not provide food and fuel for the travelling public and are not shown on the Provincial Road map."

"I don't agree with the requirement that they have to be on the provincial map. If you went to the province they'd say they're not on because they don't have signs," Councillor Art Starr said.

Councillor Eldred King suggested that the town pay the cost of having signs erected by regional personnel at hamlets that don't qualify.

Mr. Bando was unsure of which hamlets would receive signs but some of those that won't are: Pleasantville, Cedar Valley, Lemonville and Bloomington.

"There are a number of places which were once prominent places on the map which have now shrunk to only a few houses," Mr. Bando said.

A horse grazes beside an abandoned building on Faulkner Avenue. Residents claim the owner Daniel Klockhoff has abandoned the property and the animals there. They include one dog, one horse tethered and two dogs running loose, according to the town's building inspector Willis Wideman.

the motto of the Town of Richmond Hill, "En La rose je fleure," translated "I bloom as the rose," aptly accompanied the crest of the Fourth Duke of Richmond, Governor-in-Chief of Canada, 1818-19, for whom some say that the village, (up until then named Mount Pleasant), was rechristened following a visit by the vice regal representative. The original crest (left, above) was drawn by W.A. Wright of the local carriage works. The year was 1919—the same in which Simpsons opened in Halifax. A stylized version by Stanley Arculus, heraldic artist of nearby Buttonville, replaced it in 1961.

Faulkner Avenue Residents claim property abandoned

CEDAR VALLEY — Residents of Faulkner Avenue in Cedar Valley have appealed to Whitchurch - Stouffville Council for help.

Council received a letter from the residents stating, "For years now, all residents on Faulkner Avenue have been bothered at one time or another by animals running loose, all owned by Daniel Klockhoff. We have had pigs uproot our gardens, a bull and cows confronting us, dogs roaming around and barking twenty-four hours a day. A cat was destroyed by two of his dogs. Other injuries and deaths of pets could very well have been the work of these dogs, too. On several occasions we have had to call in the Humane Society and police to get matters under control. However, nothing seems to help. Only yesterday, Mr. Klockhoff's stallion broke

loose and ran wild on other properties. Police had to be called in again."

The letter goes on to say the property has now been abandoned—but animals are still kept there, "the property itself is an eyesore in this area, where all residents take great pride in maintaining clean and pretty grounds. Old cars, junk, a broken-down building and an impossible house, paint a very sad picture."

Mr. Klockhoff's neighbours conclude by saying they don't even know where to reach him anymore.

A report on the property was submitted to council by Willis Wideman, Building Inspector, By-law Enforcement Officer.

The report explained that Mr. Wideman and Wayne Forsyth, bad inspected the site.

They, "found one dog

and one horse tethered, obviously belonging to the property and two dogs running loose. The animals appeared to have been well taken care of."

They said Mr. Klockhoff was not present, but reserved judgement as to whether the property was abandoned.

The report states, "Two of the three buildings on the property appeared to be somewhat dilapidated," and, "we found excessive debris such as three vehicles in inoperable condition and without current licence plates, old machinery and wood."

Mr. Wideman concludes, "In my opinion, Mr. Klockhoff is in contravention of Clean Yards by-law 71-55."

Mayor Gordon Ratcliff said he would be informed and given so many days to clean up the property.
