Reader defends board against criticism

Dear Sir,
In last week's paper W. B. Hartshorne criticizes the Ballantrae Community Centre Board for its improper administration of the centre. Council, according to Mayor Ratcliff, has faith in the decisions the board makes.
As written in the Ontario Community Centres Act "The board of a community centre may make such rules as it deems necessary relating to the management and control thereof and may fix such charges for the use of the community centre as it deems advisable." Council was quite right in supporting the board.

Under Regional Government our taxes are now pretty equal across the whole of Whitchurch-Stouffville and so recreational facilities should be more equally balanced, when at all possible. One way of getting some balance is with our new lighted softball diamond and an outdoor skating rink. Unfortunately, our water pressure is insufficient for proper flooding nor do we have enough volunteer manpower to flood the rink. As a result, last year we had no rink. With Works Dept. help we were trying to remedy the situation. We're still going to try to get a rink in this year.

The efficient operation of a community centre is important if our taxes are not to go even higher. When working out the yearly budget for council, we must not only work out a general operating budget and capital expenditures but we must also estimate our assets for the coming year. These assets include donations and rentals. Certainly we are not making a profit when our rentals are much lower than our general operating budget.

It has always been the policy of this board and past boards that children's groups such as cubs, brownies, baseball and youth groups use the centre free of charge. We want to encourage, not discourage, these groups to continue operating. Since the centre caters basically to local people we don't feel the people in the southwest area of the town should subsidize us completely. Even council pays a rental fee when it uses the centre for any civic meetings. We, by paying a rental fee, can contribute toward the continued operation of the centre just as others rent and support Latham Hall, Vandorf Hall, the swimming pool and other community buildings.

Perhaps Mr. Hartshorne would like to see us charge all groups the same amount of rent so that we might no longer have cubs and brownies or any other groups which use the centre on a weekly basis.

May I extend an invitation to Mr. Hartshorne and any others who might have any questions—Come to a board meeting and find out what is going on, or put your name on the agenda so you can air your problems. By attending a few meetings, you may find out some of our problems as well.

Councillor claims remarks misquoted

I am writing with regard to a letter which appeared in the Tribune last week from Mr. W. Hartshorne, protesting the rental fees charged at the Ballantrae Community Centre, and your article reporting my comments on this letter. I feel that you have misquoted me, and would like to clarify my position on this matter.

First of all, the comments I made were not in support of Mr. Hartshorne's objection, but were made to clarify the situation. I prefaced my statements by saying that some factions in the community felt that all groups using the Centre should be charged rent, and some felt that no one should be charged rent. In fact, the policy of the Ballantrae Community Centre is that all groups are charged the same rental except those few that offer a community service, but are not economically independent (such as Cubs and Brownies). It could be pointed out that when the Municipality wishes to use these facilities for Planning Board meetings or for polling stations for Municipal Elections, it is charged the same rental fee as all other groups.

The rate schedule is established, not to make a profit, but to offset some of the financial burden of maintaining the Centre, by those who wish to use it. Certainly no profit is made.

Mr. Hartshorne suggests that all taxpayers should use the building free. This may sound well in theory, but would not be practical. The Town subsidizes many activities, such as hockey, baseball, swimming, etc. If this logic were applied, all these activities would be free to all taxpayers, and the cost to the Municipality would be horrendous. Subsidies or grants for activities or Community Centres are, in my opinion, a base from which these programs can be made available to the public; however, the balance of the expense must be borne by those who choose to use these facilities or take part in these activities.

One has only to serve on a Community Centre Board, as I have for the past several years, to appreciate the difficulties which would arise from a policy as suggested by Mr. Hartshorne.

Although the Community Centre Boards in the Town are basically the same, the needs can differ slightly in the various localities. At present I believe that some Centres charge rent to everyone, and some give consideration to certain groups. None offer their facilities free of charge. I feel that the policy established by the Ballantrae Community Centre is a sound and just policy for all parties.


Make a special effort to attend this hearing and be sure that anyone in your household who is old enough to be concerned, also attends.

Board chairman defends policy

Dear Sir,
Mr. Hartshorne in his letter to your paper last week does not seem to understand the method by which Community Centre Boards operate. I would invite him to come to our next board meeting, and we will gladly explain to him why the present system "saves" the majority of taxpayers money.
For example, The Whitchurch-Stouffville Ratepayers Association, of which I am a member, have an average attendance of from 15 to 20 people at their meetings and comprise a membership of approximately 7 per cent of the residents of this area, and are charged only for expenses to cover heat, electricity and clean-up. The non-profit fee is \$15. for such meetings. Now if we let all groups such as this have the hall free we would have to ask Council for a "larger budget" — and then Mr. Hartshorne your taxes and the taxes of other residents who do not belong to such organizations might be affected.
