

Proposals for 200 acres

3 properties mentioned

UXBRIDGE Development proposals which could see houses going up on almost 200 acres of land in and around Uxbridge were presented to Township Council at its last meeting.

Making the presentation was Jim Knox, of Knox, Martin, Kretsch Ltd., a firm of consultants. Knox said that his company has been retained by Troika Developments, to plan development of lands owned by Troika.

"At the moment, we only want to inform you of the properties for which we're planning," he said.

The three parcels involved were described as: the Gould property, 60 acres of land on the south side of town; the Harris property, a small parcel on either side of Maple St. in Uxbridge, which has already been divided into 32 lots; and the Forsythe property, on the west side of town, taking in more than 100 acres.

Knox explained that his clients are not putting

forward any definite proposals at this time, but wish to be sure that their properties are considered when priorities are determined for the planned expansion of the town sewage plant. He expressed a desire to work with Council, and asked if a meeting might be arranged with the Planning and Development Committee.

"We want to show how our proposals would fit into the overall picture of existing and planned building," he said.

Under questioning by Council, Knox maintained that his clients were still at a very early stage in their planning. Mayor Carl Puterbaugh, appearing to harbour some misgivings, questioned him closely on such topics as type of building and population figures.

Knox stated that these are matters that haven't been settled yet, and said he hoped to work with the Town to some extent in making these decisions.

discussion, Councillor Eleanor Todd suggested that these developments be handled by the process already established: a plan must be submitted, with a deposit of \$500, before the proposal is studied.

"You're absolutely right," said the Mayor. "We can't go any further on this tonight."

It was agreed that the town will notify Knox of a date when he can attend a meeting of the Planning and Development Committee, and the idea can be explored in greater detail.

Construction cave-in \$1,000 fine for unsafe conditions

NEWMARKET — A construction company hired to install sewers at the new addition to the York County Hospital was fined \$1,000 after being convicted in Provincial Court last Tuesday for failing to provide adequate protection at the work site.

Leonardi Bros. Construction Ltd. were charged under sections of the Construction Safety Act after a workman at the site was killed by a cave in which occurred last July 25.

Carrado Aprile, 46, of Scarborough was trapped when the wall of a trench collapsed, another worker Yvon Chartier of Thornhill was also buried under the debris, but escaped with minor injuries.

At the trial, held two weeks ago before Provincial Judge Clare Morrison, a Ministry of Labor Safety Officer testified that he found inadequate shoring in the trench, and no ladders placed for safety measures.

Mr. Chartier a machine operator had also testified to the same effect. The man also told the court that foreman Corrado Paglialunga of Toronto had been absent from the site at the time

the accident occurred. Mr. Paglialunga was also fined \$200 by Judge Morrison because he failed to remain at the site.

The court was told that Mr. Chartier had excavated part of the trench and Mr. Aprile had gone into the excavation to level off the earth and check as to whether it was safe for other workers to enter, when the excavation collapsed, Mr. Chartier had jumped into the trench, to try and assist the trapped man and had been buried also.

Mr. Paglialunga said he had given orders to carry out excavations under maximum safety standards, but denied giving orders to any of the men to enter the trench, he said he left the site after checking to ensure the safety of the trench and had not been present at the time the accident occurred.

Judge Morrison in a lengthy summation said that he did not think the lack of ladders in the trench had been a factor in causing the death of Mr. Aprile since workers had access to and from the trench from a graded fill. The Judge commented on the lack of shoring however and found the company negligent on this point.
