## Dec. 1 start Committee seeks course ideas for adult craft centre

**STOUFFVILLE** — Anyone with suggestions as to what courses should be offered when the adult arts and crafts program starts up can submit their ideas at the town hall, care of the Recreation Committee.

Committee Chairman Jack Watson is optimistic some classes will be running by Dec. 1 and that a full program will be operational by the first of the year.

The Committee has received a Local Initiatives Program grant to initiate the crafts courses in the old library building and they are now looking for two full-time people to teach classes and handle administrative matters.

There is still some uncertainty as to what will be taught but some courses are already definitely scheduled.

One of these is a rather innovative course for parents and children. It is aimed toward preschoolers and according to Mr. Watson it will "give the mothers an opportunity to play with their children."

The course will be taught by Cathy Tyrer. "We are begging, borrowing and stealing

anything we can find," commented Mr. Watson of the committee's efforts to obtain material.

Hand looms, which can be used for rug hooking, and small quilts, are now being made.

Mr. Watson said they have been in contact with Seneca College and they will definitely be offering afternoon and evening courses in the leisure and recreation fields.

There has already been a great deal of interest shown in courses on quilting, decoupage and macramé.

The price of courses will vary with the cost of materials and Mr. Watson predicted the minimum fee would be \$25.

## Suburban plans presented

(continued from page 1) but served by municipal water. They requested 18 lots with access off the 10th conc. This, they estimated, would bring in about 70 people.

The developers speculated there would be capacity for 2,500 people when the sewage plant is expanded for the proposed Dulverton subdivision.

They offered to pay any consulting fees and to contribute toward the sewage plant expansion.

"At the present time there is no capacity and the municipality has nothing firm that there will be capacity," Board Chairman Eldred King said. "We cannot allot capacity we don't have."

Councillor Becky Wedley asked what kind of houses were planned for the first proposition.

Mr. Kimura said they would be 1,200 to 1,500 square feet and he said they had discussed moderate to low priced housing.

Councillor June Button pointed out that other small developers would have priority as they own land zoned residential or transitional while the property they wish to build on is still zoned rural.

Mr. Kimura asked that they consider ordering a feasibility study for proposition number three as it requires no sewage facilities.

Councillor Cathy Joyce supported the idea of a feasibility study but stipulated it be given no priority over any other work presently being conducted by the town planning consultant.

Mrs. Wedley

suggested all three alternatives be studied "since they are willing to pay. They are looking to the future and would like to know what their chances are."

Mayor Gordon Ratcliff was against giving any encouragement as he felt the infilling around town would take up any sewage capacity left after Dulverton is completed.

Mrs. Joyce said that was why she supported number three which she called "a new concept."

"That is top quality agricultural land and if it is ever developed, it should be used for high density to make the best

use of it," commented Councillor Merlyn Baker.

Councillor Art Starr said no action should be taken until consolidation of the Official Plan is completed in 1976.

A motion introduced by Mrs. Joyce requesting a feasibility study was defeated.
